Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. Notice for applicants with warrants or unpaid fines: Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing. You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

On Sunday, July 7, 2024, at approximately 2:56 pm, my partner (P.O. Murray HAYES) and I were dispatched to 5526 W North Ave (Scene One Restaurant & Lounge) for a noise nuisance.

Upon arrival, I contacted the caller, identified as Taylor M DUWELL (W/F, 3-14-1991) who stated the music that was playing at Scene One Restaurant & Lounge was causing a disturbance to her. DUWELL stated that she lives at 2343 N 56th St and that the bass was so loud that it was rattling her windows. She stated that she first started hearing the bass at approximately 1:00 pm but after consistently hearing it for over an hour, she placed a call for service at approximately 2:14 pm. DUWELL stated that she walked by Scene One and confirmed the bass was coming from there location before she contacted the police.

When I arrived on scene, I faintly heard the music while parked directly across the street. I approached Scene One and again heard the music and bass very faintly, however when the the front door was opened, I was able to clearly hear both. P.O. HAYES walked to the rear of the business and stated he faintly heard the music and bass while in back of the business. I spoke with the license holder, identified as Lenzy L CRAWFORD (B/M, 9-28-1985) and told him about the complaint. I did not advised CRAWFORD to turn down the music because at the time of our investigation it seemed it was at a reasonable volume.

CRAWFORD was cooperative during the investigation and stated that they are holding a community meeting with the alderman on Saturday, July 13, 2024 about their business and they would welcome anyone with complaints to come.
