

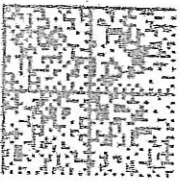

Dear Clerks,

On behalf of my client, Ray Stribling, I am making the following claim for \$499.00:

Ray Stribling resides 5175 North Hopkins Street, Apt. 111, Milwaukee, WI 53209.

On January 4, 2016 Stribling was arrested by City of Milwaukee Police. At the time of his arrest he possessed \$499.00 in cash on his person. This is acknowledged in Milwaukee Police Incident Report 160040132.

Sometime on January 4 or 5, 2016, he was taken to the Milwaukee County Jail. The cash was either not brought by the Milwaukee Police to the Jail, misplaced during transit or booking, or stolen. Upon his release on January 7, 2016 Mr. Stribling was not given his cash. It is unknown when, where, or how the cash was misplaced or taken.

On December 20, 2016 both the County and City informed Mr. Stribling they did not possess the cash. However, neither entity could account for the cash. Milwaukee County Circuit Court Judge Timothy Witkowiak then ordered both the City and County to release any portion of the cash in the possession of the City or County. The City and County have not complied with this order.

This claim is made to both the City and County to comply with the order, which has been enclosed.

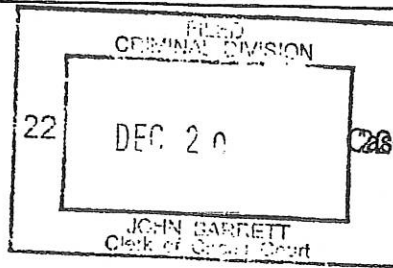
