2nd Aldermanic District

N. 70th St. – W. Capitol Dr. to W. Congress St. (ST211140131):

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (6-8 foot width of tree border area), and grading.

Ald. Davis moved approval with late billing. (Prevailed 4-0, Ald. Wade excused)

5th Aldermanic District

N. 77th St. – W. Keefe Ave. to W. Capitol Dr. (ST211140108):

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (9 foot width of tree border area), and grading.

Ald. Bohl moved approval with late billing. (Prevailed 4-0, Ald. Wade excused)

N. 90th St. – W. Burleigh St. to W. Auer Ave. (ST211140141):

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (6 foot width of tree border area), and grading.

Ald. Bohl moved approval with late billing. (Prevailed 4-0, Ald. Wade excused)

Alley between W. Capitol Dr., W. Melvina St., N. 96th St., and N. 98th St. (ST212150109):

Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, grading, and storm drainage facilities where needed.

S. 83rd St. – A point south of W. Dixon St. to W. Dixon St. (ST211140110):

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, sodding (7 foot width of tree border area), and grading.
