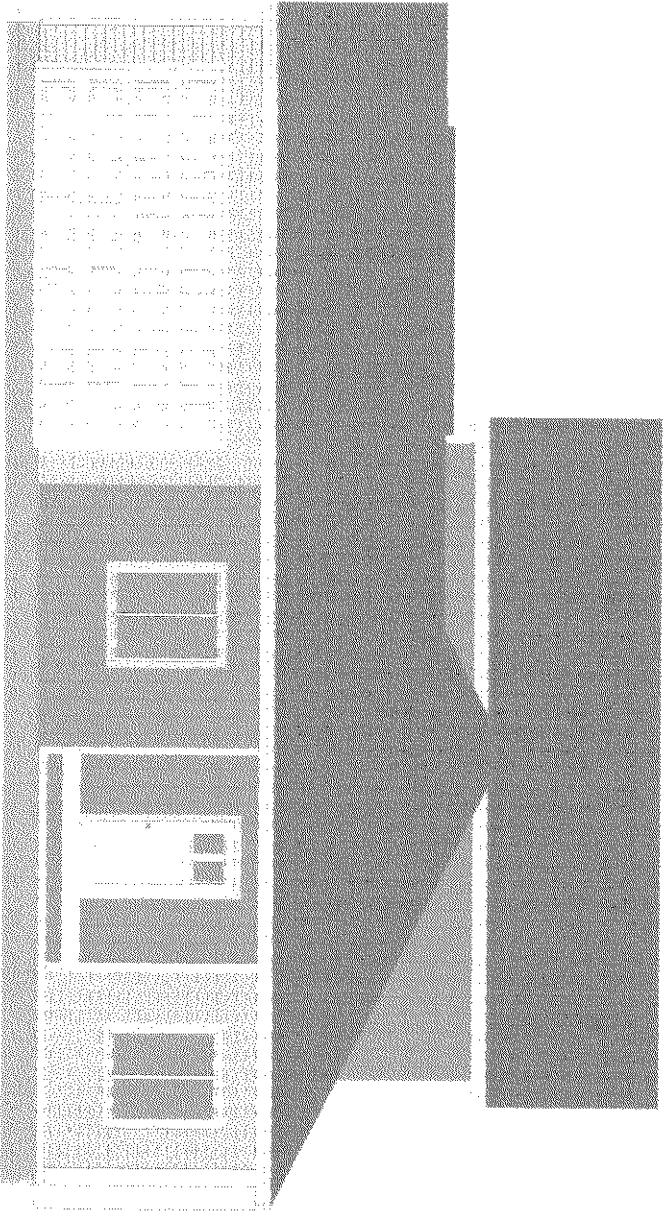
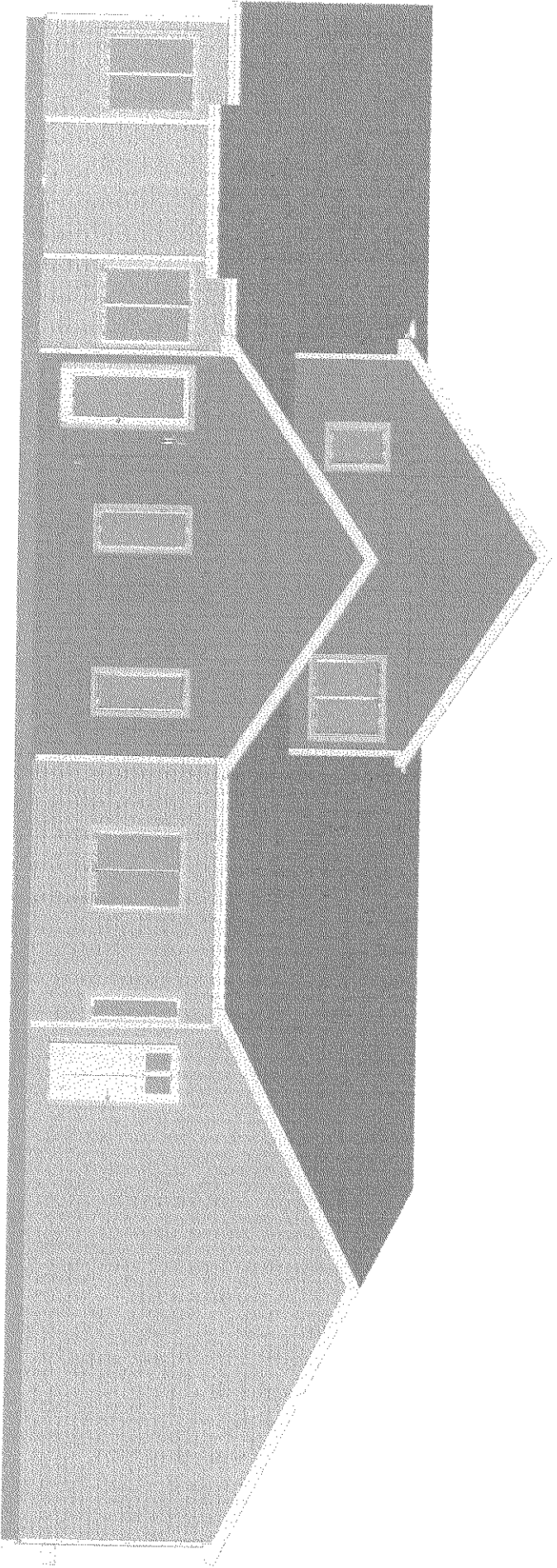


West Elevation

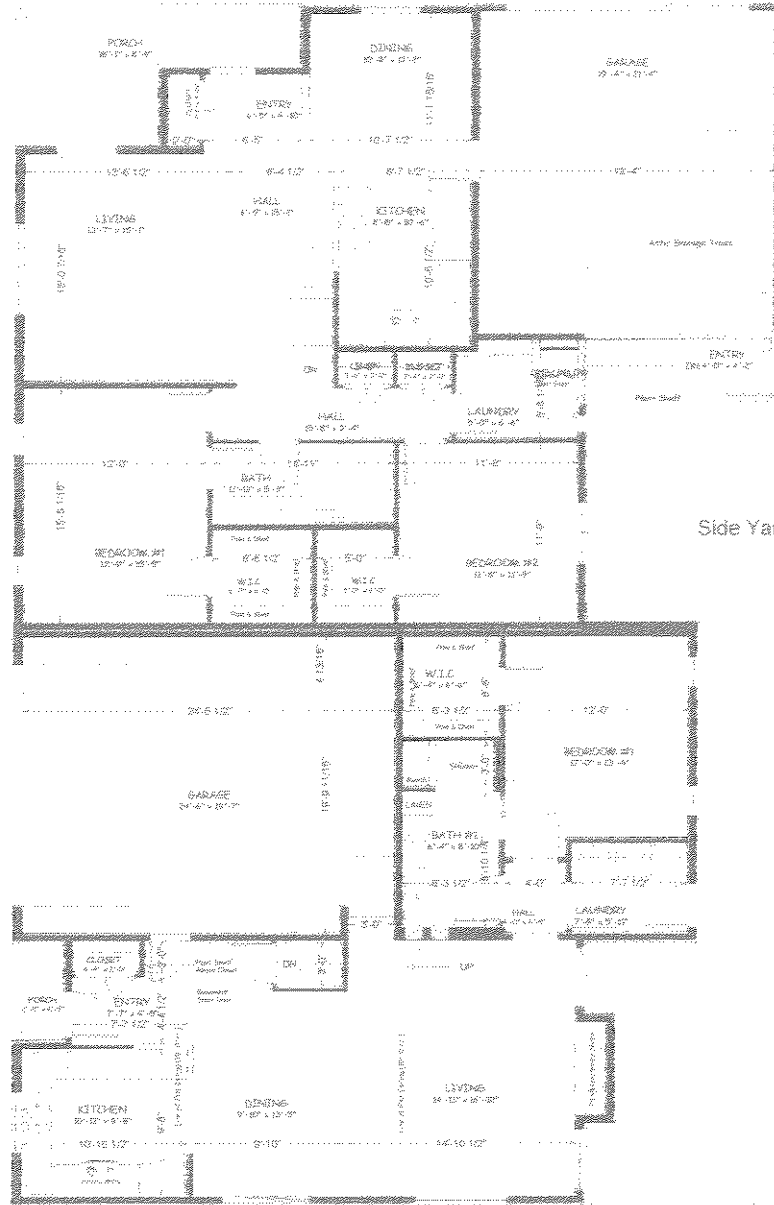
Front Yard Setback

Side Yard Setback

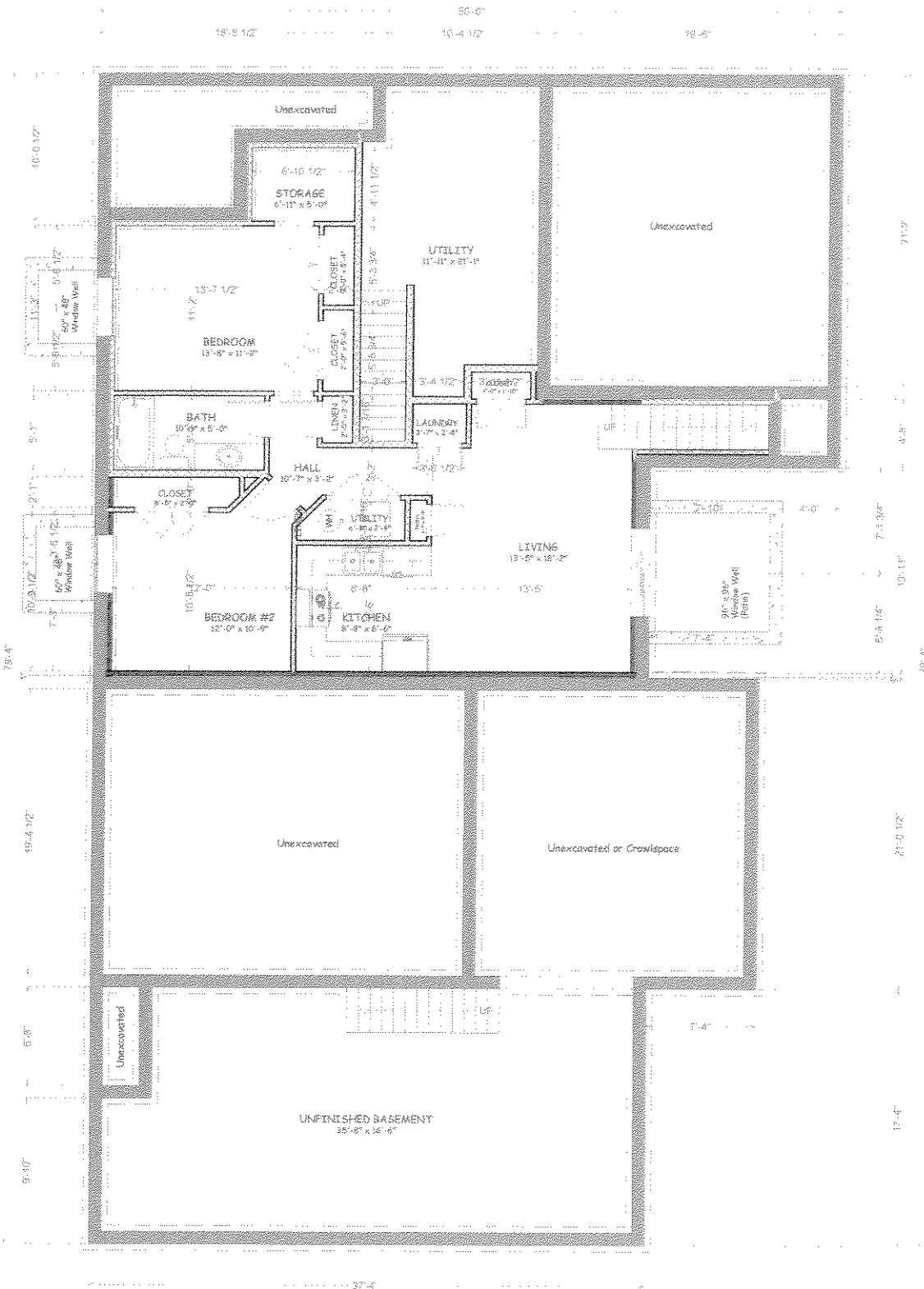

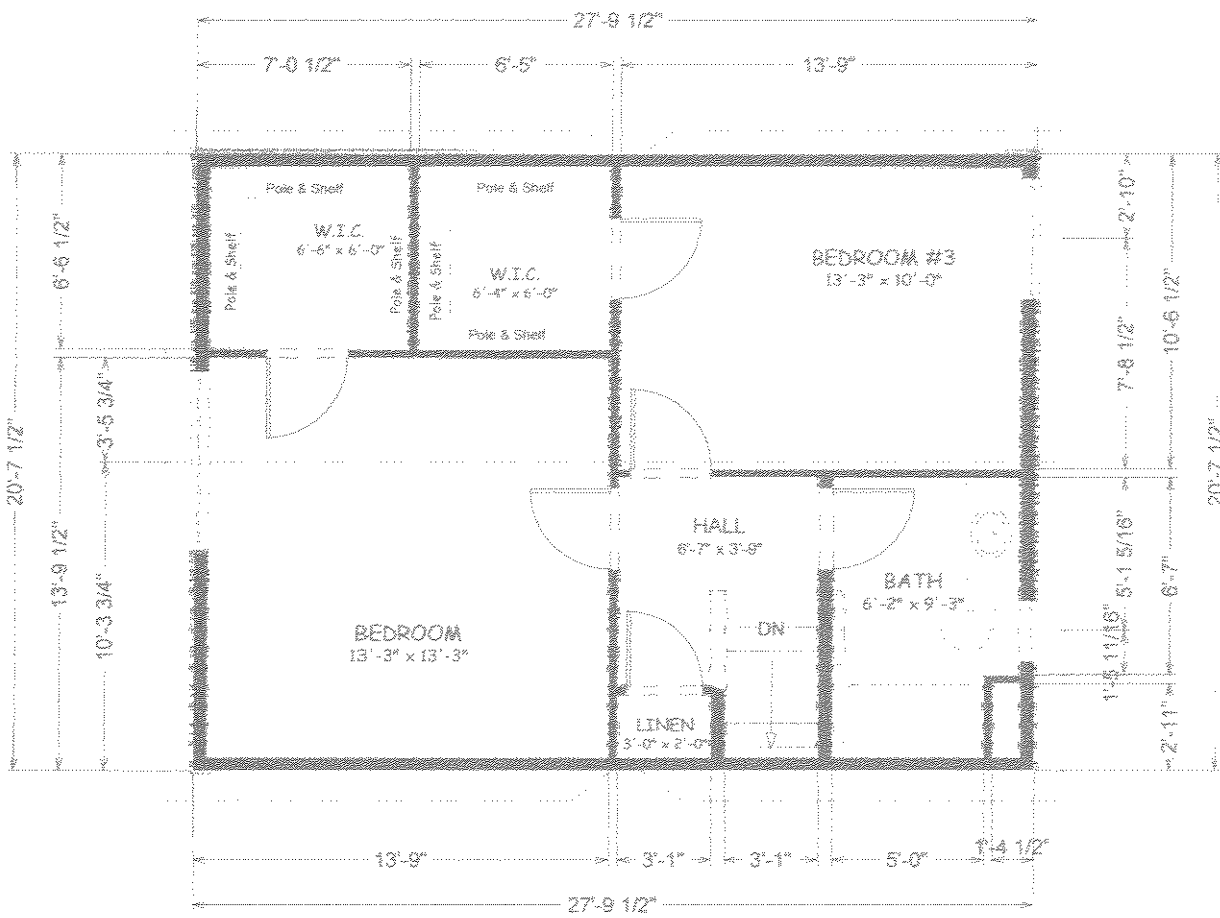
