Our traffic engineering staff has investigated this request and found eastbound motorists on East Linnwood Avenue have a difficult time seeing traffic traveling northbound on North Maryland Avenue when vehicles park close to the corner. Therefore, in the interest of public safety, we recommend installing this restriction to increase cross traffic visibility at the intersection.
