I then spoke to the caller who was also the licensed manager of the business identified as Areli GARCIA (W/M 04-01-82). GARCIA stated he did not wish to pursue any law enforcement action towards JOHNSON. GARCIA stated JOHNSON had been inside the business for approximately 6 hours and he just wanted her to be removed from the business and taken somewhere warm. No security staff works at the Denny's and no surveillance footage was needed.

The Food Dealer License was displayed directly behind the host stand.

JOHNSON was then conveyed to the repairers of the breach warming shelter.


