The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 05/05/2019 a 16-year-old working in conjunction with the Milwaukee Police and the WI WINS Tobacco Initiative was able to purchase a Swisher Sweet cigar from the clerk at 200 N. 35<sup>th</sup> St, who did check her ID but made the sale anyways. The clerk admitted the sale saying he checked her ID and he must have made a mistake. The applicant was issued a citation for Sale of Cigarette to Minor/Underage.

2. On 09/10/19 Milwaukee Police Officers were dispatched to the location 200 N. 35<sup>th</sup> St, regarding a strong arm robbery complaint. The complainant stated to officers that two suspect took \$700.00 dollars in cash from him outside of the location. Subsequently the complaint admitted to the officers that he was at the location in an attempt to purchase marijuana, from the suspects.

3. On 04/01/20 Milwaukee Police officers were at the location 200 N. 35<sup>th</sup> St., regarding a reckless use of weapon complaint. Officers interviewed the gas station security officer, who observed two subjects starting to fight with in the station lot. One subject left the area on foot while the other subject chased the subject with in a vehicle. Officers asked to review the video cameras but the manger was not scene. The gas station clerk was cooperative with officers by providing officers the cell number of the manager.
4. On 09/17/20 Milwaukee Police Officers were dispatched to a shooting at 200 N. 35<sup>th</sup> St. Upon arrival officers located the victim, who suffered multiple gunshot wounds, in the parking lot of the location. Milwaukee Fire Department was at the location and gave medical attention to the victim. The victim was later pronounced deceased at the scene. The investigation revealed that the suspect was legally armed with a fire arm at the time of the incident. Also the victim was the brother of the security guard, who was at the location visiting. The suspect was approached by several males including the victim. One of the subjects attempted to disarm the suspect, and the victim pointed his fire arm at the suspect. The suspect was able to produce his firearm and fired several gun shots, striking the victim. The suspect then fled the location on foot. The owner arrived at the location and assisted officers with surveillance video of the incident.

5. On 10/12/2020 a call in meeting was held regarding the 09/17/2020 shooting at 200 N. 35<sup>th</sup> St. The applicant stated he has security and the shooting was an isolated incident. He plans on making the gas station a state of the art station right of the freeway and will work with the residents to ensure the business is not contributing to problems in the area.
6. On 10/14/2020 officers were dispatched to a Trouble with Subject at Hometown Gas Station, 200 N. 35<sup>th</sup> St. The officers interviewed a security guard, who stated a female was having trouble with her boyfriend and wanted him to leave. The security guard allowed the female to wait in the store and he removed the boyfriend from the store.
7. On 10/18/2020 at 6:45pm bicycle officers were checking the gas station at 200 N. 35<sup>th</sup> St. for drug activity. They approached an auto parked at the gas pumps and observed the occupants to be in possession of narcotics. The driver observed the officers and fled the scene.
8. On 11/14/2020 at 2:00am officers investigated a battery in the area of N. 35thst and W. Mt Vernon. The victim was located at the gas station at 200 N. 35<sup>th</sup> St. The incident did not occur there but the victim went there after the incident. The officers interviewed the security guard, who stated he observed the incident occur across the street.

9. On 09/08/22 at 2:51a.m., Milwaukee Police were dispatched to a Battery at 436 N. 41<sup>st</sup> St. Investigation revealed the caller was battered in the restroom at 200 N. 35<sup>th</sup> St. The caller's father attempted to intervene and upon his son exiting the restroom they returned to their vehicle that was parked by the gas pumps. While outside the same suspects struck the caller's father. Officers followed up with the clerk and he corroborated the caller's statement. The clerk stated he attempted to unlock the locked restroom but the caller was able to escape on his own. Officers attempted to review the surveillance video but the clerk did not have access. Officers were advised to respond in the morning hours for access.

10. On 09/25/23 at 11:14p.m., Milwaukee Police were dispatched to a Battery at 200 N. 35<sup>th</sup> St. Investigation revealed a security guard observed two subjects attempting to steal. When the security guard approached the subjects, they began to physically fight with the security guard. The employee was cooperative and allowed officers to view video surveillance of the incident.

On *09/25/2023 at approximately 23:14*, *PO FLORES and I* were dispatched to *200 N 35th St.* for a Battery Complaint.

Upon *our arrival* I observed *our caller* who was identified as *Joshua J EVANS, (m/w, 07/06/88)* in the *parking lot of the gas station*.

I spoke to the caller, who called from *(414)933-0102* and *EVANS* stated that *two subjects attempted to steal from the store, and he advised the two subjects to leave the store before he called the cops and the two subjects then began to fight with EVANS*.

There were no witnesses on scene and *EVANS* is an armed security guard for *Hometown Gas station*.

I reviewed video surveillance footage emailed to me by *EVANS* which showed the two subjects both fighting with *EVANS* in the parking lot of the gas station.

While on scene, I did not observe the licenses posted due to me investigating a battery complaint. During my investigation for *a battery*, I did not observe any violations in the licensed premise.

A battery citation will be issued to the suspects should they be located.

## Narrative (1)

### LICENSED PREMISE REPORT

This report is written by P.O. Jaimee WARNER, assigned to District 3, Late Power Shift.

On Friday, October 13, 2023, I was advised by Sgt. William KINGSTON (squad 3412) about a battery complaint that P.O. Kurt KEMNITZ and I investigated on 9-8-2022 and a license premise report needed to be filed regarding.

I reviewed my body camera regarding that incident.

On Thursday, September 8, 2022, at approximately 2:51 A.M., P.O. Kurt KEMNITZ and I (squad 3320) were dispatched to 436 N. 41st St., located in the City and County of Milwaukee, regarding a Battery complaint.

Upon arrival, I spoke to the caller, Nathan A. NOVAK (w/m 5-15-1991), who stated he and his father, Alexander W. NOVAK (w/m 8-14-1967) were at the Hometown Gas Station on N. 35th St. / W. Park Hill Av. getting gas and water to add to the coolant tank due to it overheating. Nathan stated he went inside the gas station bathroom with a jug to fill it with water. Nathan stated as he was walking back inside the gas station, 2 vehicles pulled up, but he didn't have a good description of the vehicles. Nathan stated he was in the bathroom filling up the jug a second time, when 3 unknown males entered the bathroom behind him. Nathan stated he thought the 2 unknown males were going to fight each other in the bathroom, so he didn't think anything of it. Nathan stated one of the unknown males stated, "You're not ready for this" and that's when he realized the 2 unknown males were going to fight him. Nathan stated a 3rd unknown male was recording the incident on a cell phone. Nathan stated he attempted to run out of the bathroom but began being punched 50+ times all over his body by the 2 unknown males. Nathan stated Alexander saw the 3 unknown males walk into the bathroom shortly after Nathan. Nathan stated Alexander came into the gas station after them and yelled at the clerk for the bathroom keys. Nathan stated Alexander realized the bathroom keys were still in the door, so he was able to unlock it. Nathan stated after Alexander opened the door, he crawled out of the bathroom. Nathan stated he and Alexander then ran out of the gas station and towards their vehicle. Nathan stated he was able to get into the vehicle, but the unknown males wouldn't allow Alexander into their vehicle. Nathan stated the unknown males began to punch Alexander. Nathan advised me that his lip was bleeding as a result of being punched. Nathan stated the unknown males were still at the gas station when they were finally able to pull away.

I did observe a little bit of blood coming from Nathan's mouth but only after he spit.

Nathan and Alexander refused medical attention after being asked by both P.O. KEMNITZ and me.

**Nathan described the 4 unknown males as the following:**

**Subject 1:** Hispanic male, 5'08, 170-180lbs, heavy build, with long dark colored hair in a ponytail, wearing a Brewers shirt, blue pants, wearing red/white boxing gloves

**Subject 2:** Black male, 5'10-6'00, longer afro, grey jogger pants, armed with a black handgun

**Subject 3:** Black male, 5'10-6'00, wearing black sweatpants and a black shirt, and black boxing gloves

**Subject 4:** Hispanic male, unknown clothing (not involved in the battery)

We changed locations to 200 N. 35th St., located in the City and County of Milwaukee, to attempt to locate the subjects, speak with the clerk, and attempt to obtain video surveillance footage.

P.O. KEMNITZ and I spoke to the clerk, Ndubuisi P. AMAECHI (b/m 8-21-1986, who stated Nathan and Alexander came to the gas station to get gas and add water to the coolant tank of their vehicle. AMAECHI stated the younger man "Nathan" came in twice to get water for the vehicle. AMAECHI stated when Nathan was in the bathroom, 2 unknown males came into the gas station while putting boxing gloves on with a 3rd male following behind them with a cell phone out recording. AMAECHI stated all 3 males walked towards the bathroom as though they were following Nathan. AMAECHI stated he then saw "Al" (Alexander) running towards the gas station. AMAECHI stated Alexander is telling him to call 911. AMAECHI stated he came out from behind the counter and was going to the bathroom when he could hear Nathan screaming. AMAECHI stated the bathroom door was locked, so he ran back behind the counter to get a spare key. AMAECHI stated by the time he was running back towards the bathroom door, that Nathan was already out of the bathroom and running outside covering his head. AMAECHI stated Nathan was telling Alexander "They jumped me! They jumped me!" AMAECHI stated Nathan and Alexander both got into their vehicle and fled the location. AMAECHI stated he did not see Alexander get hit while outside. AMAECHI stated he began yelling at the unknown males for jumping Nathan.

AMAECHI advised us that he did not have access to the video surveillance footage. AMAECHI stated only his boss has access. AMAECHI advised us that he had already called his boss and left him a voicemail regarding the incident. AMAECHI stated he also texted his boss regarding the incident as well. AMAECHI stated his boss is usually in during the mornings between 6 A.M. - 8 A.M.

The business was cooperative with the investigation. The business had 0 security officers on scene.

Due to not being able to review the video surveillance footage, P.O. KEMNITZ requested that follow-up be doing during day shift for the CSO to attempt to view and download the footage.

While on scene, I did not observe the licenses posted but I was also not looking for them due to interviewing AMAECHI. During my investigation for battery complaint, I did not observe any violations in the licensed premise.
