- 02/22/23 Injured/Sick Caller states a subject is laying down outside and requesting medical help. Officers conveyed the subject to detox.
- 2. On 03/20/23 at 9:46p.m., Milwaukee Police conducted a License Premise Check at 3115 W Fond du Lac Av. No violations were found and the employees were cooperative.
- 3. On 04/07/23 t 6:56a.m., Milwaukee Police were dispatched to a Trouble with Subject at 3115 W Fond du Lac. On arrival the caller stated there was a subject harassing customer's and refusing to leave. The subject was conveyed to a private residence and the employee was cooperative with the investigation.
- 4. On 05/20/23 at 11:10p.m., Milwaukee Police were dispatched to a Shoplifter at 3115 W. Fond du Lac Av. Investigation revealed a subject was inside the premise eating sandwiches and other items. The clerk approached the subject to advise they would need to pay for the items, at which time the subject left without paying.
- 5. On 06/26/23 at 4:16a.m., Milwaukee Police were flagged down at 3115 W. Fond du Lac. Investigation revealed a subject was refusing to leave the premise and requested they clerk call the police for them. It was determined the subject needed housing and was provided resources by the officers.
- 6. On 06/28/23 at 4:56a.m., Milwaukee Police were dispatched to a Shooting at 3115 W. Fond du Lac Ave. On arrival officers observed a victim laying on the ground near the entrance. The victim was breathing but unresponsive to officers' questions. It was determined the victim was shot to the thigh and was conveyed to a local hospital for medical treatment by MFD. The business was cooperative with the investigation and did provide officers with video surveillance of the incident.
- 7. On 09/25/23 at 3:18a.m., Milwaukee Police were dispatched to a Theft at 3115 W. Fond du Lac Ave. Investigation revealed a subject entered the store, took an item and told the clerk another customer would be paying. The other customer agreed, however, both subjects then left without paying. The officer viewed surveillance of the incident.
- 8. On 11/11/23, Milwaukee Police were assigned to work Wisconsin WINS, which checks area vendors for age compliant tobacco sales. At 1:42p.m., a youth entered 3115 W. Fond du Lac Av., and did purchase a tobacco product from the cashier, who did not ask for identification. The clerk denied the transaction to the officer, however, was the only employee in the store and matched the description given by the youth.
- 9. On 02/03/24 at 3:51a.m., Milwaukee Police were dispatched to a Shotspotter at 3115 W. Fond du Lac. No casings were recovered at the scene and witnesses stated the sound was more like a car backfiring.
- 10. On 02/15/24 at 12:39a.m., Milwaukee Police were dispatched to a Shotspotter at 3115 W. Fond du Lac Ave. Investigation revealed the victim was involved in a road rage incident at a prior location, when the suspect vehicle fired rounds at their vehicle. The victim drove to 3115 W.

Fond du Lac., followed the suspect vehicle, and waited for police to arrive. The suspect exited their vehicle and fired additional shots at the victim's vehicle. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.

- 11. On 03/12/24 at 9:53a.m., Milwaukee Police were dispatched to a DOE at 3115 W. Fond du Lac Ave. Officers were advised by the caller, they observed the body laying by the vacuum. The citizen alerted the business, who called police. The employee stated they victim was last seen earlier in the store. The business was cooperative and officers viewed video surveillance, which showed the victim speaking to another subject by the vacuum earlier.
- 12. On 04/06/24 at 5:51a.m., Milwaukee Police were dispatched to a Shots Fired at 3115 W. Fond du Lac Ave. It was determined this was a baseless call.
- 13. On 04/15/24 at 2:43a.m., Milwaukee Police were dispatched to a Bomb Threat at 3115 W. Fond du Lac Ave. The business was very cooperative and allowed officers to view video surveillance of the incident. The video depicts the suspect and security engaged in a brief argument, before the suspect leaves the store.
- 14. On 05/01/24 at 7:02a.m., Milwaukee Police were dispatched to a Theft at 3115 W. Fond du Lac Ave. Investigation revealed the business was the victim of a retail theft. The business was cooperative, allowing officers to view video surveillance of the incident.
- 15. On 06/17/24 at 8:53p.m., Milwaukee Police were dispatched to a Shooting at 3115 W. Fond du Lac. Investigation revealed the victim was in line to make a purchase, when the suspects observe the victim has a firearm in their waistband. The suspects grab hold of the victim's arm, eventually shooting the victim. The victim succumbed to their injuries. The business was cooperative and provided video surveillance of the incident.
- 16. On 09/05/24 at 9:30p.m., Milwaukee Police conducted a Field Interview of a suspect at 3115 W. Fond du Lac Ave. This was due to officers' observations of drug transactions at the location via utilizing FUSUS cameras, which allows officers to monitor activity. The officers observed a vehicle parked near the front door of the business, conduct multiple drug transactions. The driver identified themselves as a security guard at the location, as well as a customer stated the driver was the security officer for the location. A black digital scale, a loaded firearm, and 28.45grams of THC, packaged in 10 different bags, were recovered in the vehicle. It should be noted the vehicle was parked in an area that was clearly visible to the clerk. The officers did not interview the cashier.
- 17.On 10/28/24 at 6:20p.m., Milwaukee Police conducted follow up at 3115 W. Fond du Lac., regarding the Nuisance Abatelement Agreement. Officers observed proper signage, visible functioning cameras and flood lights. The agent successfully completed 2-10 of their Abatement agreement, with the exception of missing a Crime and Safety Meeting. The agent agreed to attend the next meeting in November.

On Saturday, November 11, 2023, I was assigned to work with the Wisconsin WINS Youth Tobacco Prevention, which checks area vendors for age compliant tobacco purchases.

Assisting in this assignment was Terrance J. KELLEGG (B/M) of WI WINS Organization. KELLEGG is a minor that is under the age of 18.

At approximately 1:42 pm, Terrance J. KELLEGG entered Hometown gas station located at 3115 W Fond Du Lac Av. and purchased a single Black and Mid cigar for \$1.50. Terrance J. KELLEGG described the clerk that sold him the tobacco was a middle eastern male with a brown hoodie and a camouflage hat. Terrance J. KELLEGG stated the employee (did not ask for his identification.) I entered the store at approximately 4:37 pm, and identified the clerk based on the description given. I was able to identify the clerk by the description given from KELLEGG. The clerk stated that he didn't sale tobacco product to a minor. The clerk informed me that I can get anything I wanted from the gas station. I informed the clerk with the brown hoodie and a camouflage hat that I don't want anything from the gas station. The clerk identified was the only one in the store that matched the description. I informed the clerk that this was a violation and that a citation will be issued in the future.

I spoke with several witnesses at the gas station whom did not wish to be identified, and PO AVILES of squad 7350, whom was a block south parked outside of Detox, and all witnesses stated they hear a boom, but it did not sound like a gunshot, but rather a car backfire, or car crash. The gas station witnesses stated that they hear the sound come from the intersection area of W Fond Du Lac Av and W Locust Av. No casings were recovered from either area.

On Thursday, February 15, 2024 at 12:39 AM, Squad 7330 (PO Jacob BLANCO and I) were dispatched to a Shot Spotter Complaint at 3115 W Fond Du Lac Av, 53210. This incident was determined to have occurred at approximately 12:36 AM at 3115 W Fond Du Lac, 53210. This is related to IR#240460005 that occurred at 1862 W Fond Du Lac at 12:28 AM on 02-15-204.

INTERVIEW WITH CALLER / VICTIM (Keontae L ESKRIDGE (B/M 08-01-2001))

Upon arrival I spoke with the caller / victim, Keontae L ESKRIDGE (B/M 08-01-2001) who was shot at in his vehicle (2003 tan Chevrolet Suburban PLT#AVH4265). ESKRIDGE stated that he was shot at by Suspect #1 (black male, late 20's, skinny, dark complexion, black hoodie with white graphic on the back and hood, black joggers, black hat, black shoes) who was the driver of the suspect vehicle (2003 silver Mercury Grand Marquis PLT#AJT1721). ESKRIDGE stated that he pulled up to 3115 W Fond Du Lac Av after getting his vehicle shot into near 1800 W Fond Du Lac Av over a road rage incident after he honked at a vehicle (newer model silver / gray 4-dr sedan) that cut him off at the stop sign at that location. ESKIRDGE stated that he went to 3115 W Fond Du Lac Av so that he could follow the vehicle to make sure police caught them.

ESKRIDGE stated that Suspect #1 got out of the Mercury on foot and went to the west side of 3115 W Fond Du Lac Av on the grass median and fired 2-4 shots at his vehicle before getting into the gray sedan as an unknown occupant and fleeing in an unknown direction. While I was on scene for an unrelated Shot Spotter prior to being dispatched to this incident, PO BLANCO and I counted five gun shots coming from the direction of this incident.

CAMERA FOOTAGE

Camera footage shows a corroborating story with the victim statement. PO BLANCO advised me that at 12:34 AM the Mercury drives into the gas station parking lot from W FOnd Du Lac Av. Approximately 30 seconds later the gray sedan pulls up next to the mercury. At 12:35 AM suspect #1 gets into frame and is seen near suspect #2 by the open trunk of the gray sedan. Suspect #1 then walks across the parking lot to N 32nd St, where the victim is in his vehicle, who is on the phone with police from the prior incident near 1800 W Fond Du Lac Av. Suspect #1 then appears to point a handgun towards the victims vehicle and discharges the handgun, to which the victim drives away in his vehicle. Visible muzzle flash can be seen at least twice in the video. Suspect #1 then gets into the gray sedan with Suspect #2 and several others and flees the scene, west on W Locust St.

A second occupant of the gray sedan is an unknown male wearing a black hoodie and black pants. This vehicle fled west bound on W Locust St based off reviewing security camera footage.

00:35:36 an unrelated vehicle flees the gas station, indicating that shots were just fired

00:35:46 Suspect #1 walks back into frame and jogs towards the gray sedan, appearing to conceal an item in his left hoodie pocket

00:36:35 Suspect #1 then gets into the front passenger seat of the gray sedan which flees west on W Locust Av from the gas station parking lot

00:34:56 ESKRIDGE and his Chevrolet drive into frame and park on the east side of N 32nd St behind the gas station out of view from the parking lot; it should be noted that the rear side of the passenger trunk and front passenger window can already be seen to be struck by gunfire from IR#240460005

00:35:25 The Chevrolet drives forward and appears to react to getting shot at by accelerating quickly towards W Fond Du Lac Av

00:35:29 muzzle flash can be seen coming from Suspect#1's outstretched arm as he appears to aim towards the Chevrolet driving away northbound

CST / CASING RECOVERY

See Squad 7369 (PO Blake LAUFENBERG) supplement regarding photos, camera footage and casing recovery. The Mercury was evidence towed to the tow lot #Z004 to await a search warrant for processing.

The casings were located on the west side of 3115 W Fond Du Lac Av, near the east sidewalk of N 32nd St.

I placed the three spent gold brass casing stamped RP 40 S&W under INV#24004452 (1-3).

VICTIM VEHICLE OBSERVATIONS

The Chevrolet is struck five total times that I see (rear passenger tire, rear passenger side trunk, rear passenger side door, front passenger window, front driver side tire. I was unable to locate bullet slugs in the vehicle. I observed the inside of the vehicle to have fragmentation damage from where the path of the bullets would lead to, leading me to believe that the shooter was using a hollow point ammunition possibly. Eskridge towed his own vehicle from the scene after processing.

PO VARGAS spoke to the caller, Elia D. PIERCE, b/f, 12-17-78. PIERCE stated on 03-12-24 at approximately 9:30am, she had pulled into the gas station lot near the vacuum and observed the b/m subject slumped over next to the vacuum. PIERCE stated the subject did not move when she attempted to wake him and was cold to the touch. PIERCE stated she then went inside the gas station and summoned the store clerk to contact the fire department.

PO VARGAS then spoke to the store clerk, Damenpreet SINGH, w/m, 10-11-00. SINGH stated the subject came inside the gas station on 03-12-24 at approximately 3:00am and then walked outside. SINGH could not provide any further information.

The business was cooperative with the investigation. The business had 0 security officers on scene.

PO VARGAS reviewed video surveillance footage. The footage depicts the subject outside the main doors of the gas station at 2:04am. The camera depicts the subject standing by the vacuum, briefly speaking to another B/M, who leaves a short time later.

While on scene, I observed the licenses posted and they were up to date. During my investigation for the dead on entry I did not observe any violations in the licensed premise.

On scene, I spoke with a gas station attended, verbally identified as Hardeep SINGH (W/M, 12-15-1999). SINGH granted me access to the surveillance cameras and put the password into the computer. SINGH was very polite, cooperative and answered all my questions.

I spoke to the primary Officer, PO GRAMINSKE who stated he needed video footage of a possible suspect who on (04-14-2024 at approximately 2:17 AM entered inside the store, argued with security then left the area after a brief altercation.)

I reviewed video surveillance footage. The footage showed shows a male enter the store at approximately 2:17 AM and walked over the beverages where camera 7 was able to pick up his actions. During that time, security can be seen on the other end of the aisle observing his movements. Security and the male appears to engage in a conversation before male individual exits the store. No physical altercation occurred.

While on scene, I observed the licenses posted and they were up to date.

Squad 7342 (PO Issac LORETO / PO Christopher AREVALO) assisted in saturating for the suspect from N 33rd St to N Sherman BI and between W Center St to W Burleigh Av. We were unable to locate the suspect.

On Monday June 17th,2024 at 8:53 PM, Squads were dispatched to the address of 3115 W Fond du Lac Av for a shooting complaint. The victim was killed in the premise when suspects attempted to steal the firearm he had in his waist band.

This report is written by P.O. Kyle KLOETY, assigned to District Seven, Late Power Shift.

Squad 7471, P.O. Kyle KLOETY and P.O. Taylor MOTIFF, arrived on scene, and they did not observe anyone in the parking lot of the gas station. Upon entering the business immediately to the left of the door next to the drink machines PO KLOETY observed a black male wearing a white tank top and white shorts, later identified as David T BRENT Jr (b/m 03-12-1982), lying face down on the ground. There were two females standing around him one of which was wearing purple nitrile gloves and applying pressure to his back. The person applying pressure was later identified as Terry MORAN (b/f 06-05-1977). MORAN stated that she was a CNA and had been outside when the incident occurred but came in to assist.

MORAN assisted PO KLOETY in rolling BRENT over on to his back where he observed a hole in the front left side of his tank top, maneuvering the tank top PO KLOETY was able to observe that this was a gunshot wound. BRENT had a weak pulse and appeared to not be breathing. PO KLOETY began lifesaving measures (chest compressions) eventually swapping with P.O. MOTIFF.

PO KLOETY spoke with the other female that was standing over BRENT when P.O. MOTIFF took over compressions. She was identified as Valerie L BRENT (b/f 07-13-1982). V.BRENT stated that she was not inside at the time of the incident and had entered to check on BRENT. P.O. MOTIFF then requested me to swap out with him again to continue chest compressions.

P.O. MOTIFF then went and observed surveillance footage regarding the incident.

Milwaukee Fire Department, Engine 13 and Med 5 arrived on scene and took over lifesaving measures but eventually succumbed to his injuries.

PO STEFFEN also responded to the scene and initially placed yellow police caution tape around the perimeter of the scene.

Further in the investigation, PO STEFFEN spoke to a witnesses later identified as Valerie L. BRENT (B/F 07-13-1982) and Deandre R. MOODY (B/M 03-28-2006).

BRENT stated that she had pulled into the gas station at approximately 9:00 PM. BRENT stated that her "husband" started to pump gas and walked into the gas station with MOODY. BRENT stated that they both exited the gas station together and returned to the vehicle. BRENT stated that her "husband" stated he forgot to get something from within the gas station and walked back inside of the gas station. BRENT stated approximately two minutes after he walked inside, she heard one gunshot. BRENT stated she then saw 3-4 B/M's wearing black masks and black sweatshirts run out of the gas station. BRENT stated the B/M's got into a Red SUV style vehicle

and a Gray car, unknown makes and models. BRENT stated she did not notice her "husband" exit the gas station, that's when she went into the gas station and saw her "husband" laying on the ground with a gunshot wound to his chest.

MOODY stated he walked into the gas station with his uncle because he had to use the bathroom. MOODY stated he then exited the gas station with his uncle and got back into BRENT's vehicle by the gas pumps. MOODY stated his uncle walked back into the gas station, that's when he heard one gunshot. MOODY stated he only saw "kids" wearing all black and masks run out of the gas station.

On Friday, June 21, 2024, Detective Andrew MARX analyzed video surveillance from a homicide that occurred on Monday, June 17, 2024, at approximately 20:52, at the address of 3115 W Fond Du Lac Av which is Hometown Gas Station.

Forensic Investigator Sarah RAKOWSKI downloaded this surveillance from within this business.

During the observations of this report the suspects will be referred to as follows:

- 1 b/m, Armed, individual who shoots the suspect.
- 2 b/m, with a Nike Pooh sheisty.
- 3 b/m, with a black butterfly sweatshirt
- 4 Driver
- 5 Front passenger Red hooded sweatshirt, white shoes

All timestamps are correct. It should be noted that some of the interior and exterior shots are similar to other camera angles. Because of this, somethings might not be noted twice. However, is something different, or if something close up can be seen, it will be documented.

Camera 1- 20240617204000, 176,392 KB

Is an interior wide shot of the business looking east. The video begins at 20:40 and the picture and quality are not good. At 20:49 and 29 seconds, the suspects can be seen on the upper left. This video ends with nothing more.

Camera 1- 20240617204000 001, 266,504 KB

Exterior showing the gas pumps and the lot looking north. This video is 36 minutes and 2 seconds long, and begins at 20:40.

20:46 - The victim's white vehicle arrives and park to the left of Pump 5, with his car facing northwest. A passenger gets out of the rear passenger door at 20:46 and 37 seconds and the victim also exits about the same time.

20:47 and 13 seconds - the victim enters the gas station.

20:47 and 31 seconds - The suspects car can be seen entering the station from the south which

20:47 and 50 seconds - The vehicle is back on surveillance at the north end of the lot going east. The vehicle stops at Pump #7 facing southeast.

20:48 and 12 seconds - Suspects 2 and 3 get out of the rear passenger door and walk towards the entrance of the business.

20:50 and 8 seconds - Suspect 2 can be seen running towards the car with the front passenger door opening.

20:50 and 12 seconds - S2 quickly grabs something and runs back into the business. S5 can be seen opening the door.

20:50 and 18 seconds - S5 opens the door and yells something.

20:50 and 22 seconds - S2 runs back to the car, quickly grabs something from S2 and then runs into the store again.

20:50 and 40 seconds - The suspects' vehicle leaves the pumps and stops just south of Pump 3, near the front entrance of the store.

20:51 and 20 seconds - S2 and S3 go to the rear driver's side door. While this is occurring, the victim goes to his car to grab something from the driver's side door.

20:52 - the victim closes the driver's door and heads back into the business, while two suspects are still by the rear driver's door of their car.

20:52 and 8 Seconds - Two of the suspects look over to the victim as he enters the business.

On Thursday, 09/05/24 at approximately 9:30 p.m. Squad 7288 (Police Officer Steven MENGE and myself in full duty uniform, operating marked MPD squad 716 and equipped with body worn cameras) did conduct a Field Interview at the address 3115 W. Fond Du Lac Ave. City and County of Milwaukee. This location is a GPC gas station and convenience store. The Field Interview was related to suspected drug dealing in the parking lot of the gas station.

Officer MENGE and I were monitoring FUSUS cameras which are installed at this gas station. We observed a gray, Subaru Tribeca bearing Wisconsin auto plate AXW-1268 parked in the gas station lot near the front door of the convenience store portion of the business. The vehicle was parked in clear view of the clerks of the gas station. Over the course of approximately 50 minutes, Officer MENGE observed three (3) suspected hand to hand drug transactions between the driver and sole occupant of the Subaru and other people. The driver was later identified as Broderick T. THOMPSON a M/B, 04/09/93.

Officer MENGE and I did approach THOMPSON to conduct a field interview. During the field interview, several clear plastic bags of a green leafy substance were observed in the vehicle of THOMPSON. The green leafy substance was suspected Tetrahydrocannabinol (THC). THOMPSON was removed from the vehicle to which he volunteered a black, Taurus G2C 9mm handgun to Officer MENGE.

A search of the Subaru revealed a total of 28.45 grams of THC in 10 different bags and a marijuana cigar. Also present in the vehicle was a black digital scale. Based on the individually packaged marijuana, a scale used to weigh marijuana, loaded firearm and observations of suspected drug dealing it was believed that THOMPSON was indeed selling THC in the gas station lot.

THOMPSON informed Officer MENGE and I that he was actually a security guard at the gas station lot and works at two other locations in the City of Milwaukee (Sherman and Capitol and 42nd and Burleigh). THOMPSON did have a ballistic vest in the rear of his vehicle. During the arrest of THOMPSON a customer of the gas station stated that THOMPSON works at the location.

I did not speak to to licensed premise workers while on scene.

I did not check the license status of the business while on scene.

Upon arrival, we observed no loitering signs, no trespassing signage, no weapon signs, visible functioning cameras, Monitored by Milwaukee PD signage, and flood lights at the location. We also observed signage inside the location. I spoke with the owner who identified himself verbally as Baljinder DHILLON (w/m, 04/15/1977). DHILLON provided me with a cell number of (414) 303-5719.

I informed DHILLON that we were following up with the nuisance abatement agreement. I asked DHILLION if he had been attending the crime and safety meetings. DHILLION stated that the last meeting he attended was in September. I reminded DHILLION that he is required to attend all of the meetings as outlined in his agreement. DHILLON stated that he also attends District 5 Crime and Safety meetings for his other business, and he had the dates mixed up. DHILLION stated that he will be at the next crime and safety meeting in November.

There are no entry doors in the back of the gas station/quick mart; however, we recommended that DHILLION adds signage to the back of the location. DHILLION has successfully completed numbers 2-10 of the agreement, and the only breech in the agreement is attending all of the Crime and Safety meetings.

My body worn camera was activated during this contact with DHILLION.
