In accordance with the regulations of the U.S. Department of Housing and Urban Development (HUD), the City of Milwaukee has prepared and will submit to HUD the following two proposals:

- 1) Five Year Consolidated Strategy and Plan for Years 2010-2014. The Consolidated Strategy and Plan allows local jurisdictions and citizens the opportunity to shape the various housing and community development programs into effective, coordinated neighborhood and community development strategies.
- 2) Funding Allocation Plan with proposed funding categories for Year 2010. The Funding Allocation Plan incorporates strategic direction for the following grants: Community Development Block Grant funding, HOME Investment Partnerships, Emergency Shelter Grants (ESG) and Housing Opportunities for Persons with AIDS (HOPWA).

The Community and Economic Development Committee will hold two public hearings to obtain citizen comments on both the proposed Consolidated Strategy and Plan and the proposed 2010-2014 Funding Allocation Plan.
