

**REVISED STATE/MUNICIPAL AGREEMENT
FOR A
HIGHWAY IMPROVEMENT PROJECT
(Replaces previous agreement dated September 20, 2005)**

The signatory city, village, town or county, hereinafter called the Municipality, through its undersigned duly authorized officers or officials, hereby requests the State of Wisconsin Department of Transportation, hereinafter called the State, to initiate and effect the highway or street improvement hereinafter described.

The authority for the Municipality to enter into this agreement with the State is provided by Section 86.25(1), (2) and (3) of the Statutes.

NEEDS AND ESTIMATE SUMMARY:

Existing Facility - Describe and give reason for request:

A High number of rear end, angle, left turn and pedestrian-related crashes were identified in a safety audit performed by AAA (Automobile Association of America).

Proposed Improvement - Nature of work:

The following improvements are proposed, based the recommendations from AAA:

- ✓ Install Walk/Don't Walk LED housings and countdown timers
- ✓ Modify medians (shorten noses, partial closing)
- ✓ Install left signal housings for EB and WB vehicles
- ✓ Upgrade all signal housings to 12" LED lenses
- ✓ Install overhead mast arm mounted signals in the WB and SB directions
- ✓ Install reflective back plates on all far side and overhead signals
- ✓ Minor timing changes.
- ✓ Pavement marking (stop bars)
- ✓ Operate left-turn arrows at the intersection in all directions, throughout the day

The apportionment of costs for work necessary to finish the project (including non-participating work and work which will be undertaken by the Municipality) is as follows:
