Dear Ms. O'Connor & Mr. Blake:

This office is in receipt of your claim in the amount of \$63.35, relating to a Nintendo 64 game that was allegedly placed on inventory and subsequently was not returned by the Milwaukee Police Department Property Control section pursuant to the arrest of your son on or about October 4, 2000.

The police department records indicate a 13" TV, 2 Nintendo Game Boy games and 2 video game cartridges were seized. The records further note the items were retrieved from the City of Milwaukee Country Store and returned to you on or about November 21, 2000. Since it appears all items that were seized were returned to you and the Milwaukee Police Department followed the proper procedure in this matter, the City cannot accept liability for your loss. Accordingly, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
