8. On 03/14/20 at 10:45am, Milwaukee Police assisted the Wisconsin Department of Revenue Agent at 2908 W. Villard Avenue. Tobacco products were confiscated because of untaxed tobacco and no invoices were located.
 9. On 07/16/20 at 4:20pm, Milwaukee Police responded to 2908 W. Villard Avenue. Investigation revealed a subject entered the filling station, grabbed product, and attempted to flee the location. While fleeing the station, the subject struck an employee causing pain and injury. The employees were cooperative and assisted in the investigation providing surveillance footage. No violations of the business were observed.

10. On 11/10/2020 at 4:41pm officers were dispatched to a Trouble with Subject at Villard Food Mart, 2908 W. Villard Av. The officers observed several subjects standing outside the business. They went inside and spoke with the manager, who stated the subjects outside have been panhandling since 1:30pm and he would like them to leave the property. When the officer went back outside the subjects had left.
 11. On 07/18/2021 at 2:30am officers were dispatched to a Theft at 2908 W. Villard Av. The officers spoke with the clerk, who stated two subjects stole the air pump from outside the business. The officers viewed video of the incident, which was of poor quality.

Officers spoke with employee who stated that the subject was laying on the floor refusing to leave. The employee stated that the subject suffers from mental health issues and comes to the gas station at times. Officers spoke with subject that wished to be taken to his family member's house. Officers conveyed the subject with no further incident.
13. On 05/25/23 at 1:35am, Milwaukee Police were dispatched to 2908 W. Villard Av, for a trouble with subject complaint. Officers spoke with the employee who stated that a subject came to the store and smoked a cigarette in the rear of the store. Officers tried talking to the subject who was observed throwing herself on the ground and screaming. The subject was conveyed to MHEC for mental observation.
14. On 05/28/23 at 3:54am, Milwaukee Police were dispatched to 2908 W. Villard Av, for a trouble with subject complaint. Officers spoke with the employee who stated that a subject came to the store and smoked a cigarette. Officers spoke with the employee who stated two subjects were loitering outside selling drugs. The employee told the subject to leave and they made threats to beat him up. The subjects were last observed walking to the nearby McDonald's. Officers searched the area but did not locate the subjects. The employee was advised to call the police again if the subjects return.
18. On 07/03/23 at 7:07pm, Milwaukee Police were dispatched to 2908 W. Villard Av, for a fight. Per the caller two subjects were outside the location physically fighting over keys. Officers arrived and the subjects involved did not want prosecute each other. The business was cooperative with police allowing officers to review video from the business.
19. On 07/27/23 at 9:16pm, Milwaukee Police were dispatched to 2908 W. Villard Av, for a shooting. Officers arrived and located two vehicles in the parking lot unoccupied. Officers located spent casing around the building. Officers spoke with employee who stated that he called regarding subjects shooting into a vehicle. The business was cooperative with the investigation and provided video. The video showed the incident its entirety. This investigation was filed as a shots fired incident after no one reported any gunshot wounds.
20. On 08/08/23 at 4:10am, Milwaukee Police were dispatched to 2908 W. Villard Av, for a theft complaint. Officers spoke with the employee who stated that a subject took items without paying for them. The employee stated that the subject is unknown and he did not wish to prosecute the incident.
21. On 08/25/23 at 3:28am, Milwaukee Police were dispatched to 2908 W. Villard Av, for a property to damage complaint. Officers spoke with the employee who stated that the subject attempted to take items without paying for them. The employee got the items back, and the subject then got a blunt object and damaged the business door while outside. The subject was accompanied by a female subject during the incident. Officers reviewed the video and obtained suspect and vehicle descriptions.
22. On 08/30/23 at 4:40am, Milwaukee Police were dispatched to 2908 W. Villard Av, for a property to damage complaint. Officers spoke with employee who stated that a subject was at the location knocking over items. Initially the employee locked the subject in the store but the subject starting opening items and pouring them on the front counter. The female then left the location in an unknown direction.
23. On 09/24/23 at 5:45am, Milwaukee Police were dispatched to 2908 W. Villard Av, for a theft complaint. Officers spoke to the employee who stated that a subject took his fire extinguisher from the location. Officers located the extinguisher and it was returned to the business.
24. On 11/18/23 at 3:57am, Milwaukee Police were dispatched to 2908 W. Villard Av, for a theft complaint. Officers spoke to the employee who stated that 2 suspects came to the business and took items without paying for them. The suspect ran south from the location with the items. Officers reviewed video of the incident and obtained the suspect's description.

25. On 12/09/23 3:34am, Milwaukee Police were dispatched to 2908 W. Villard Av, for a theft complaint. Officers spoke to the employee who stated that 2 suspects came to the business and took items without paying for them. The items taken were valued over \$250.00 dollars. The business was cooperative with officers providing video of the incident.
26. 12/20/23 at 1:13am, Milwaukee Police were dispatched to 2908 W. Villard Av, for a subject with weapon complaint. Officers spoke with employee who stated that three subjects that have stolen items in the past, attempted to enter the business. The employee stated that he observed the subjects coming towards the business, and locked the door to deny them entry. The subjects tried the door, and once they realized it was locked left the area. The business was cooperative with the investigation and provided video to officers. No weapons were observed by the subjects during the investigation.

27. On 02/15/24 at 9:36a.m., Milwaukee Police were dispatched to a Threat at 2908 W. Villard. Officers were advised no threats were made, however, a subject was in the bathroom, refusing to leave. The subject left on officer's request.
28. On 02/17/24 at 7:17p.m., Milwaukee Police were dispatched to a Subject with Weapon at 2908 W. Villard Ave. The caller stated an employee had a bat, however, the officer could not reach the caller on callback. The employee stated they were having problems earlier with a panhandler, who was no longer on scene.
29. On 02/28/24 at 1:23a.m., Milwaukee Police were dispatched to a Trouble with Subject at 2908 W. Villard Ave. Investigation revealed a subject came into the store, causing a disturbance, throwing trash on the floor and their drink at an employee. The subject was no longer on scene. The officer viewed video surveillance of the incident.
30. On 10/21/24 at 2:33a.m., Milwaukee Police were dispatched to a Threat at 2908 W. Villard Ave. Investigation revealed the business was having problems with a customer who was causing a disturbance. The subject was no longer on scene on police arrival. Officers did view video surveillance of the incident.

The following items pertain to Villard Food Mart located at 2908 W. Villard Ave.

31. On 02/09/25, at 12:51 a.m., officers were dispatched to a Subject with Weapon complaint. A security guard called after observing four subjects enter the business brandishing guns. The subjects were no longer on scene upon officers' arrival.
32. On 05/03/25, at 1:22 p.m., officers were dispatched to a Theft complaint. An employee stated the actors were gone and no additional police service was needed.
33. On 07/08/25, at 12:22 a.m., officers were dispatched to a Motor vehicle Accident. The accident occurred in the parking lot and a report was filed. Security camera video could not be retrieved by the employee on scene.
34. On 11/11/25, at 5:18 a.m., officers were dispatched to Property Damage complaint. An unknown subject became upset after being sold the wrong Black and Mild cigarette but was given a refund. The subject returned with a metal weight and struck the bullet proof window.

The subject grabbed merchandise and left without paying. Security camera footage was available for review.

35. On 11/12/25, at 1:43 p.m., officers conducting surveillance in the area observed an armed subject in the business with an illegally modified hand gun. The business provided security video camera footage for officers to proceed with their investigation.
36. On 12/28/25, at 9:51 p.m., officers were in the area investigating a nonrelated incident, when a verbal argument in the business' parking lot occurred. A gun shot was heard and a car fled from the lot. A security guard stated he asked the subject of the vehicle to leave the parking lot and an argument ensued, and escalated when the subject pushed him. The subject got into the vehicle and discharged a firearm in his direction which struck his vehicle. The security guard did not want to prosecute. Additional follow up revealed the security guard intentionally gave officers the wrong name. The security guard was found to be a convicted felon in the state of Wisconsin. On 01/05/26 the security guard was taken into custody and found to be in possession of three firearms and body armor. One firearm was concealed behind the counter. Additional follow up revealed several firearms and other items the security guard was restricted from possessing.

On Sunday, February 9th, 2025, at approximately 12:51 AM, I was dispatched to a Subject with A Weapon Complaint at the location of 2908 W Villard Ave (BP Gas Station) (which is located in the City and County of Milwaukee, WI.)

Upon our arrival, I was met by Security Guard, who identified himself as Yohance GERMANY (B/M 01/10/1975), who stated that he observed a White Infinity SUV that's been driving back and forth in and out of the gas station. GERMANY stated at approximately 12:30 AM, he observed 4 subjects coming into the store with firearms. GERMANY stated the 4 subjects were brandishing their firearms. GERMANY stated there were no threats made. GERMANY stated he just wanted to call due to their suspicious behavior and to prevent things from escalating.

I spoke to licensed premise employee, who was identified by his ID as Harjot SINGH (A/M 01/05/1996), who stated that he did not see anything as he was busy working the cash register and helping other costumers. It should be noted that he did not speak English well.

The business had 1 security officers on scene. They were armed. The security officers stated he would like extra patrol throughout the night.

On Tuesday, November 11, 2025, at approximately 05:18 AM, my partner and I were dispatched to a Property Damaged complaint at the address of 2908 W. Villard Av. (Villard Food Mart/ BP gas Station), which is in the City and County of Milwaukee, WI.

Upon arrival at approximately 05:34 AM, my partner and I, were met by one of the store employee/witness, identified as Akashdeep NLN (A/M, 08-08-2004), who stated that at approximately 05:00 AM, at the listed address above, there was a Black female individual/ suspect, came into the store and was arguing with him about being given wrong kind of Black and Mild Cigarette. NLN stated that the female individual asked for a refund and the refund was given back to her. NLN stated that the female individual then exited the store and stated, "I'll be back".

NLN stated that the female individual then came back with a circular exercise weight and began striking two of the bullet proof glass panes, causing damage. NLN stated that a couple minute later the female individual came back into the store and walked into the first aisle and grabbed approximately 10 pairs of gloves, valuing \$2.99 each, and walked pass the last point of purchase without paying for the items.

At approximately 06:00 AM, the store owner, identified as Gurdev SINGH NIRWAL (A/M, 04-04-1961), came to the listed address and spoke to officers. NLN and SINGH NIRWAL was very cooperative and assisted and gave consent for officers to review surveillance footages regarding the incident.

On Wednesday, November 12th, 2025, at approximately 1:43 PM, we were conducting surveillance at 2908 W. Villard Ave., which is located within the City and County of Milwaukee, WI., in a plain clothes/under cover capacity.

We observed a white Chevrolet Trax, bearing WI plate AJC5426, pull into the gas station and park at a pump the operator and sole occupant of the vehicle, described as a black male, approximately 18 years old, with neck length dreadlocks/twisties, wearing a gold chain, black windbreaker, with a black tee shirt, gray pants, exited the driver's seat of the vehicle with a black/tan Glock style handgun with an extended magazine, visible concealed in his jacket pocket. The subject then exited the store a short period of time later armed with the same tan Glock style handgun with extended magazine, concealed underneath his left armpit. I was able to take photographs of the subject obtaining a clear face shot, and still image of the firearm underneath his arm.

A DOT check of the listed plate revealed it listed to a Janay L. DAVIS (B/F, 05-24-1988). A check of MPD records revealed a previously reported child abuse (MPD case#230960151) in which DAVIS was listed as the suspect. A witness, identified as Brandon K. HOLLINGSWORTH (B/M, 06-17-2008), is listed in the report as the biological child of DAVIS. I obtained a WI DOT photograph of HOLLINGSWORTH and compared it to the photographs I took of the suspect at the gas station. I identified HOLLINGSWORTH as the same suspect at the gas station armed with the black/tan Glock style handgun with extended

magazine. I uploaded the still shot of HOLLINGSWORTH holding the firearm onto Axon.

HOLLINGSWORTH has not attained the age of 18 years old and does not possess a valid CCW permit.

On Thursday, November 13th, 2025, at approximately 11:00 we responded to 2908 W. Villard Ave. and reviewed video surveillance of this incident. As HOLLINGSWORTH entered the store, I observed he had the firearm tucked under his left armpit and could clearly see what appeared to be a selector switch on the backside of the slide which is used to convert semi-automatic handguns to fully automatic. While inside of the store purchasing items HOLLINGSWORTH concealed the handgun inside of his jacket as he exited the store.

Employees at the gas station were very helpful and allowed us to review surveillance footage.

This report is being submitted by Police Officer Collin ENK, assigned to District 4 Early shift, assigned to squad 4282 with Officer Sean CARLETON.

Initial Response:

On Sunday, December 28th, 2025, at approximately 9:51pm, Officer CARLETON and I were finishing an investigation related to a vehicle pursuit. It should be noted that the vehicle pursuit has no relation to this event. While on scene an argument could be heard at the gas station, 2908 W Villard Ave (Located in the City and County of Milwaukee), between unknown parties. As I continued my pursuit investigation I overheard one loud and distinct gunshot come from the gas station parking lot. Shortly after I observed a silver/gray Honda Odyssey, with no registration plates, flee northbound on Teutonia Ave away from the parking lot. I then walked to the parking lot to check the welfare of the citizens still in the parking lot. At this time I was met by the security guard who identified himself as Ronnie ANDERSON (M/B 01/10/1975). ANDERSON stated that he had gotten into a verbal argument with the suspect after telling the suspect to leave the parking lot. ANDERSON continued to stated that he suspect got into his face multiple times, specifically one incident that caused ANDERSON to physically push the suspect away from him. ANDERSON then stated that he could tell that the suspect was armed with an unknown caliber handgun. ANDERSON then stated that the suspect got into the driver seat of the gray/silver Honda Odyssey and ultimately discharged a firearm towards his direction. This round struck ANDERSON's 2017 blue Land Rover, bearing WI registration BCD-7990, front passenger window and exiting through the rear quarter window of the driver side. ANDERSON is the security guard at the gas station and is often armed. I did confirm ANDERSON to be armed on this date, I had not asked ANDERSON the information regarding his firearms prior to him leaving the scene.

ANDERSON did originally state to me on scene that he did not wish to press charges. It should be noted that due to a lack of staffing and resources on scene, I was unable to hold the scene and ANDERSON ultimately left the scene before further questioning and photographs of the scene could be done.

Follow Up Conducted 12/31/2025:

On December 31st, 2025, I was conducting follow up for the above listed incident when I discovered that ANDERSON was not truthful about his identity on 12/28/2025. ANDERSON's true identity was determined to be Yohance T GERMANY (M/B 01/10/1975). GERMANY's identity was discovered after a DOT search of the registration plates BCD-7990 listed to a Yohance T GERMANY (M/B 01/10/1975). I then compared GERMANY's booking photos to those of the subject I recorded during an interview on body worn camera footage. I know that GERMANY and the subject who identified himself as Ronnie ANDERSON (M/B 01/10/1975) to be the same person.

A search through Etime of GERMANY's information revealed that he does not hold a valid CCW permit within the state of Wisconsin.

I then conducted an open CCAP search of GERMANY's name to reveal that he has been convicted of a felony in the state of Wisconsin and is not permitted to posses a firearm. It should be noted that on 12/28/2025 I did observe GERMANY to be in possession of 2 handguns of unknown make or model. One firearm was retrieved from his right side in a holster and the other was in his front left pants pocket.

Arrest of GERMANY:

GERMANY was arrested on Monday, January 5th, 2026 at the address of 2908 W Villard Ave (Located in the City and County of Milwaukee) at 8:11 pm. GERMANY was taken into custody in possession of 3 (three) firearms and a armor plate carrier containing two armor plates.

Firearms/Body Armor recovered during arrest of GERMANY:

Black in color Shadow Systems semi-auto pistol with a compensator attachment, chambered in 9mm, with a fully loaded magazine. This item was recovered from a plastic holster on GERMANY's right hip. This item was inventoried as item #2.

Black in color American Tactical semi-auto pistol style rifle with a spent cartridge catcher, chambered in .223 cal, with a fully loaded magazine. This item was recovered from behind the counter of the gas station after the employees of the gas station informed Officers that GERMANY placed the firearm there prior to his arrest. This item was placed on inventory as item #1.

Black in color Ruger Security 9 semi-auto pistol, chambered in 9mm, with a fully loaded magazine. This item was recovered from GERMANY's front left pants pocket at the time of his arrest. This item was placed on inventory as item #3.

Germany was also arrested whilst wearing a green plate carrier that contained two armor plates. This item was inventoried as item #62.

On Monday, January 6th, 2026, I drafted a residential search warrant for the address of 2442 N 20th St #206, this is the address where GERMANY was known to reside at. This was also the address that GERMANY provided when undergoing the booking process at District 4. This warrant was signed and approved by the Honorable Judge Frederick ROSA.
