Hi Joseph,

No, there is only one memo from the Licenses Division. Originally, the file was going to make all of the changes relating to Act 73 for alcohol and tobacco. That's why Jim's memo has information about vaping. But after discussing it with Licenses, it seemed easier and more transparent to divide alcohol and vaping into two separate files. The alcohol file was further divided to just make the changes relative to the fixed full-service retail outlets and the unlimited transfer full-service outlets. The remainder of the alcohol provisions relating to tastings, and axe throwing and changes in notice will be in a subsequent file.

The intent of the ordinance that you are looking at is to incorporate the two new license types created by Act 73 into our ordinances and makes them subject to the same process and fees that we use for other alcohol establishments.
