
Dear Mr. and Mrs. Morgan:

This office is in receipt of your claim in the amount of \$790.41, relating to damage sustained to vehicle on March 20, 2001 when it was allegedly scratched during garbage pick-up by City crewmen at 453 North Story Parkway.

The Sanitation Division records indicate that the Sanitation crew assigned to this location denies causing said damage to your vehicle. Since there is no evidence to support your claim the City cannot accept liability. Accordingly, we are denying your claim.
