This report is written by Police Officer David Novak, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 10/14/2017 a 17 year old working in conjunction with the Milwaukee Police Department and WI WINS Tobacco initiative, was able to purchase a Jaz Black and Mild cigar from the clerk at La Franja Grocery, 2366 S 9th Pl. The clerk did ask for ID but sold the cigar even though the ID showed she was 17 years old. The clerk was identified as the applicant. He stated he must have calculated the age wrong. A MARTS letter was mailed to the applicant.

2. On 06/23/21 at 10:51am, Milwaukee Police conducted a license premise check at 2366 S. 9th Place. Officers found that the current applicant did not have any licenses issued to him and that he was working under the old applicant's license. The old applicant was told that he could not have another applicant work under his license.
3. On 06/24/21 at 11:50am, Milwaukee Police did follow up regarding Item #2. The old applicant and the new applicant were advised as to how to get their licenses in order and that the new applicant cannot use the old applicant's license. Both applicants stated that they understood the process.

4. On 06/28/21 at 3:00pm, Milwaukee Police conducted follow-up on Items #2 and #3. They found the new applicant still operating under the old applicants license and there was no responsible person on premise. The business was closed and citations were issued for Responsible Person Upon License Premise and Use of License by Another Prohibited.

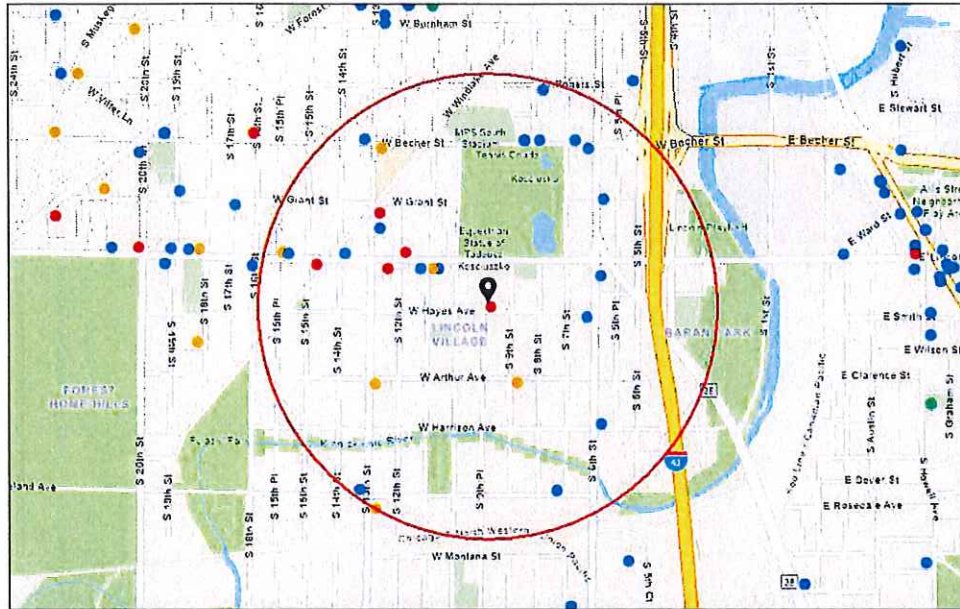
Items #2-4 added to Previous Premise

City of Milwaukee Concentration Map

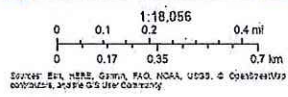

The above application has been made by the above named applicant(s). This requires approval from the Licenses Committee and the Common Council of the City of Milwaukee. The hearing before the Licenses Committee will take place virtually on 07/19/2022 AT 09:50 AM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at <http://city.milwaukee.gov/citychannel>. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.




