#### Addendum

On December 22, 2022, the owner Mr. Daljit S. Kler left a voicemail message for Mr. Michael Tonelli at (414) 286-3975 to discuss the charges. The voicemail message stated that Mr. Tonelli would be out of the office until January 3, 2023.

On January 3, 2023, Mr. Tonelli called Mr. Kler. Mr. Tonelli advised Mr. Kler in that conversation that the "\$2,032.00 amount can be removed".

Subsequently, Mr. Kler left four voicemail messages for Mr. Tonelli to which he didn't respond.

On February 15, 2023, Mr. Tonelli called Mr. Kler and advised me that he'd have to discuss the issue with Jermaine his supervisor.

Mr. Kler and Mr. Tonelli spoke several times subsequently. The matter is still unresolved for both calendar years 2022 and 2023.
