There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. It is the intention of the Common Council to suspend or non-renew the licenses if objectors provide testimony related to the factors enumerated in MCO 85-4-4 that the Common Council finds to be true by a preponderance of the evidence and/or police reports are found to be true by a preponderance of the evidence. The police reports and other attached documents relating to objections to the license are a part of this notice and expressly incorporated in this notice. The licensee should be prepared to address these matters at the hearing.

Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

This report is being written by PO Justin YOUNG assigned to District 3, Late Shift.

On Monday, December 23rd, 2024 at 2:30 AM, Squad 3390 (PO Derek KOLB and I equipped with Axon body cameras that were active during this investigation) was dispatched to a Property Damage call for service at N 39th St and W Center St, which is in the city and county of Milwaukee. PO KOLB and I arrived on scene at 2:31 AM where I observed a door on the west side of the building at 3833 W Center St (Quick Foods) with the security gate broken and the door damaged. PO KOLB, Squad 3368 (PO Adriana GALVAN) and Squad 7369 (PO Blake LAUFENBERG) cleared the locked business but did not observe any suspects inside of the business. PO KOLB got a hold of the camera system and pulled up video surveillance which captured the incident. The following is a synopsis of the incident through multiple views.

2:12 AM- Suspects entered the business through the door and run through the back of the business.

2:13 AM-2:14 AM- Suspects begin placing different items from the business and placing them in different bags that each suspect is holding.

2:15 AM- One of the suspects goes from the back of the store with a crowbar in hand and begins to pry the lower panel of the entrance to the register area. The suspect with the crowbar and another suspect then crawl through the pried opening and begin placing more items into the bags.

2:18 AM- Suspects then leave out of the business and flee in unknown direction.

The following descriptions of the suspects were gathered from the video surveillance. They are described as the following:

S1- B/M, MEDIUM BUILD, 506-508, PULLOVER SWEATSHIRT WITH HOOD UP, BLACK OR DARK COLORED SHOES, LIGHT COLORED PANTS, BLACK SKI MASK. ENTERS THE REGISTER AREA.

S2- BLACK MALE, 600, HEAVY BUILD, ZIP UP HOODIE WITH HOOD UP, BLACK MASK, BLACK SANDALS, BLACK MASK

S3- BLACK MALE, MEDIUM BUILD, PULLOVER HOODED SWEATSHIRT WITH HOOD UP, BLACK MASK, BLACK PANTS, BLACK MASK. ENTERS REGISTER AREA AND WAS THE SUSPECT WHO PRIED OPENING WITH CROWBAR

S4- BLACK FEMALE, BLACK HOODED SWEATSHIRT WITH WRITING ON THE BACK "IF LOST OR DRUNK,

The video surveillance was downloaded by PO KOLB and will be uploaded to Axon.com. I notified District 3 Acting Lieutenant Sergeant RODRIGUEZ who stated that CIB would not be responding and that it was my investigation to handle.

Forensic Investigation Autumn WELLS responded and processed the scene for photo documentation and processing of the scene. See supplemental report regarding.

I attempted to notify the owner of the Quick Foods mart but received no answer. A PV-17 was left inside of the business as the board up was called due to damage of the door.

On Monday, July 28th, 2025, at 9:04 p.m., while assigned to Squad 3440, P.O. Omar CONTRERAS and I were dispatched to 3833 W Center Street (Quick Food Market), located in the City and County of Milwaukee, regarding a Stabbing in Progress Complaint.

While enroute the call for service notes indicated there was a subject stabbed at the location and there was lots of blood observed on scene, the notes further stated the suspect was still on scene and was described to be WEARING BLU JEANS// NO SHIRT// BLU HAT// SMALL AFRO//.

Upon arrival, I observed the interior of the convenience store to be disarray. I observed an end cap on the floor with chip bags and other miscellaneous items scattered all over the floor. While assessing the scene, P.O. CONTRERAS and I observed a male subject matching the description of the suspect provided by the call for service notes. The male subject verbally identified himself as Lamont E WALLACE (M/B 06/10/75). WALLACE appeared to be profusely sweating while eating a bag of chips. WALLACE initially stated he stopped by the store while on the way to his wife's home. WALLACE stated a male subject approached him and told him to watch his back. WALLACE stated the male subject began following him around and began being chased around the store by the subject who was armed with the knife. WALLACE stated the incident became physical and stated the incident was "unwarranted". WALLACE stated the incident had to have been captured on the surveillance cameras. WALLACE stated he believed the suspect had dreads then stated he could not recall what the subject looked like and stated he has never seen him before. WALLACE was detained and placed in the back of Milwaukee Police squad 65340 until we investigated the incident further.

I checked the interior of the store for the blood which was not located. Squad 3231, P.O. Nicolas ORNELAS and P.O. Christian CASIANO, Squad 3451 P.O. Michael WARD, P.O. Alfonso TOLEDO arrived on scene to assist. P.O. WARD and I checked the exterior perimeter of the dispatched address for a blood trail or any other possible victims, which were not located.

I spoke to the store clerk who verbally identified himself as Yash NANKANI (M/A 01/16/02). NANKANI stated at approximately 8:30 p.m. he observed a verbal argument ensue between two individuals while in the checkout counter. NANKANI stated he told both subjects not to fight in the store and asked them both to leave. NANKANI stated the male with the blue hat called the subject in the white shirt back as he

was leaving at which point it became physical between the two. NANKANI stated he did not observe any weapons. NANKANI stated the both subjects caused the damage to the store while in the physical altercation. NANKANI stated he is unsure what the value of the damages is and contacted the manager regarding the incident. NANKANI stated he will be notifying the owner of the store who he verbally identified as "PINKY" who was not on scene during the incident.

NANKANI contacted the store manager via phone, I spoke to a female who verbally identified herself as Mamta SINGH (F/U) store manager. SINGH stated she will be assessing the damages in the morning and will contact the officers in the morning. Mamta stated she wished restraining order information.

P.O. CASIANO recovered surveillance video captured by the in store and exterior cameras. The video was uploaded as Milwaukee Police evidence to Evidence.com.

I spoke to WALLACE while in the back of the squad. WALLACE stated he wished to be a complainant regarding the incident. WALLACE stated he did not consent to be assaulted. WALLACE stated he did not know the subject he had the physical altercation with, and described the subject to be approximately 20-30 years old. WALLACE stated he was chased around the store trying to get away from the subject. WALLACE became agitated with me and changed his mind and requested medical for pain to his right hand. CURTIS 315, arrived on scene and conveyed WALLACE to Mt Sinai hospital.

While on scene, a group of bystanders approached us and stated they observed the subject involved in the incident in the 2600 block of N 39th street. P.O. ORNELAS, CONTRERAS and I responded to the area where the subject was last seen. We searched the immediate area but did not locate the subject.

I took photos of the scene, the photos were uploaded as evidence to Evidence.com.

P.O. CONTRERAS and I relocated to Mt. Sinai hospital to follow up with WALLACE regarding the injury. WALLACE was admitted by medical staff at 11:04 p.m.

Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.
Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
