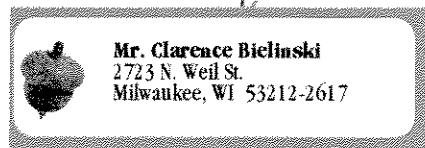

Attached is a copy of the items taken and destroyed by them and you should be able to see that they went away overboard. And I would like to receive compensation for said items.
