This letter is recognized as official notice that payment is being demanded for the car accident that occurred on 6/3/2025. The total demand estimated amount, after calculating payments of the event, is **\$2,130.91** .

STATEMENT OF FACTS: CAR ACCIDENT

On Tuesday, June 3rd, 2025, at approximately 8:50AM, the following auto accident occurred, in the city of Milwaukee, WI, as described: I, Lanaja M. Lucas, was getting off the I-43 ramp in my 2020 Toyota Corolla XLE, onto West Garfield Avenue, to then turn left onto North 7th Street, when the other driver, identified as, Margaret Davis, operating a parking enforcement vehicle, hit my vehicle while turning into my lane.

On West Garfield Avenue, it is a two lane turn onto North 7th Street, which then becomes a one way road with a left turning lane, a straight lane, and a right turning lane. Once we turned onto North 7th Street, it was immediately apparent there was construction in the left lane. However, the guidance from the construction cones shows for whoever is on the left (I, Lanaja Lucas) to turn into the middle lane and whoever is on the right (Davis) to turn into the right lane. As we were both turning, I was following the construction signage and stayed in my lane, consequently; Davis, did not and turned into the same lane, causing impact to the right side of my vehicle.

After impact, I immediately followed Davis to North 6th Street, until she pulled over. We then exited our vehicles to observe the damage from the incident in question. Davis, commented to me "There is nothing wrong with your car" which was false as there is indisputable evidence of damage to my mirror, under my mirror, and along my passenger door. Davis also stated, "Are you really going to call the police?" I replied "Yes, I am because you just hit my car." After that verbal exchange, we did not speak to one another and waited for the Milwaukee County Sheriff Department (Sheriff, Z. Zuraff) to arrive on the scene . The reporting took about 45 minutes, I left the scene at 9:46am.
