To Whom It May Concern:


My name is Willie Jackson. On May 18, 2018 I was visiting Milwaukee attending my nephew graduation at The Milwaukee Theatre at 500 W Kilbourn Ave. Between 4:15 - 4:30 I was crossing the street on 4th and Kilbourn and my feet went into the broken concrete and I fell hurt both of my knees. The right knee was cut badly and the left knee was bust open and I had to receive 8 stitches from the fall. There was a car accident on the same street. When I fell the police officer came to make sure I was ok and asked did I need any help; I told him I didn't because at the time I didn' feel I need any medical help at the time. As I went into the building I checked my leg due to my pants feeling wet and that is when I noticed that it was cut open and bleeding very bad. At this point I had to let my family know I had to leave because I have to go to the ER because of my leg. I would have been filed my claims but I have not received by bill from Froedtert Hospital have not came yet.

I came up there from Arkansas to attend my nephew graduation and to attend his after event with the family but I could not go due to the bleeding and pain and having to go to the ER to get stitches. I would like to put a claim in for \$15000

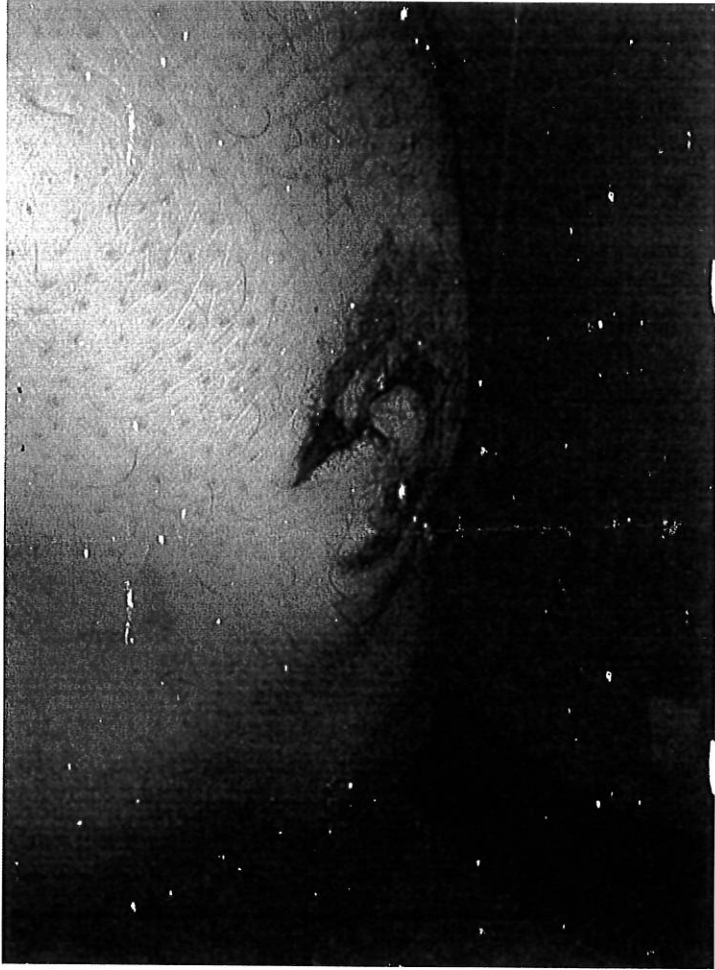

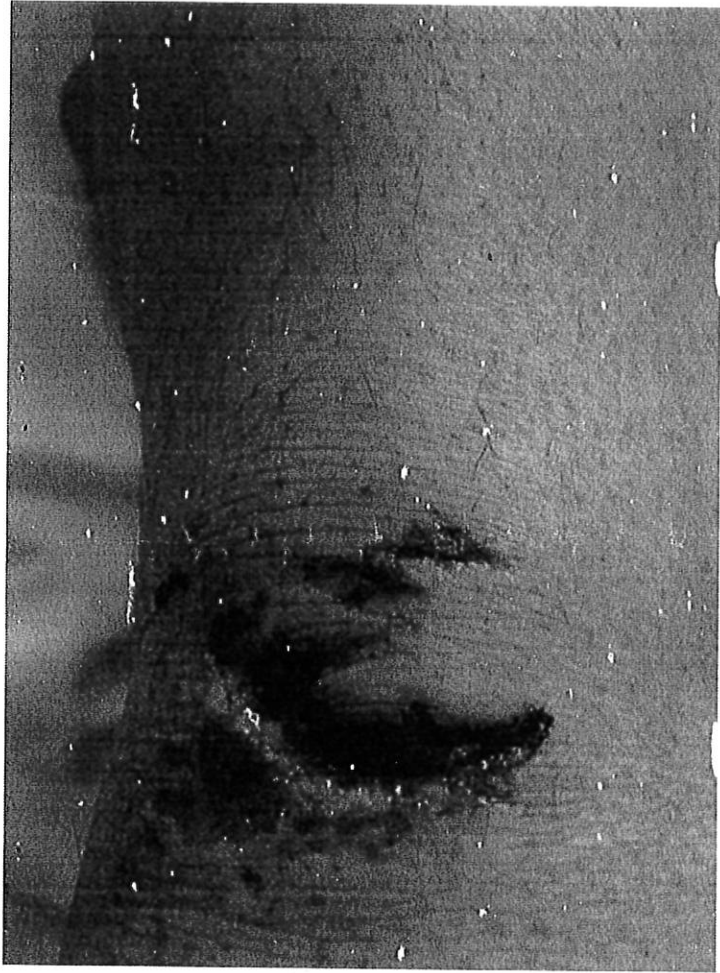
