Dear Ms. Hess:

This office is in receipt of your claim in the amount of \$1,132.03, relating damage to your vehicle on April 1, 2005 when a basketball hoop fell on your vehicle while it was parked at 3626 West Fond Du Lac Avenue.

Our investigation reveals that an unknown person moved the hoop to an upright position next to your vehicle and caused the hoop to fall on it. There is no evidence that the damage was caused by the negligence of any City employee. As such, the City would not be liable for your loss. Accordingly, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
