#### **INITIAL INVESTIGATION**

This report is written by PO James PITTMAN, assigned to Squad 1360. On Sunday, May 13, 2018 at 5:39 a.m. I responded to a sick/injured 911 call at Jackson's Blue Ribbon Pub, at 1203 N 10th St, in the city and county of Milwaukee, State of Wisconsin.

The 911 caller reported that he was the morning cleaner, and he entered the bar area of the hotel (which was locked) to find a male and female both unconscious. MFD Engine 2 and Truck 2, Green Shift, arrived and determined the two subjects were only highly intoxicated by alcohol and not under the influence of any narcotics.

MFD reported they found the male sleeping under the bar and the female in a corner of the establishment.

I met with Chelsea L HUTZENBUEHLER (w/f,9-18-1988), who said she is the bar manager and closed up last night. She invited a male patron, Joshua T HUNTER (w/m4-21-1992) to stay with her at the bar after hours to drink alcohol and socialize. HUNTER is a registered guest at the hotel.

Both HUTZENBUEHLER and HUNTER refused medical care. I verified with the hotel manager on duty that HUTZENBUEHLER is, in fact, employed by the hotel/bar and was authorized to be in the bar.

Further investigation revealed that HUTZENBUEHLER has a valid permanent bartenders license, issued by the City of Milwaukee in 2012.

HUTZENBUHLER was highly intoxicated and had difficulty walking, speaking and staying awake. However, she was courteous when giving information.

HUNTER was argumentative with MFD rescue personnel.

- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimonv.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 11/02/2017 at 2:01am officers investigated a shots fired Complaint in the area of E. Mason St and N. Broadway St. While on scene a shooting victim arrived at St Mary's Hospital. The investigation revealed the victim was at the District Night Club earlier with a group of friends. During the night an unknown subject bought her a drink. The same subject later touched her breast. After closing the situation escalated outside which resulted in shots being fired by both parties. The District was cooperative with the officers and provided video surveillance footage. The District pats down all patrons prior to them being allowed inside and the subjects involved had obtained their guns from their cars.
- 2. On 11/13/2018 officers investigated a Battery DV that started at 628 N. Water St in line waiting for the District Bar. The victim was in line with the suspect who was kicked out of the line by security for smoking and a dress code violation. The victim and suspect walked off and the suspect hit the victim in the head. The victim asked security to help her get her keys from the suspect but they refused stating she would need the Police to do that. The victim then leaves the scene. The tavern supplied video to the officers.
- 3. On 12/14/2017 at 3:07am a subject went to District One to report an incident that occurred at The District, 628 N. Water St. The victim stated she was standing at the bar when a subject came up behind her and pulled up her skirt exposing her underwear. She reported the incident to security who confronted the subject and kicked him out. The victim observed him return at closing time and be allowed back in the bar. The officer made attempts to follow up at the tavern but it was closed.

4. On 01/09/2018 a meeting was held at District 1 regarding incidents at The District, 628 N. Water St. Captain Rowe suggested an ID scanner and a staggered or early release to avoid problems with 618Live closing at the same time. Security cameras were discussed. The applicant stated she has 6 cameras inside and 2-3 outside. She stated the footage is saved for 7 days. The applicant was reminded to call the Police when incidents occur. She stated she has hired a new General Manager but he doesn't have his manager's license yet.

- 5. On 02/28/2018 an officer met with the applicant regarding safety updates. The applicant advised the officer of the new ID scanner which is connect to a data base that track people kicked out of taverns nationwide. She also showed him new security cameras installed inside and outside. She stated that she has added two security officers outside in a car that are capable of going mobile if needed.
- 6. On 10/06/2018 officers responded to St Mary's Hospital to investigate a battery that occurred at District on Water, 628 N. Water St. The victim stated she was inside when a subject pushed her. When she confronted the person about the push she was punched in the face by a third subject. the Police responded to District on Water and spoke with the applicant. The officers were shown the ID scanner which had a picture of the subjects ID but could not view the video surveillance because nobody, including the applicant, knew how to operate the system. The suspect was located and arrested.
- 7. On 11/04/2018 officers were monitoring District on Water, 628 N. Water St. The Officers reported there were shots fired inside the tavern and located a victim, who is 18 years old. The victim was inside the tavern with her 17 year old friend. The investigation revealed the victim and her friend used an ID that belonged to someone else to get in the tavern. The employees were cooperative with the investigation and provided a copy of the video to the officers. The officer estimated there were 300 patrons inside and saw the posted capacity was 225. The officer used the video surveillance on the front door to count the patrons as they left and had a count of 383 when the video stopped at 1:20am, prior to all patrons exiting. This count was 158 over capacity. While watching the cameras the officer observed patrons walking around with full bottles of liquor. The business manager was not able to provide names of security personal on scene, he could only give nicknames. The officer also observed a smell of marijuana by the hooka pots and packaging for marijuana that tested positive for THC. The applicant was issued a citation for over capacity.

8. On 11/09/2018 a meeting was held at District 1 regarding District on Water. The issues discussed included: over capacity, marijuana recovered by the hooka, not knowing the names of security officers, using a promoter, and underage patrons. The applicant stated they do not use a promoter, they have a subject on staff the promotes the business on Facebook and would install a metal detector.

- 9. On 12/06/2018 at 2:05am officer conducted a tavern check on District on Water, 628 N. water St. The officer observed a patron leaving after hours. The officer went in and spoke with the applicant who stated the subject was having trouble closing his tab and another person was waiting to give an employee a ride home. The applicant was advised a PA33 would be written.
- 10. On 12/28/2018 officers, along with an inspector from the health department, conducted an inspection at District on Water, 628 N. Water St. The applicant was on scene.
- 11. On 01/26/2019 officers were dispatched to a battery cutting at District on Water, 628 N. Water St. The officer spoke with the applicant who stated she did not know of any problem in the tavern. she then remembered a friend who had a cut on his head from a broken bottle. The officers returned later and spoke with the bar manager who provided video of the victim leaving the business with the cut on his head.

## PA-33 Narrative

This report submitted by P.O. Thomas Kline, District One, Early power Shift.

On Wednesday, February 28, 2018, I, P.O. Thomas Kline met with Patsy J Smith, W/F, 08/30/1952, regarding the safety updates she made to the District VI, located at 628 N Water Street.

Smith first went over the new ID scanner they had installed, which takes a photo of the ID. The system keeps tracks of people who have been banned nationwide from bars, and what the incident was. Although Smith stated they may not turn someone away because of the alert, but the person will be watched while in the tavern. The monthly subscription for this service is \$295. Smith stated she would be more then willing to cooperate with the police if we were looking for someone.

Smith then showed me how she had a security camera installed in the alley, which was suggested to her at the prior meeting. She is also in the process of having three additional cameras installed inside the tavern, which was not suggested of her. She stated they now have an upgraded system which will store the video footage for 30 days.

Smith stated she or her manager holds nightly meetings with the security staff before the tavern opens, to go over things to watch for, and how to properly conduct themselves. The security staff are equipped with radios so they can communicate with each other. She stated she has also added a two man security detail who park in a security car outside the front door, and are capable of going mobile if need be.

Attorney Vince Bobot and manager Salvatore G Safina, W/M, 07/27/1973, were present during the inspection.

On 10/06/2018 at 1:41AM I PO Elliott SANDERS-BARTA (Squad 1340) was dispatched to 2301 N Lake Dr, Columbia St Mary's Hospital regarding a Battery complaint.

On scene in the ER waiting room at 1:50AM I spoke to victim, Alexis I BUTH (W/F 10/02/1995) who stated that she was punched in the face while at the bar, "District On Water." District On Water is located at 628 N Water st. On scene I observed a small laceration to BUTH's lower left lip and bruising to her left cheek.

BUTH stated that she was at District On Water to celebrate her birthday. BUTH stated that she was at the bar for a short time when between the times of 1:00AM and 1:15AM a female known as Veronica CERRATO (the girlfriend of the later identified suspect) tapped her on the shoulder. BUTH stated that she turned around and Veronica pushed her. BUTH stated she approached Veronica and said, "I don't even know you." When BUTH said she was saying this she was punched in the face with a closed fist by Amani M WILBORN (B/F 03/07/1997) an acquaintance of CERRATO. BUTH said she was knocked back by the punch but did not fall to the ground. BUTH stated that security moved the parties away from each other, and she was escorted out of the back of the bar. BUTH stated that WILBORN was escorted out of the front of the bar. BUTH said the punch caused pain and injury as she was bleeding from her lip. BUTH did not give

BUTH drove to Columbia St Mary's and was seen at the Hospital in ER #29 by MD Melissa JARBOE with the admit time of 2:05AM. BUTH received one suture to her lower lip as a result of being struck by WILBORN.

WILBORN is known to BUTH because BUTH's sister and witness, ALANA Y BUTH (W/F 07/01/1999) had an intimate relationship with WILBORN in the past.

I responded to 628 N Water St, District On Water, at 2:34AM on 10/06/2018 to speak to employees regarding the incident. I spoke with owner, Patsy S JAMES (W/F 08/30/1942). JAMES said she is aware of the incident and saw the commotion after the incident occurred. JAMES said the two parties were separated and removed from the bar. JAMES said they have a ID reader at the entrance of the building and scan every ID that comes into the bar. JAMES was able to show me the results from the card reader and I saw that WILBORN and CERRATO entered he bar and had their ID's scanned at 12:47AM. JAMES said WILBORN is a regular at the bar and recognized her as being involved in the incident.

There are multiple surveillance cameras inside and outside of the bar, however the staff at the location including JAMES said they were unable to retrieve and video or view any video because they do not know how to operate the system.

I contacted Sergeant Kevin SADOWSKI the Acting Lieutenant at District One and notified him of this incident. Sergeant SADOWSKI advised that the Criminal Investigation Bureau would be responded to assist in the investigation.

Myself, PO Justin ARREDANDO and PO Johnathan ECHEVARRIA (Squad 1365), Detective Shaun LESNIEWSKI (Squad 9358), Detective Baniel BOECK (Squad 9375), Sgt Marcin PAGACZ (Squad 1311) and LT Marlon DAVIS (Squad 9307) met at 1500 E Wells St along with Marquette PD at 5:33AM. Marquette PD let us into the building and knocked on room 240. WILBORN answered the door and was placed in custody at 5:45AM for Substantial Battery.

Squad 1365 conveyed WILBORN to Central Booking for processing at 5:51AM.

## **TAVERN INVESTIGATION**

This report was written by P.O. Brian LaROQUE, assigned to District One, Late Shift.

On November 4, 2018 officers were monitoring "District IV" a tavern located at 628 N Water St. At 1:12am the officers reported that there were shots fired inside of the tavern and requested assistance.

I responded to the location to assist with crowd control and later with the tavern investigation.

While enroute to the location we were informed that there was a female who was struck by the gunfire in the abdomen. I was later informed that the victim was identified as Lyric L BELSER (B/F, 8/30/00) and that she was 18 years old. I later learned that she arrived at the tavern with a friend of hers who was identified as Diamond S LOCKETT (B/F, 11/4/01).

During the investigation we learned that both LOCKETT and BELSER used an identification card belonging to someone else to enter the tavern. I also learned that LOCKETT entered the tavern prior to midnight the making her 16 years old when she was allowed to enter the tavern.

Through my investigation of the tavern I spoke with Salvatore G SAFINA (W/M, 7/27/73) who informed me that he was the tavern's general manager. SAFINA stated that he is in charge of inventory for the tavern, and the hiring or termination of employees. I asked SAFINA if he has a Class B Managers License with the City of Milwaukee and he stated that he does not. SAFINA stated that he understands that he needs one and that he has completed the paperwork but has not turned it in. I asked SAFINA how long he has been the general manager for the tavern and he informed me that he has been in that role for about 1 year.

SAFINA did cooperate with the investigation and quickly provided us access to the camera system and provided us with a copy of the requested footage.

I spoke with Lorese C BANKS (B/M, 9/4/85) during the investigation who informed me that he is the tavern's promoter. I was informed that David J GAFINA (W/M, 8/17/75) was on scene at the time of the incident and that he is the kitchen manager for the tavern. I was also informed that Juan J GONZALEZ-SOLANO (W/M, 12/14/74) was at the scene at the time of the incident and that he is the bar manager. I verified and confirmed that GONZALEZ-SOLANO does have a valid Class B Manager's License.

When I arrived on scene and conducted my initial walk through the tavern to clear the building of any potential threats I estimated there to be close to 300 patrons inside of the tavern. It should be noted that this was an estimate based on initial observations to include the patrons that were running from the front door when I arrived on scene.

I reviewed the occupancy permit and license for the tavern and learned that they have an occupancy limit of 225 persons. I later reviewed security camera footage from the front door

foyer door of the building and counted the number of individuals that left the tavern starting at 1:11am ending at 1:20am. It should be noted that his camera points directly at the entrance door near within the foyer of the building. This angle provides me with a detailed view of the door and from this angle I was able to conduct an accurate count of the individuals leaving using a digital counter. During my review of the security camera footage I counted 383 persons leaving the tavern.

It should also be noted that the video stopped at 1:20am and from my view of other camera angles of the tavern there was an estimated additional 50-60 persons that I was not able to get an accurate count of still inside of the building at this time. This indicates that the tavern was over capacity by 158 persons that I could confirm.

During my walk through of the tavern I noted that the business was selling the use of hookahs. I also noted that there was a strong odor of burnt marijuana emanating from inside of the business. While checking the hookahs and areas around them I noticed tobacco products as well as what I believed to be "blunts" or marijuana cigarettes. I also located two plastic corner cut baggies with a green leafy plant like substance in them. I collected the two baggies and later tested a sample of the substance using Nark II Pouch 05 field test kit. It tested positive for the presence of Tetrahydrocannabinol (THC) and had a total weight of 0.96g. It was placed on Milwaukee Police Department Inventory 18041493.

When checking the front entrance I checked with employees if they had a cover charge for the day. They stated that they did and that it was \$10 for females and \$20 for males. During the course of the investigation witnesses stated that some of them had paid a \$15 cover charge when they entered. It is unknown at this time where the discrepancy has developed from. When I asked about the cover charge the employees were cleaning the area and showed me a sign that stated \$10 females, \$20 males. The sign was not posted when they showed it to me but it may have been on the counter during the time the business was open.

I also noted that there were bottles of liquor on the floor of the business. While reviewing security camera footage from inside of the tavern I observed people carrying around full bottles of liquor on the floor and that one of the bottles also had a large flame coming from it. It appeared to be some kind of sparkler or pyrotechnic that was placed in the mouth of the bottle of liquor. This is a concern as the floor of the tavern was covered in a sticky substance believed to be spilled liquor or alcohol.

During the course of my investigation I reviewed License Information using the Lira website for the City of Milwaukee. This site also allowed me to review the application that was submitted by the agent, Patsy SMITH-JAMES (W/F, 8/30/42).

I also noted that the application indicates that they will have licensed and trained security on premises during business hours but when I was speaking with SAFINA he was unable to provide the names of the security guards working the night of the shooting. SAFINA could only identify the security guards by their nicknames. In addition I noted that in the application the agent marked that Promoters would not be used for any of the entertainment at the tavern. This is contrary to my investigation for when I spoke with BANKS he indicated that he is the promoter for the establishment and this was confirmed by SAFINA.

On Friday, December 28th, 2018 at 10:30pm I, along with City of Milwaukee Health Inspector Lindy WIEDMEYER went to 628 N Water St, District on Water to conduct an inspection. WIEDMEYER stated that the City had gotten a complaint about the business which resulted in this inspection.

Upon entering the business we were greeted by the business agent, Patsy JAMES. WIEDMEYER identified herself to JAMES as being from the Health Department and informed her that we were there to conduct an inspection. JAMES seemed shocked that we were there and told us that she was going to go put her cup of coffee in the office and get right back to us. It was approximately ten minutes before JAMES returned to us and led us back into the kitchen.

Once we got into the kitchen we me with the bar manager, Salvatore SAFINA (M/W 07/27/73). SAFINA questioned why we were there and stated that he does not serve food at the bar. SAFINA stated that it has been three to four months since they last served food. A check with the City of Milwaukee License database shows that District on Water has a class B tavern license and a food dealer license. Both are valid until 04/08/19.

While WIEDMEYER was conducting the inspection of the kitchen I observed that there was multiple bags of frozen chicken wings in the freezer. One of the bags was open and about half full. It did not appear that there was any freezer burn or any other indication that the food has been sitting for three to four months on any of the chicken wing bags in the freezer. I observed that one of the burners on the flat top grill was on and that the two fryer units were turned on and hot.

I again asked SAFINA if they were serving food at the bar and mentioned the "bar food" that was in the freezers. SAFINA again claimed that they haven't served food at the bar in three to four months and that the food was for personal use.

Patsy greeted us and asked if everything was ok, I informed her that we were dispatched to a Battery Cutting complaint that happened in her tavern. Patsy stated she was not aware of anyone that got stabbed in her bar or any incident that occurred. Patsy then informed me that she remembered now that she had a friend in the bar that was cut on the top of his forearm with a broken bottle, Patsy provided him with basic first aid care and he left.

Later that evening we returned back to the tavern and spoke with SAFINA, Salvatore G. (W/M 7/27/1973) who is the manager of the tavern. Salvatore provided us with the surveillance video from the incident. I briefly viewed the video that was provided to us and observed a recording from the front entrance of the tavern which is the camera labeled "front door" or camera #7. At 1:29 AM I observed a male who was later identified as our victim RODRIGUEZ, Ricardo (W/M 12/18/1974) leave the front the door. As Ricardo turned towards the camera I observed a large cut on his left ear which continued down towards his neck. Ricardo's shirt also had a large wet spot on the front which appeared to be blood. Ricardo then waited for more people to exit the bar and left with the other people out the front door. Ricardo and a female leave the tavern and continue south on N. Water St. until they are out of camera view. I placed the video on MPD inventory for evidence.
