This report is written by Police Officer David NOVAK, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On March 23, 2007 plain clothes Milwaukee Police Officers conducted an underage alcohol buy at 1230 N. Van Buren St. (Victor's). A 20 year old Milwaukee Police Aide successfully purchased two 12 ounce bottles of Miller Lite beer from the bartender, Tanya Armstrong.

- 2. On 08/07/08 at 3:11 am, Milwaukee police were dispatched to 1230 N Van Buren for a Trouble With Subject complaint. Police spoke to the caller who stated he was at Victors bar and was getting up to leave when he stepped on a piece of glass. The victim stated he felt a sharp pain immediately and grabbed a bar stool hitting his shin causing more pain. The victim stated he spoke to the bar manager regarding what happened but that the manager didn't do anything about it so he left the bar. Officers spoke to the manager, Victor Jones, regarding the victim's complaint and Jones stated the victim complained earlier about the doorman bumping into him causing him to spill his drink but that the victim never told him about any injury to his foot.
- 3. On 09/07/08 at 12:52 am, Milwaukee police were dispatched to 1230 N Van Buren for a Theft complaint. Investigation revealed a patron was dancing inside Victors bar and when she returned to her table and found that her wallet was stolen from her purse. Officers spoke to the owner Victor Jones, who advised he did not have any video of theft. A report was filed.

4. On 12/28/09 at 12:15 am, Milwaukee police were dispatched to 1230 N Van Buren for a Battery complaint. Investigation revealed two patrons who are married became involved an argument that turned physical inside the tavern. A witness to this incident called for police and the male patron was arrested for battery domestic violence.

- 5. On 04/18/10 at 2:15 pm, Milwaukee police were dispatched to 1230 N Van Buren for a Theft complaint. Police spoke to the victim who stated on 04/18/10 at 1:30 am he was at Victor's and was punched in the face and robbed of his money while in the men's bathroom. The victim provided descriptions of the actor and spoke to a friend of his that witnessed this incident. Bouncers then escorted all parties involved out of the bar. Officers were unable to speak with employees that work at Victor's due to the bar being closed. A report was filed.
- 6. On 05/02/10 at 2:42 am, Milwaukee police were dispatched to 1230 N Van Buren for a Battery complaint. Investigation revealed that as patrons were leaving the bar, words were exchanged and a fight broke out between the two parties. Both subjects were cited for this incident.

7. On 04/11/13 at 11:30pm Milwaukee Police in conjunction with Marquette Public Safety, performed a tavern check at Victor's (1230 N. Van Buren St). The purpose of the tavern check was to locate underage drinkers. Upon entering officers observed a rush of young patrons, appearing to be underage attempting to leave out of the front and back doors. The officers requested the lights be turned up and the music off. Vic R. Jones was on the scene and cooperated with the officers. The officers allowed persons that presented their fake ID along with their real ID to leave. 57 underage persons did so. An additional 40-50 underage patrons were identified inside the tavern without any form of state ID. None of the underage patrons were accompanied by a parent or legal guardian. All of the underage patrons were advised citations would be mailed to them.

The tavern was operating with three security members, two at the front door and one roaming the tavern. Identification is required of all patrons entering the tavern and there is a working video surveillance system. The practice for identifying patrons from out of state was they had to present a second picture ID along with their state ID. The doormen were allowing student photo identification to be the second form of ID. The Marquette student ID's only display a photo and name of a student, not a date of birth.

On 04/24/13 a meeting was held between representatives of the Milwaukee Police Department, the City Attorney's office, and the owners of Victor's. Discussed was the incident from 04/11/13 where there were over 100 underage customers in their establishment. It was reported that the shuttle van from Victor's was picking up students at the freshman dorm. The owners presented a plan to address this issue and to prevent further occurrences. The shuttle bus will be used to only take people home in the future and they are providing an educational program for their employees to assist in recognizing fake IDs. 8. On 01/01/14 at 11:25am an officer was flagged down in front of Victor's at 1230 N. Van Buren St. regarding a disorderly subject. The intoxicated subject was harassing a patron and refused to leave the club. He was escorted outside by the bouncer and began fighting. He was restrained until the officer was flagged down. The subject was arrested and cited for Disorderly Conduct.

9. On 05/03/2014 a 19 year old Milwaukee police aide, working in conjunction with Milwaukee police, attempted to gain entry to Victor's (1230 North Van Buren Street) but was turned away when she could not produce proof she had attained the legal drinking age of 21.

- 10. On 05/17/2014 Milwaukee police responded to a subject making threats at Victor's (1230 North Van Buren Street). Investigation revealed a patron had been asked not return to the club after going outside for a smoke. This patron continued to attempt to re-enter the business and made threats to the doorman that he would shoot the place up if he were not allowed to re-enter. Milwaukee police incident report #141370023 filed.
- 11.On 01/16/2015 Milwaukee police conducted a tavern check at Victor's (1230 North Van Buren Street). Officers discovered two underage females inside the club that had gained entry with fake Oregon ID's. When checked by the business's identification card reader, both fake ID's came back as valid. The two females were cited.

12. On 02/16/2015 Milwaukee police conducted a tavern check at 1230 North Van Buren Avenue (Victor's) and delivered a packet of tavern related ordinances.

- 13.On 02/26/2015 a 19 year old Milwaukee police aide, working in conjunction with Milwaukee police, attempted to gain entry to Victor's (1230 North Van Buren Avenue) but was turned away when she could not produce proof she had attained the legal drinking age of 21.
- 14. On 08/07/2015 a 20 year old Milwaukee police aide, working in conjunction with Milwaukee police, attempted to gain entry to Victor's (1230 North Van Buren Avenue) but was turned away when she could not produce proof she had attained the legal drinking age of 21.
- 15.On 11/17/2015 Milwaukee police responded to a subject with a gun complaint at Victor's Tavern (1230 North Van Buren Avenue). Investigation revealed a patron, Floyd Harriell, of the business identified himself as a retired police officer and displayed a revolver under his shirt. The bartender, John T. Jones, told Harriell that guns were not welcome in the business and called police to report the incident. Milwaukee police incident report #153210009 filed.
- 16. On 11/26/2016 an officer investigated a battery complaint that occurred at Victor's, 1230 N. Van Buren St. on 11/20/2016. The victim stated he was at the tavern drinking until closing time. He stated he was battered in the parking lot by one of his friends and a security guard from Victor's. The officer located the victim's friends who witnessed the incident. They stated the victim was very intoxicated and was escorted out by security. While in the parking lot the victim saw a female exit the tavern and he pushed the female. Security intervened and pushed the victim to the ground. His friends were able to restrain him and get him into a car and drive him home. They stated he had passed out in the car on the way home. The officer determined the battery compliant was baseless.
- 17. On 03/30/2017 officers conducted underage tavern enforcement in District 1. An underage Police Aid attempted to gain entry to Victor's, 1230 N. Van Buren St. The Police Aid was denied entry at the door by security.

18.On 12/15/2017 officers were dispatched to shots fired at Victor's, 1230 N. Van Buren St. The officer interviewed Victor's security who stated there was a fight across the street and he did not believe the actors had come from the bar. He stated he observed a subject pull an item from his sock and then he heard a pop, though he didn't think it was loud enough to be a gun

shot. The officer did recover a 9mm casing from the street. Video was recovered from Victor's but due to the distance it was too fuzzy to see what actions occurred.

- 19. On 11/29/2018 officers conducted underage tavern enforcement in District 1 at Victor's, 1230 N. Van Buren St. The tavern passed the check.
- 20.On 12/09/2018 at 2:09am officers were dispatched to a battery complaint at Victor's, 1230 N. Van Buren St. Upon arrival the officer found a subject laying on the ground surrounded by people attempting to help the subject. The subject, identified as Manuel WILLIAMS, stated he had been hit to the left side of his head by an unknown subject, causing him to lose consciousness and pain to his jaw. The subject received medical treatment for a broken jaw. The officer spoke with the manager, Victor JONES, who stated he could not get into the camera system to check the video. JONES stated the suspect was a bouncer of the bar but he was only able to provide the name of the subject, Travis DOBBS. On 12/14/2018 the officer was advised the video of the incident was now available. The video showed the victim outside attempting to get inside but two bouncers were blocking his way. The victim walked off and returned taking off his jacket. Another subject arrives and tries to get WILLIAMS to leave and an argument starts between all of the subjects. A physical altercation ensues with WILLIAMS swinging at the bouncer, who then hits WILLIAMS causing him to fall to the ground. The second bouncer then appears to hit WILLIAMS. The other patrons assist WILLIAMS until MPD arrives. JONES was not able to provide the officer with any identifying information on the bouncers. The case was pended by the DA's office on 02/08/2019.
- 21. On 03/15/2019 at 1:50am officers were monitoring closing time at Victor's , 1230 N. Van Buren St. At 2:03am officers observed 34 patrons inside with drinks in their hands after closing time. The officers spoke with the applicant who stated his staff got a late start clearing the patrons out.

- 22. On 04/26/2019 at 7:30am an officer was dispatched to a battery complaint. The victim stated the was at Victor's last night and was assaulted by a bouncer. The victim stated he was sitting near the door and got into an altercation the bouncer. He was not sure what happened but knows he was kicked out and and injured himself on the ground. Hehad a bruise on his forehead. The officer went to the bar but it was closed. On 05/10/2019 the officer conducted follow up and spoke with the bouncer. He stated the victim is a regular patron and was cursing at him. Another patron got into an argument with the victim and were getting ready to fight. The bouncer got between the parties and when they did not calm down he kicked out the victim. The bouncer stated he laid the victim on the ground and noticed he was bleeding from his head. The bouncer stated Victor Jr came out to speak with the victim, but the victim cursed him out as well. The officer spoke with the applicant about the incident and the need to speak with Victor Jr but had never received a call from Victor Jr regarding this incident.
- 23. On 02/08/2020 at 2:07am officers were dispatched to Victor's Cocktail Lounge, 1230 N. Van Buren St. The victim stated she was sitting at the middle of the lounge, by the back bar, when a fight started off to her side. She stated at some point a friend put a napkin to the victims face, the victim did not feel anything and did not know why the friend was holding a napkin to her face. The victim was taken to the kitchen and treated for a cut to her lip. The officer interviewed the friend who stated an unknown male, who was involved in the fight across the bar, threw a glass and it hit the victim to the face. The victim was treated at the hospital and required 5 stitches to close the cut.

This report is being typed by P.O. Jutiki X district #1 squad 1123. On Friday, April 26, 2019 at 7:30 a.m. I was dispatched to the address of 924 E. Juneau Ave. for a complaint of a battery. Upon arriving at the location I spoke to the caller Mark Nmi KOGUTKIEWICZ W/M (12-11-62) who stated that he was at Victor's bar located at 1230 N. Van Buren Street on Thursday, April 25, 2019 around 9:30 p.m. and he was assaulted by one of the bouncers. I asked KOGUTKIEWICZ to further explain and KOGUTKIEWICZ stated that he remembers being at VICTOR'S last night around 9:30 p.m. KOGUTKIEWICZ further stated that he was sitting near the entrance of the bar and got into some kind of altercation with one of the bouncers described as being a six foot six large black guy about four hundred pounds. KOGUTKIEWICZ stated he wasn't sure of what really happened at the bar but he knew Victor junior was there. KOGUTKIEWICZ stated that he remembered Victor junior saying "Mark you reached for your jacket." KOGUTKIEWICZ further stated he told Victor Junior "game on," "I'm coming for you." KOGUTKIEWICZ stated he knew he was thrown out the bar and injured himself on the ground outside the bar. KOGUTKIEWICZ stated he walked home after the incident. I asked KOGUTKIEWICZ if he knew what exactly happened in the bar last night and KOGUTKIEWICZ stated "I pay your salary," "you figure out what happened to me last night." I finished speaking to KOGUTKIEWICZ and looked at his head and did notice a bruise on the left side of his forehead. I asked KOGUTKIEWICZ if he had been drinking last night and KOGUTKIEWICZ stated he only had two bottles of beer. I took nine photos of KOGUTKIEWICZ injury and went to Victor's bar located at 1230 N. Van Buren Street and attempted to locate any witnesses to the incident but the bar was closed. I returned to the bar later in the day around 3:00 p.m. and I was unable to locate Victor junior or the bouncer KOGUTKIEWICZ had described.

On Friday, May 10, 2019 I went to Victor's Bar to check for the black male subject KOGUTKIEWICZ had described to me. Upon arriving at Victor's Bar I observed a black male bouncer standing at the front entrance. I walked up to the bouncer and spoke to him. The bouncer identified himself as Travis M. BABBS (03-27-89). I showed BABBS a picture of KOGUTKIEWICZ and asked him if he remembered being in an altercation with KOGUTKIEWICZ a few weeks ago. BABBS stated that he did. BABBS stated that he was sitting in a chair near the front entrance and KOGUTKIEWICZ started cursing at him. BABBS stated as KOGUTKIEWICZ was cursing at him another patron overheard him yelling at BABBS and got into an argument with KOGUTKIEWICZ. BABBS stated KOGUTKIEWICZ and the other patron were about to fight and he got in between them and KOGUTKIEWICZ wouldn't calm down and stop his actions. BABBS stated

that he picked up KOGUTKIEWICZ and took him out the bar to keep him from fighting. BABBS stated he laid KOGUTKIEWICZ down on the ground outside the bar on the sidewalk in front of Victor's. BABBS stated that he noticed KOGUTKIEWICZ bleeding from the head once he laid him on the ground. BABBS stated Victor came out to speak to KOGUTKIEWICZ and KOGUTKIEWICZ cursed out Victor. BABBS stated the KOGUTKIEWICZ was a regular at the bar and was drunk that night the incident happened. I asked BABBS if Victor was at the bar right now and BABBS stated that he wasn't. I finished speaking to BABBS and left the area.

I went back to Victor's on Van Buren several times and attempted to locate Victor Jr. and was unable to locate him and speak to him regarding this incident. I contacted the registered licensee (Victor R. JONES) by phone #272-2522 and left a message for him that informed him that I would be filling a report regarding this incident. JONES later contacted me at district #1 and I informed him about the incident with KOGUTKIEWICZ at the bar. JONES stated that he didn't know anything about the incident. JONES stated that he would have Victor junior give me a call at a later time. As of May 26, 2019 I haven't received any phone calls from Victor junior regarding this incident.

### INITIAL INVESTIGATION

This report is written by Police Officer James DUERR, assigned to District One, Late Power Shift.

On Saturday, February 08, 2020 at 2:07 AM, P.O. ARREDONDO, and I (Squad 1340), while in full duty uniform equipped with an Axon body worn camera activated in a marked Squad, was dispatched to the address of 1230 N. Van Buren St, (Victor's Cocktail Lounge) which is in the City and County of Milwaukee WI, for a Battery complaint.

Upon arrival I was met by Ashleigh R. GIMENEZ (W/F 03-22-1998), who was the victim of the battery. GIMENEZ stated she arrived at Victor's at approximately 1:00 AM to have some drinks with her friends.

GIMENEZ stated that at approximately 2:00 AM, after having several drinks, she was sitting on a chair drinking some water from a glass cup in the middle of Victor's facing away from the bar that's to the rear of the lounge. GIMENEZ stated that she some-what noticed from her peripheral vision an altercation coming from some people on her left side, but did not really pay attention to them. GIMENEZ stated that the next thing she knew was that one of her friends was putting some napkins on her face and she did not know why. GIMENEZ stated that she did not feel any pain or discomfort at the time that her friend was putting napkins on her face. GIMENEZ stated that she did not know what was going on. GIMENEZ stated that her friends and some lounge staff took her to the kitchen to take care of her.

After speaking with GIMENEZ, she stated to me that she did not consent to the offense, and she would like to prosecute if the subject is arrested. GIMENEZ seemed to be under the influence of an unknown substance. GIMENEZ stated to me that she had about five alcoholic drinks before the incident took place.

I then spoke to Cailin R. DILDAY (W/F 06-04-1998) who was with GIMENEZ and also witnessed what took place. DILDAY stated that an unknown subject threw a glass cup across the bar while in an unrelated fight, and hit GIMENEZ in the face causing a laceration on the bottom left side of GIMENEZ's bottom lip, a small cut on her tongue and a cut on GIMENEZ's left hand, above her knuckles. The suspect was an unidentified male who was no longer at the scene.

DIDLAY stated to me that she went to the hospital to check on GIMENEZ, and while at the hospital, she wanted to get looked at for a small cut and a bit of swelling on her left index finger, that she also received from the broken glass. DIDLAY stated that she was admitted to the

hospital at approximately 2:50 AM, and seen by Dr. Kevin BARBER. DIDLAY stated to me that she got an x ray exam on her left index finger at approximately 4:00 AM. DIDLAY stated that her exam came back negative for any broken bones and that her left index finger was just a bit swollen.

GIMENEZ was taken to St Mary's Hospital by Bell 416.

Dr. YU gave GIMENEZ five stitches for the laceration that she got during the incident on the left side of her bottom lip.

I provided GIMENEZ with a PV17.
