Thank you for your response from Mr. Grant Langley, City Attorney, and Linda Uliss Burke, Assistant City Attorney dated February 5, 2001. The day that my car was stolen from the parking lot of Milwaukee Hamilton High School, my wife did agree to have the car towed because of the coat hanger that was found next to where my car was parked. The police and school advised her that the column of the cars steering mechanism(which is common per the police detective that I talked to on 1986 Chevrolet Caprice's) was more than likely damaged, making it easier to start and steal. No one in my family, including myself, knows how to start the vehicle without the ignition key. In fact, the gentleman at the tow lot had to show myself and son how to start the car, which was damaged beyond repair, with a screw driver. Total damages for just the steering column totaled in excess of \$225.00, total cost to repair all damages was \$570.00. I feel that if I went down to the alley on 24th and Capitol Drive where I was told the vehicle was recovered, that I would not have been able to start the car, it did not start with my keys. With the above facts, I am asking you to reconsider by reimbursement of my \$80.00 tow charge.


