Purpose of Amendment:

The purpose of this amendment is to amend the Milwaukee Police Department's (MPD) existing Vendor Services Contract for Inmate Health Care Services with Wellpath, LLC (Wellpath) by adding and immediately exercising a one (1) year option to extend from 03/01/2026 through 02/28/2027 and increasing the contract total by \$475,492.05 from \$1,275,833.78 to \$1,751,325.83, in accordance with Wellpath renewal letter dated 10/15/2025.

The operating funds being added to the contract represent the annual management fee and costs for personnel, benefits and insurance for the requested contract term extension. Vendor contract services for in-house medical assessment and patient care has reduced the number of medical runs required by the Milwaukee Police

Purpose of Amendment:

The purpose of this amendment is to continue Psychological Services for the Milwaukee Police Department (MPD) with First Responders Psychological Services, LLC (FRPS) by increasing the contract total by \$66,820.00 from \$787,780.00 to \$854,600.00. Additionally, extend the contract term for one (1) year, from 01/01/2026 through 12/31/2026, exercising the second (2nd) of four (4) options to extend.

The budget proposal provided with the original contract estimated year 2026 costs to be \$854,600.00. It is estimated that a total of 8,546 hours will be used for direct treatment services and indirect services, to include clinician prep time, post treatment documentation, meetings, etc. These hours are billed at a rate of \$100 per hour. Operating funds are used for this amendment. MPD has applied for 2026 grant funding to help cover some of the cost of this service.
