

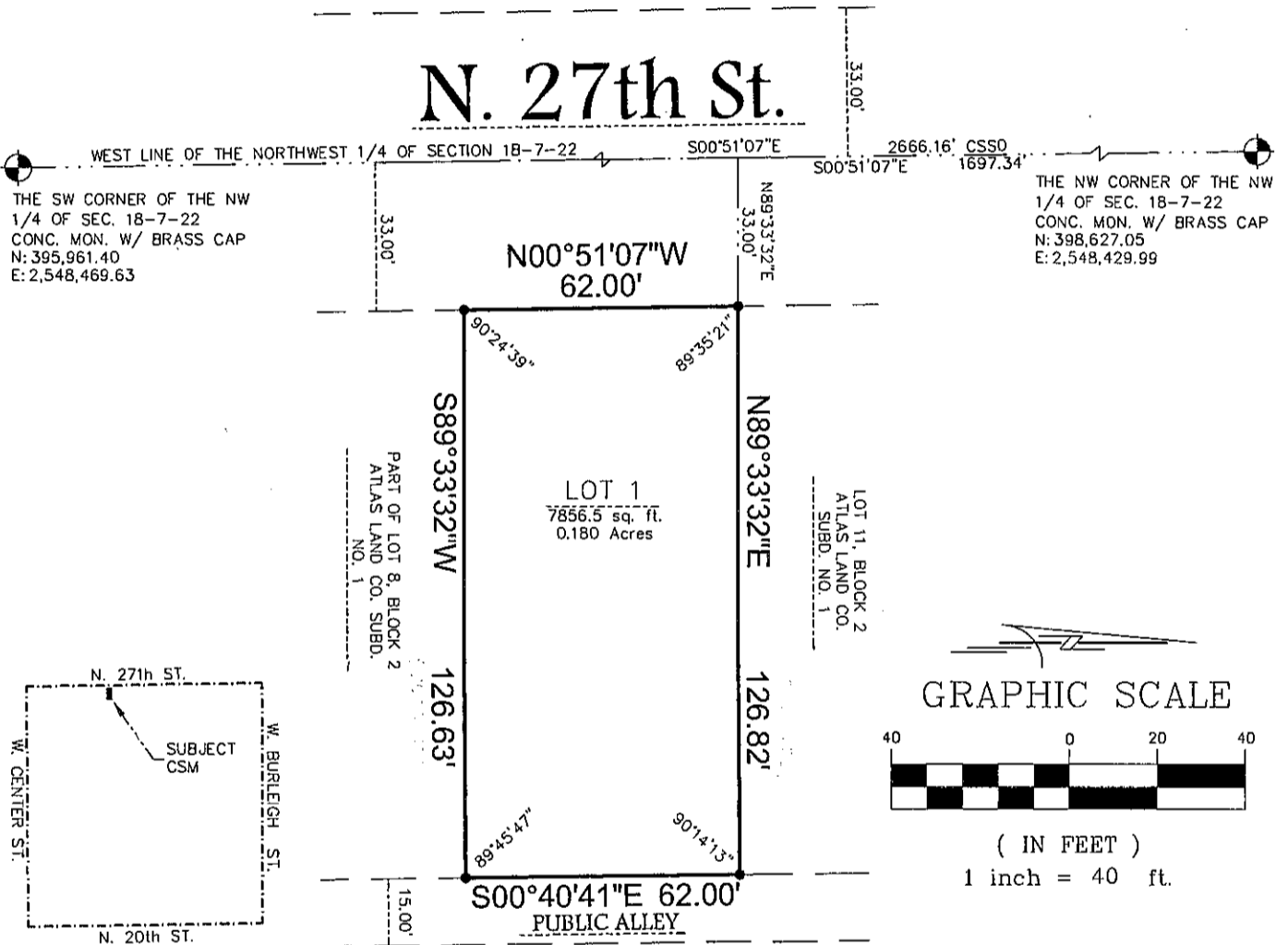

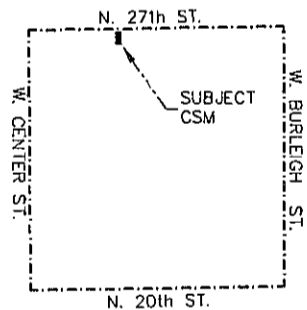

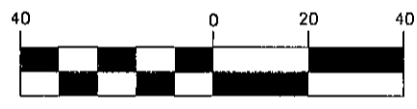

GRAPHIC SCALE



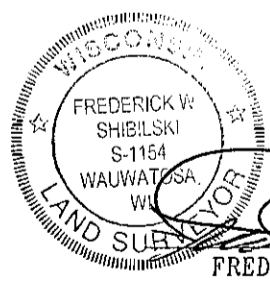

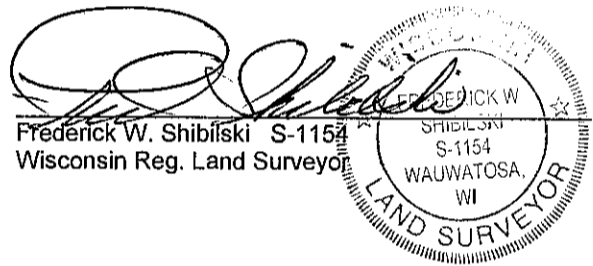
