SWORN CHARGES BY CHIEF OF POLICE FOR REVOCATION OF LICENSES

Pursuant to Wisconsin Statutes § 125.12 and Milwaukee Code of Ordinances ("MCO"), §§ 85-4, 85-27, 90-12 and 108-11, Chief of Police Jeffrey Norman, a City of Milwaukee resident and interested party, by Erin Mejia of Police District 2, an interested party, being first duly sworn and upon his oath, respectfully charges the following based upon review of official Milwaukee Police Department ("MPD") reports drafted in the ordinary course of business, review of documents received by MPD District 2 and communication with other law enforcement, municipal officials and individuals with information:

REVOCATION STANDARDS

MCO § 85-4-1.5 requires all issued licenses to be heard for revocation at the same time. MCO § 85-27 grants the discretion to revoke any MCO ch. 85 license for any improper conduct of the licensed person. MCO § 85-4-4 provides grounds for revocation and these include the following:

- Failing to meet municipal qualifications.
- Pending charges or convictions of any level and type of offense which substantially relate to the circumstances of the particular licensed or permitted activity.
- Whether the licensed premises facilitates a public or private nuisance.
- Whether the premises facilitates congregations of people that have resulted in failing to comply with the approved plan of operation or has otherwise demonstrated any factor

which reasonably relates to the public health, safety and welfare.

Revocation of public entertainment premises follows the same MCO § 85-4-4 factors pursuant to MCO § 108-11-3.

MCO ch. 90 contains many similar factors, but also additional and different grounds for revocation. MCO § 90-2 adopts Wis. ch. 125. MCO § 90-12-3 also adopts state law revocation provisions. Grounds for revoking an alcohol license include:

- The licensee corporation does not have a natural person as an agent who meets the professional character requirements of MCO § 90-6-1-a.
- The licensed premises is operated in a such a manner that it constitutes a public or private nuisance.
- The licensed premises is operated in such a manner that it has a substantial adverse effect upon the health, safety or convenience and prosperity of the immediate neighborhood.
- Failure of the licensee to operate the premise in accordance with the plan of operation.
- Any other reasonable cause which shall be in the best interests and good order of the city.

MCO § 90-12-1.

LOCATION AND APPLICATION HISTORY

1. Cantaritos Bar, LLC, (d/b/a Passion Nightclub) was issued licenses on January 21, 2025 and the licensee agent is listed as Francisco Gomez-Ortiz.

FACTUAL BACKGROUND

2. The above-recited paragraphs and exhibits are realleged in this section and are incorporated by reference.

3. On July 31, 2025, numerous law enforcement personnel searched 1566 S. Muskego Ave.

4. The business was open with one customer inside the location.

5. Francisco Gomez-Ortiz was located in the rear of the location and was taken into custody as part of the search warrant. He stated he was the boss of the location for approximately

15 years.

6. 1566 S. Muskego Ave. is a night club and bar attached with an underground basement. The building has five upstairs apartments that were not searched. The building had a previously unknown unit on the first floor in the northeast corner of the building. A closet in that unit contained a ladder that went through the floorboard into the basement.

7. A utility room existed on the eastern exit of the dancefloor/DJ booth. The utility room contained body armor rifle plating and 0.89 grams of cocaine.

8. The utility room has a northeastern exit into another hallway and that hallway has a northern door which leads to the newly discovered apartment unit described above.

9. That apartment unit also contained a kitchen. Numerous relevant items were recovered:

- a) U.S. currency along the countertop.
- b) .22 caliber black revolver above the microwave.
- c) .45 caliber semi-automatic handgun above the microwave.
- d) Cocaine underneath the stove hood. There were 106 single packages/bundles that contained 58.43 grams.
- e) A female statute that contained 0.52 grams of cocaine inside.
- f) Shotgun ammunition by the sink.

10. That apartment unit also contained a bedroom. Numerous relevant items were recovered:

- a) 12-gauge shotgun behind the bedroom door.
- b) U.S. currency throughout the bedroom on a plastic container, on a table, in a black safe, on the dresser and near the dresser.
- c) Chase bank deposit account balance summary requestor Cantarito's along the

south wall.

d) 0.69 grams of cocaine on the table under a laptop.

11. The total amount of cocaine recovered, as alleged in the paragraphs above, was 60.53 grams of cocaine in 107 packages.

12. The total amount of money recovered, as alleged in the paragraphs above, exceeded \$200,000.00.

13. The presence of firearms, the amount of cocaine recovered and the manner in which it was packaged is consistent with cocaine possessed for further distribution.

14. Francisco Gomez-Ortiz was charged in Milwaukee County Case No. 25CF3610 and a certified copy of the criminal complaint, information and court record of events are attached as Exhibit A and incorporated by reference.

15. Francisco Gomez-Ortiz was bound over after a preliminary hearing on August 15, 2025. (Ex. A).

RELIEF REQUESTED

WHEREFORE, a license may be revoked for failing to comply with the approved plan of operation and any factor reasonably related to the public health, safety and welfare.

BASED UPON all the allegations alleged above including the failure to follow Wisconsin state statutes and City of Milwaukee ordinances, the licenses granted at this location must be revoked.

THE CHIEF OF POLICE, by his designee, respectfully requests the immediate revocation of all licenses relative to the above-referenced licensee and licensed premises.

THE BELOW NAMED COMPLAINANT BEING DULY SWORN, ON INFORMATION AND BELIEF STATES THAT:

Count 1: POSSESSION WITH INTENT TO DELIVER CONTROLLED SUBSTANCE (COCAINE) (>40 GRAMS) - PTAC, AS A PARTY TO A CRIME, USE OF A DANGEROUS WEAPON

The above-named defendant on or about Thursday, July 31, 2025, at 1566 South Muskego Avenue, in the City of Milwaukee, Milwaukee County, Wisconsin, as a party to a crime, did knowingly possess with intent to deliver cocaine, a controlled substance, in an amount more than 40 grams, contrary to sec. 961.41(1m)(cm)4, 939.50(3)(c), 939.05, 939.63(1)(b) Wis. Stats.

Upon conviction for this offense, a Class C Felony, the defendant may be fined not more than One Hundred Thousand Dollars (\$100,000), or imprisoned not more than forty (40) years, or both.

And further, invoking the provisions of sec. 939.63(1)(b) Wis. Stats., because the defendant committed this offense while possessing a dangerous weapon, the maximum term of imprisonment for the felony may be increased by not more than 5 years.

And the Court may suspend the defendant's operating privileges for not less than six (6) months nor more than five (5) years. If the defendant's driving privileges are already suspended, any suspension imposed must be served consecutively.

Count 2: MAINTAINING A DRUG TRAFFICKING PLACE - PTAC, AS A PARTY TO A CRIME, USE OF A DANGEROUS WEAPON

The above-named defendant on or about Thursday, July 31, 2025, at 1566 South Muskego Avenue, in the City of Milwaukee, Milwaukee County, Wisconsin, as a party to a crime, did knowingly keep or maintain a building which is used for delivering controlled substances in violation of chapter 961 Wis. Stats., contrary to sec. 961.42(1), 939.50(3)(i), 939.05, 939.63(1)(c) Wis. Stats.

Upon conviction for this offense, a Class I Felony, the defendant may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than three (3) years and six (6) months, or both.

And further, invoking the provisions of sec. 939.63(1)(c) Wis. Stats., because the defendant committed this offense while possessing a dangerous weapon, the maximum term of imprisonment for the underlying crime may be increased by not more than four (4) years.



And the Court may suspend the defendant's operating privileges for not less than six (6) months nor more than five (5) years. If the defendant's driving privileges are already suspended, any suspension imposed must be served consecutively.

PROBABLE CAUSE

Complainant is a law enforcement officer employed by the Milwaukee Police, and bases this complaint on official reports prepared by fellow Milwaukee Police Officers, which are of the kind that complainant has used in the past and found to be accurate and reliable and which complainant knows are prepared in the regular course of that department's business.

Those reports reveal that on Thursday, July 31st, 2025, at approximately 2:50 PM, Milwaukee Police and Federal agents executed a knock search warrant at Cantarito's Bar, 1566 5. Muskego Ave., City and County of Milwaukee, Wisconsin regarding a drug investigation with the defendant one of the targets. Upon entry to the bar, several patrons were located inside. In addition, the defendant, who is the bar owner, was located inside and taken into custody. *During a search of the bar*, officers located a previously unknown unit on the first floor in the northeast corner of the building that has a door that exits to the hallway of the establishment and a ladder that is posted through the floorboard of a closet in the apartment which leads into the basement. A second search warrant was obtained for this area.

During the search of the bar the following items were located:

Utility Room

- "BAM" body armor rifle plating with carrier by Agent Scott Marlow
- White Powdery substance suspected to be cocaine located on safe by Agent Scott Marlow

Eastern Apartment Unit

Kitchen of Unit:

- US Currency (countertop and south wall) collected by Inv. Donald Krenzien
- .22 black Heritage Rough Rider Revolver Pistol above microwave by Inv. Krenzien
- .45 Caliber Semi-automatic Springfield Armory XDM above microwave by Inv. Krenzien
- Shotgun ammo kitchen south wall by sink by Inv. Krenzien
- Bindles of white powdery substance suspected to be cocaine underneath stove hood by Inv. Krenzien
- Inside a female statute more white powdery substance by Agent Tyler Fink
- Green memo book "Gustavo" ledger located in top drawer by kitchen sink by Marlin Schilcher

Bedroom of Unit:

- 12 GA Remington Shotgun (Black w/ wooden stock) behind bedroom door by Agent Marlow
- US Currency on table near south wall by Agent Marlow
- North wall, black safe with more US Currency by Det. Gregory
- Southwall on table under laptop white powdery substance by Agent Marlow
- Identifier's south wall, Chase Bank Deposit Account Balance Summary Requester Cantarito's by Agent Marlow
- US currency on north wall plastic container by Det. Gregory
- US currency south wall near dresser by Agent Marlow

- US Currency south wall near dresser by Agent Marlow
- US currency south wall dresser by Agent Marlow
- Defendant's Mexico Passport located on bedroom dresser by Officer Becker
- Several identifiers for the defendant including mail.

Officer Hernandez and Sgt. Marlin Schilcher Jr. subjected a small sample of the white powdery substances collected to a MobileDetect test which revealed the positive presence for cocaine. The cocaine yielded a total weight of 60.53g through 107 separate bindles of cocaine located. The total amount of cash located was over \$200,000. Based on the investigation, the packaging, amount of drugs, firearms and significant cash, officers believed the recovered drugs were consistent with street level sales.

This report is written by Police Officer Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 12/08/11 at 5:42 pm, Milwaukee police were dispatched to 1566 S Muskego Avenue for a Battery complaint. Officers spoke to the owner of the tavern who was the victim, Francisco Gomez-Ortiz who stated he was walking outside of his tavern and was approached by four unknown subjects. These subjects stated "Fuck You Mexican" and Gomez-Ortiz responded, "What are you talking about?". Gomez-Ortiz stated he feared for his safety and turned to knock on the bar window to get the attention of people inside the bar when one of the subjects hit Gomez-Ortiz on his right shoulder and back. Gomez-Ortiz was able to get inside the bar and was able to detain the subject who hit him until police arrived.
2. On 03/04/12 at 8:11 pm, Milwaukee police were dispatched to 1566 S Muskego for a Battery complaint. Upon police arrival, officers were advised that all parties involved had left, however one subject was pointed out walking northbound down Muskego. Officers caught up with the subject and observed the male to have a swollen eye and small cut above his right eye. The subject was intoxicated and refused medical attention. The subject stated to police that an unknown male hit him for no reason. The subject was uncooperative with police and did not want to press charges. Officers returned to the bar and spoke with the bar owner, Francisco Gomez-Ortiz who stated two patrons were arguing and he asked them to leave. Gomez-Ortiz further stated both parties stepped outside and that neither returned.

3. On 03/24/13 at 12:05 am, Milwaukee police were dispatched to 1566 S Muskego Avenue for a Property Damage complaint. Police spoke with Francisco Gomez-Ortiz who stated at approximately 11:45 pm, his security escorted a patron out of the bar due to his intoxication/disruptive behavior. A few minutes later, witnesses observed that same patron throw a brick through several vehicles that were parked in front of the bar. Security went outside and restrained the subject until police arrived. The subject was cited.
4. On 05/06/13 at 1:00 am, Milwaukee police investigated a Battery that occurred outside of the El Cantarito Bar. Investigation revealed a patron of the bar sustained a cut to his head due to a fight that took place outside of the bar. On 10/06/2014, at 8:22pm, Milwaukee police were dispatched to 1566 South Muskego Avenue to determine if the business was the scene of a battery/cutting that was being investigated at St. Luke's hospital. The bartender who started her shift at 4pm, stated during her shift an altercation occurred at the business between several men. During the altercation one individual was struck with a bottle. She was able to break up the fight and the individuals left the bar. Milwaukee police incident report #142790169 filed.
9. On 11/01/2014 Milwaukee police were dispatched to a subject with a weapon complaint at 1566 West Muskego Avenue. Investigation revealed a security guard was struck in the back of the head with a glass bottle, resulting in an injury that required stitches. Milwaukee police incident report #143050149 filed.

On Saturday, May 17, 2025, at about 8:30am, squad 2120 was dispatched to Cantaritos Bar, located at 1566 S Muskego Av. Upon arrival we observed a male subject lying on the ground with a bloody face. The subject, identified as Kelvin J ORTIZ-SANTIAGO (w/m, 10-11-05) stated that he was walking to his girlfriend's house when he observed the security guard of Cantaritos, kicking two Hispanic males out of the premise. Kelvin stated that his uncle works at the location and wanted to help the security guard because the two subjects were being uncooperative and aggressive with the security guard.

Kelvin stated that he walked across the street and approached the subjects. He stated that the subjects started to leave and walk away, and he then started to walk away as well. Kelvin then stated that he then got sucker punched by suspect #1, who was wearing a white shirt. Kelvin stated that he didn't get a good look at the suspects, but he described them as hispanic males in their mid-20's. He stated that as soon as he got sucker punched he fell to the ground and the suspect's began striking him. While speaking with Kelvin I observed that he was visibly confused and might have suffered a concussion. Kelvin stated that he has never seen the suspects before

Bell 456 responded and treated Kelvin, who refused medical treatment to go to the hospital. We then conveyed Kelvin to his mother's house at 823 S 10th St. PO VODICKA spoke with the bartender, Ceslo LOPEZ-SANCHEZ (w/m, 4-7-77), who was able to show VODICKA the video. The surveillance video shows Kelvin approaching the 2 suspects on the sidewalk, and raises his fists first to start fighting. It then shows Kelvin throw the first punch at which point the 2 suspects begin fighting back against Kelvin. After Kelvin went down to the ground the 2 suspects ran to a black Toyota and fled south.

- A test fire of one of the handguns revealed it to be used in a 2023 "Shotspotter" incident where six (6) rounds were fired in the 1500 block of S 21st St at 12:47pm with apparently nothing struck.
- A total of one hundred and seven (107) bindles of cocaine, totaling 60.54 grams, in the kitchen and other areas of the apartment.
- A ledger with suspect drug transactions in the kitchen of the apartment
- 15.2 grams of marijuana in the kitchen of the apartment.
- Packaging materials in the apartment
- A large sum of U.S. Currency in various denominations throughout the apartment that was seized by D.E.A. agents
- Identifiers (IDs, passport, mail, prescription pill bottles) for the owner of the premises, GOMEZ-ORTIZ.
