This is in response to a request we received from Divine Savior Holy Angles High School to install the above-captioned parking restriction.

Our traffic engineering staff has investigated this request and found that motorists exiting their northern most driveway from their property have a difficult time seeing traffic traveling northbound on North 100th Street when vehicles park close to their driveway. Therefore, in the interest of public safety, we recommend installing this parking restriction to increase visibility at the driveway.

We will prepare the necessary legislation for the next Public Safety Committee meeting, so that you may support it to final passage.
