*was nominated by Alderwoman Andrea M. Pratt for her lifetime of distinguished achievements and service to represent the women of Milwaukee as a 2026 Women's History Month Honoree; and*

**WHEREAS,** *Women's History Month honorees are exemplary figures in the Milwaukee community who demonstrate outstanding contributions in civic, professional, and humanitarian pursuits; and*

**WHEREAS,** *Arlisia E. McHenry graduated from the University of Wisconsin-Milwaukee with a bachelor's degree in education, a catalyst for her first professional role as a Deputy Project Director with Lockheed Martin, working closely with local municipalities across Wisconsin, and extensive career as valuable leader and collaborator within the City Clerk's office; and*

**WHEREAS,** *Arlisia E. McHenry has held several roles within the office of the Common Council, joining as a Legislative Assistant in 2001 and working her way up to the president's Legislative Assistant and Campaign Aid for 13 years, Chief of Staff in 2016, and Executive Assistant to the president in 2020 as well as serving as Mayor Johnson's Liaison Officer to the Common Council in 2021; and*

**WHEREAS,** *Arlisia E. McHenry's defining role was serving as the first Community Outreach Liaison from 2018 to 2021 where she worked with all 15 members of the Common Council assisting and providing leadership, project management, and supportive activities for various community outreach engagement programs and initiatives; now, therefore, be it*
