Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

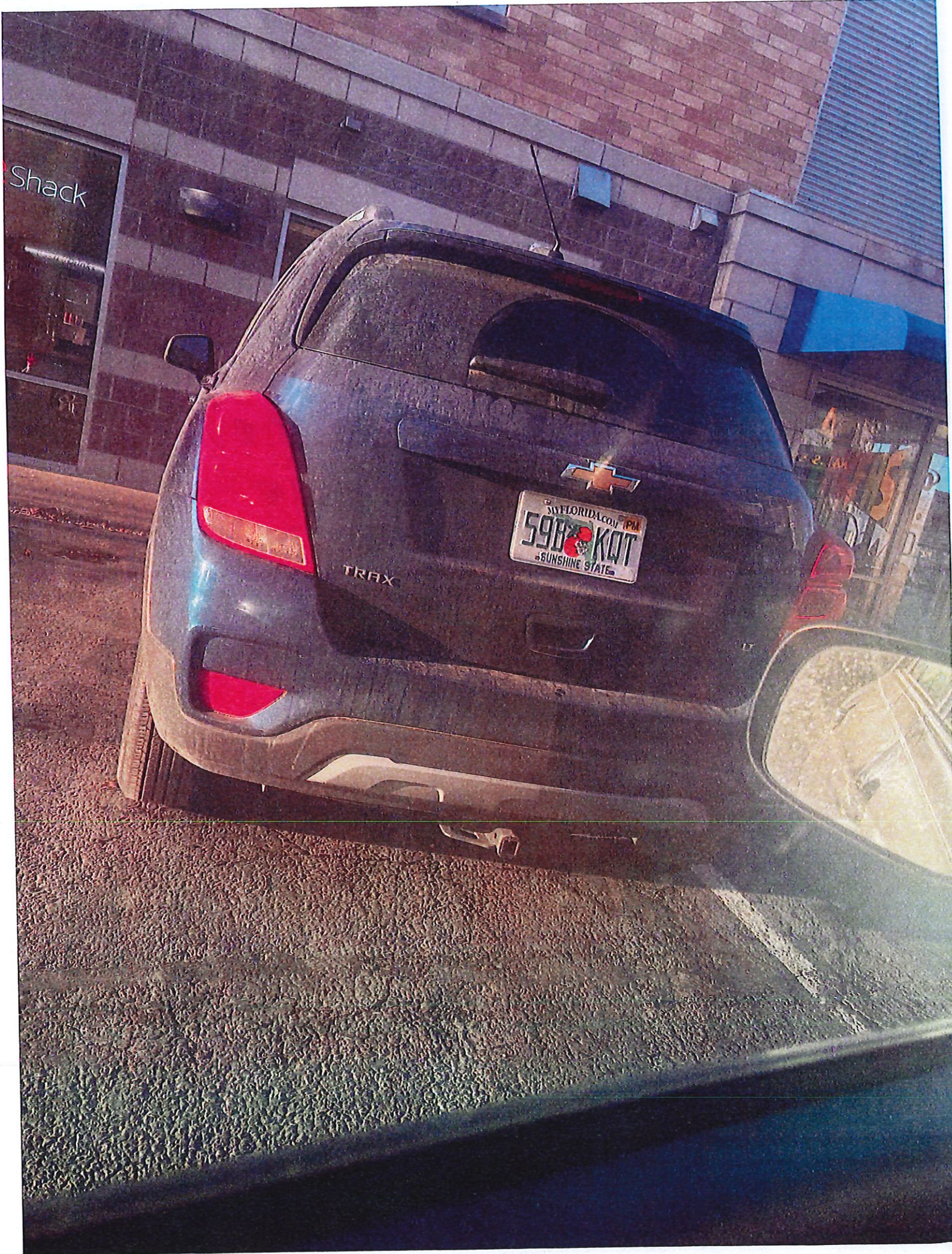

I was there for the first time, but my daughter had been there with her father previously. When we entered in, no one greeted us which is fine. I happen to notice out on the counter in front of everyone was some ground beef that was exposed completely so I asked about it because I wanted to know what was going into my food.

I did take a picture of it because I was a little shocked by it especially because this place had a A rating. I asked about it and they removed it after some arguing the back. I then asked they can take my order and then I was informed that they wouldn't take my order until the owner arrived because I had said something about the meat.

At that point, my camera is on and I had them confirm that that was in fact the case, that they would not serve me. I said thank you very much and I will be making a formal complaint. As I was in my car and gathering myself, the owner showed up and told me to never come to his restaurant again after the staff told him I had footage. I do want to have mediated conversation with this man if you can help that.

This business does not represent our city and I'm shocked by their treatment and the health hazards they protect. Looking forward to solving this with you.

The photo with the license plate so you can see this is the owner's car what showed up while I was in my car. I have another video of them not taking my order but is too large so I'll try to link another way.

On Thursday, 11-16-23, at 4:28 PM I responded to Patty Shack, 2121 S Kinnickinnic Ave for a Threat complaint.

Upon my arrival I observed the business was open, well lit, and had approximately 4-6 customers inside.

I spoke to Desmond D. JIMERSON, who is the owner and licensee for the restaurant. JIMERSON stated that his wife, Kaylynn N. ARNOLD, had called but was no longer on-scene. JIMERSON advised that his restaurant has been open since 10-1823. He stated an employee that was hired on 10-11-23 and quit on 11-9-23 has been texting him and his wife throughout the day because he believed the restaurant owed him more money than what was on his check and saying he wants to fight.

JIMERSON stated that at approximately 3:55 PM the former employee entered the restaurant yelling in a loud and profane manner, creating a disturbance in front of several customers. JIMERSON stated the subject attempted to walk behind the counter but he stood in front of him. He stated he asked the former employee to leave but he refused and continued to yell. He stated the employee was spitting while he was yelling but believes it was just because he was very animated and did not believe it was intentional. He stated that when the former employee exited, his wife observed him intentionally spit on the window. JIMERSON was cooperative throughout the investigation. He desired for the former employee to be cited for Disorderly Conduct.

I spoke to Kaylynn N. ARNOLD by phone. ARNOLD confirmed the former employee had been sending text messages all day and then entered their restaurant yelling and swearing loudly. She stated he spit in her face and spit on the window when he left; she stated she believed it was intentional.

The location is equipped with surveillance cameras. JIMERSON stated that the cameras only have a live feed and do not record.

While on scene, I observed the location had a Food Dealer license posted in a public area; the license was up to date and expires 10-15-24. and they were up to date. During my investigation for the threat complaint, I did not observe any licensed premise violations. There were no citations issued to the business or business owners. A Disorderly Conduct citation was mailed to the former employee.

The hearing before the Licenses Committee will take place on 3/6/2025 at 9:40 AM in Room 301-B, Third Floor, City Hall. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at <http://city.milwaukee.gov/citychannel>. Those wishing to provide oral testimony via internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.


