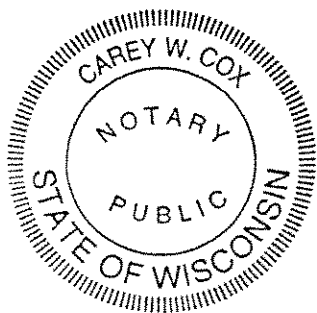

Leonhardt, City Clerk of the City of Milwaukee, certify that pursuant to Section 4-06-3 of the Milwaukee City Charter, notice is given of the passage of the following ordinances by the Common Council of the City of Milwaukee on 01/18/2006, with the approval of Mayor Tom Barrett. 050292. A substitute ordinance relating to public passenger vehicle driver's license testing.

050351. Substitute ordinance relating to the Second Amendment to a Detailed Planned Development (DPD) known as Risen Savior Evangelical Lutheran Church, on land located on the North Side of West Brown Deer Road and West of North 95th Street, in the 9th Aldermanic District.

050702. Substitute ordinance relating to the change in zoning from Downtown-Mixed Activity (C9G) and Downtown-Warehousing and Light Manufacturing (C9H) to Industrial Mixed (IM) and Industrial Light (IL2) for portions of the East end of the Menomonee Valley, generally South of the Menomonee River and East of the North-South Freeway (I-94), in the 12th Aldermanic District.

050703. Substitute ordinance relating to the change in zoning from Downtown-Residential and Specialty Use (C9B(a)) and Downtown-Ware-

housing and Light Manufacturing (C9H) to Redevelopment District (RED) for the Park East Redevelopment Area, being the former Park East freeway corridor in the Northern section of Downtown, in the 3rd, 4th and 6th Aldermanic Districts.

050704. Substitute ordinance relating to the change in zoning from Downtown-Residential and Specialty Use (C9B(a)) to Redevelopment District (RED) for the Beerline "B" Redevelopment Area generally located on the East and West Sides of North Commerce Street and North of the Milwaukee River, in the 6th Aldermanic District.

050705. Substitute ordinance relating to the change in zoning from Downtown-Mixed Activity (C9G) to Redevelopment District (RED) on land located generally South of the Menomonee River and on the East and West Sides of South 6th Street, in the 12th Aldermanic District.

051006. Substitute ordinance to further amend the 2006 rates of pay of offices and positions in the City Service under control of the Common Council.

051009. A substitute ordinance relating to parking controls in various Aldermanic Districts.

051010. A substitute ordinance relating to traffic controls in various Aldermanic Districts.

051158. Substitute ordinance to further amend the 2006 offices and positions in the City Service under control of the Common Council.

051174. A substitute charter ordinance relating to automatic rollover of certain retirement benefits as required by the Internal Revenue Code.

051188. An ordinance relating to standardization of language and minor revisions to various city boards, commissions and committees.
