Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. This report is written by Police Officer Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 05/25/2019 at 2:05am officers conducted a licensed premise check at Woody's Bar, 1579 S 2nd St. The officers observed 10 patrons at the bar with open beer bottles. The bartender then advised the patrons it was closing time. The bartender presented his license and stated he does not normally work on Thursday nights and lost track of the time. The bartender was cooperative and no other violations were observed.
- 2. On 05/25/2019 at 10:47pm officers were dispatched to a battery at Woody's, 1579 S 2nd St. The victim stated he was battered by patrons of Woody's bar outside on the sidewalk. The applicant stated he did not have a camera in the location the incident occurred but assisted the officers in viewing the available video. The video contradicted the victim, who then stated it was a passerby that struck him.
- 3. On 06/20/2019 a meeting was held at District 2 regarding the after-hours incident at Woody's on 05/25/2019. The applicant was advised to start closing the business 30 minutes early to allow time for the patrons to leave. He was also advised how to amend his hours of operation. The applicant advised that he was going to upgrade the camera system and exterior lighting.

- 4. On 12/01/23 at 1:23a.m., Milwaukee Police were dispatched to a Fight at 1579 S. 2nd St. Investigation revealed two intoxicated patrons were escorted out and were trying to regain entry. There was no fight and the business was cooperative.
- 5. On 01/19/24 at 11:00p.m., Milwaukee Police were dispatched to a Trouble with Subject at 1579 S, 2nd St. The caller stated people are often observed smoking and drinking outside of the business. On arrival officers did not find any violations and the business was cooperative.
- 6. On 03/08/24 at 12:50a.m., Milwaukee Police were dispatched to a Battery-DV at 1579 S. 2nd St. The officers were met by the caller who stated a physical altercation occurred outside of the bar. The officers stated two patrons were arguing upon entrance, however, left and no physical altercation occurred. The business was cooperative.

On Friday December 1st, 2023, at 1:23 A.M. I was dispatched to 1579 S 2nd Street, in the City and County of Milwaukee for a FIGHT.

Upon *my/our arrival* I observed multiple male subjects outside the listed business preventing two black male subjects from reentering the premise. I observed no fight or physical confrontation. According to patrons at the bar, two subject entered the location because problematic and were asked to leave by security. When the subjects refused, the patrons escorted the subjects out.

I spoke to the caller, Busby SANDERS (214-679-2942). They stated that the individual was intoxicated and was being confrontational and was asked to leave the premise.

The Listed Business was cooperative and had 0 security guards on site.

While on scene, I observed the licenses posted and they were up to date. During my investigation for the reported FIGHT I did not observe any violations in the licensed premise.

No violations observed, no citations issued.

This report is written by P.O. Kevin FREY, assigned to District Two, Late Shift, Squad 2340 with P.O. Victor HERNANDEZ. While on duty, I was operating a marked Milwaukee Police Department squad (242) and in full duty uniform equipped with Axon body worn cameras.

On Friday, January 19th, 2024 I was dispatched to address of 1579 S 2nd St (Woodys Milwaukee), which is located in the City and the County of Milwaukee, for a trouble with subject investigation.

Upon my/our arrival i observed no person to be standing outside of the tavern and there was a thin layer of fresh snowfall on the ground. I did not hear any loud music or persons as well.

I spoke to the caller by phone who identified himself as Joseph A. KUMROW (M/U 1-30-1983). KUMROW stated when he gets off of work there are often people outside of the bar and they will be smoking and drinking outside of the tavern. KUMROW stated a subject he knows as "Hector" made a comment to him that he did not like. I advised KUMROW since he lives next to a tavern there would be more foot traffic and there will be people outside smoking since it is illegal to smoke inside of an establishment.

I spoke to the bartender, identified as Roman E. KUZNETSOV (M/W 9-13-1980) who stated there was "drama" with the neighbor. KUZNETSOV had a valid Class D Operator's License # BART-21-00661 Exp. 12-31-2024.

I spoke to licensed premise owner, identified as Alan F KETTERING (M/W 9-19-1958). KETTERING stated he has owned the tavern for approximately five years and has not had any issues since he has owned it. KETTERING stated he does not have any issues with the neighbor but sometimes the neighbor dates "questionable" people. The business was cooperative with the investigation. KETTERING was able to provide me with the license info, which was posted on the southwall of the tavern.

I did not review video surveillance footage since there was no actual crime committed.

While on scene, I observed the licenses posted and they were up to date. During my trouble with subject investigation, I did not observe any violations in the licensed premise. KETTERING pulled the license board down from where the were posted and had a Class B Tavern License # BTAVN 0211689 Exp. on 10-13-2024 and a Food Dealer -Restaurant # FREST 0019835 Exp. on 10-13-2024.

The hearing before the Licenses Committee will take place on 9/10/2024 at 9:30 AM in Room 301-B, Third Floor, City Hall. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel — Channel 25 on Spectrum Cable — or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony via internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
