2010 Proposed Changes

- Parking Citation Electronic Case Transfer cost transferred to Parking Fund (-\$10,000)
- Reduce Court Commissioner hours (-\$11,057)
- Eliminate temporary help (-\$3,000)
- Eliminate out of state conferences (-\$2,000)
- Reduce substitute judge days (-\$1,980)
- Furlough days and no step increases (-\$41,000)

Policy & Service Issues

- Case files increasing
 - 2009 cases 12% higher than 2008 and 22% higher than 2007
- Revenue not increasing proportionately
 - 2009 revenue 13% lower than 2008 and 20% lower than 2007
- Implementation of electronic case files

Drivers License Recovery & Employability Project

- Fourth year of City funding
- SPA funded at \$75,000 in 2007, 2008 and 2009
- 2010 funding proposal:
 - \$100,000 CDBG funding allocation
 - \$50,000 CDBG reprogramming
 - \$50,000 SPA funding
- City funding 17% of projected 2010 budget
- Other funding 83% of projected 2010 budget

Drivers License Recovery & Employability Project

- Assists in restoring suspended & revoked licenses to remove a barrier to employment
- Initial employment outcomes positive
 - Women obtaining driving privileges experienced wage gains of \$759 per quarter, a 62% increase
 - Men obtaining driving privileges experienced wage gains of \$106 per quarter, a 24% increase
 - Men experienced decreased unemployment
 - Men experienced increase in percentage earning at least full time wages double the minimum wage

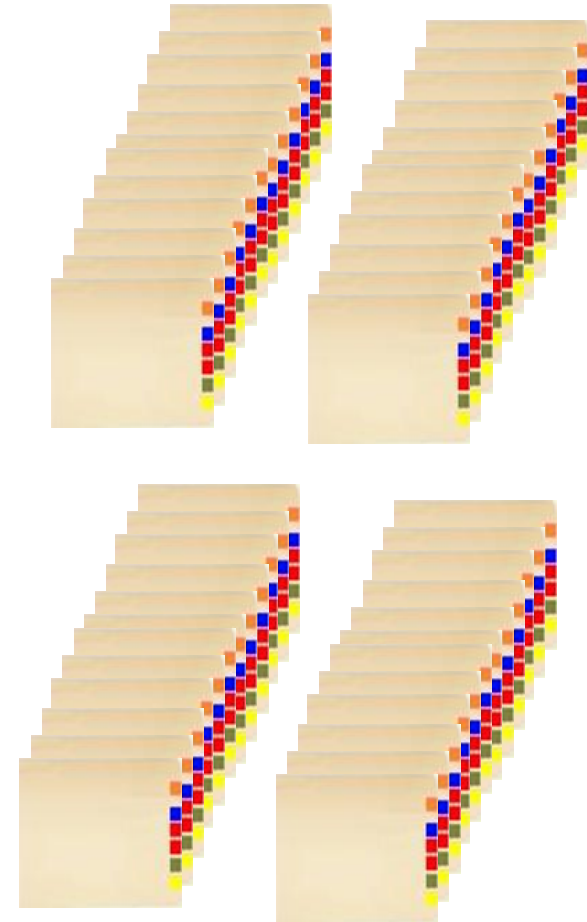

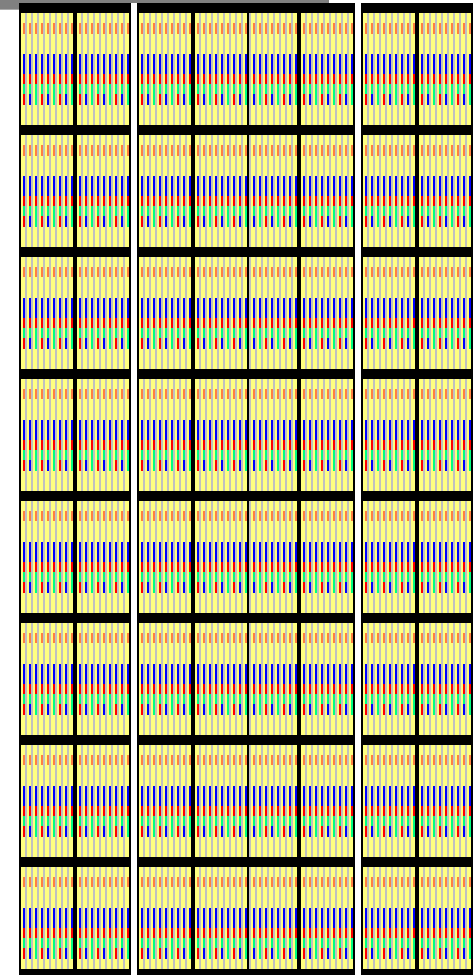
