Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. See attached police report or correspondence.

## Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

#### PA-33E Narrative

This report is written by P.O. Denise Rueda assigned to the License Investigation Unit. On Saturday, September 23, 2017, I was assigned to work the Wisconsin WINS Youth Tobacco Initiative, checking area vendors for age compliance tobacco purchases. Assisting in this assignment was Amunique McGee, (B/F, 10/06/99, of 1921 N 28th Street). McGee is 17 years of age which is not of legal age to purchase tobacco.

At approximately 10:23am, McGee entered Loves Supermarket II at 2305 W Atkinson Av and purchased 1-2pk of White Owl Grape cigars. McGee stated the cashier described as a Middle Eastern male in his 20's, with black hair, wearing a black/grat T-shirt did ask for her ID and after he looked at it sold the White Owl cigars to her anyway. I entered the store and immediately identified the cashier based on the description given. The cashier identified himself as Amardeep SINGH, (A/M, 06/10/94). SINGH did admit to selling MCGEE White Owl cigars. SINGH stated that he looked at her (McGee) ID but made a mistake on the date and thought she was 18 yrs of age. SINGH was advised that I would be sending out a letter to enroll in the M.A.R.T.S. program.

Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing. Please review the information below and if you have further questions regarding this process, please contact the License Division at (414) 286-2238.

# Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.

2. On 11/12/2016 Milwaukee police were dispatched to a fight/subject with a gun complaint at 634 West North Avenue. Investigation revealed there had been a fight inside the bar and all the involved parties were pushed outside. A gunfight ensued, during which several rounds were fired into the air and two subjects chased each other while firing weapons. One round struck a vehicle. The armed security guard told officers that "shooting in the air and at people was not a danger towards anyone" so he didn't take action during the gun battle. Milwaukee police incident report # 163170011 filed.

- 3. On 09/29/2017 at 2:35am officers observed cars parked in the bus zone in front of 634 W. North Av. The officer began issuing parking citations and the owners began moving their cars. The officers attempted to speak with owner of the tavern at 634 W. North Av but as they approached they heard the door being locked. The officer looked in the window and observed several people hide behind the bar. On 10/05/2017 the officers spoke with Terence SMITH, the bar manager. He stated he was aware of the incident. He was advised they could not lock the bar in an attempt to keep officer out. The officers checked the posted licenses which stated their closing hours were 1:30am Monday through Saturday.
- 4. On 10/13/17 at 6:15pm officers responded to Levels on North Bar (634 W North Ave) regarding a complaint that the establishment was open even though their license was expired. Upon arrival officers observed the open sing on and people inside the establishment with drink in their hands. Officers spoke with a bouncer and advised him that the bar was no supposed to be open. The bouncer called the owner by phone and explained the situation. The owner stated he didn't know the license was expired and stated he would comply and close the business.
- 5. On 10/17/17 at midnight officers conducted follow up regarding Levels on North Bar being open for business when their license was expired. An officer drove past the business and found it to be closed. The officer received an email from Terence Smith, the manager, asking why they could not be open. The officer responded by email explaining the Class B Tavern license was expired and the application for a provisional license was denied. Smith responded to the email stating he would comply and that they would be doing some remodeling until the license was renewed.

6. On 03/17/18 at 3:15 am, Milwaukee Police were investigating a shooting at N. 6<sup>th</sup> Street and W. North Avenue when an officer observed blood and multiple bullet casings on the stairs outside 634 W. North Avenue (Level's on North). An officer entered the tavern and made contact with a subject, who identified himself as the manager, and asked him if he knew anything about the shooting. The manager stated that he did hear 2 gunshots, went outside, but did not observe anything. While the officer was interviewing the manager, the door of the woman's restroom opened and a male and female exited and was told to wait for detectives. The officer did observe blood inside the threshold of the door to the tavern which caused the officer to look around the establishment for more signs of blood. While doing this the manager became defensive and agitated, questioning the officer as to what he was doing. The manager told the officer who the owner of the business was and asked the officer to contact the owner because he was "just the manager". While waiting for detectives, the officer observed and heard the bar manager urinating in the sink behind the bar area. When detectives arrived, the bar manager became extremely uncooperative with them and kept repeating himself when asked questions. The agent was issued a citation.

7. On 03/20/18 at 10:30 pm, Milwaukee Police conducted follow-up regarding a shooting which occurred outside of 634 W. North Avenue (Level's on North) on 03/17/18. Employees of the tavern lied to officers about the events surrounding the incident and only told the truth when officers confronted them with the fact that police knew the shooting victim entered the establishment after being shot. One of the employees also said that he was the Manager of the tavern but when he was asked for his "Class B" manager's license, he changed his story and told officers that he just stocks and cleans the bar. While conducting these interviews, officers could smell fried food being made and found that there was an employee, in the kitchen, standing next to an oil fryer. There were four baskets of wings frying in the deep fryers and a five gallon bucket of chicken wings defrosting in the sink. The employee stated that they were selling food items and he was "in charge" of the food. Officers later check to see if the tavern had a food dealers license and found they did not. - 8. On 03/21/18 at 8:30 pm, Milwaukee Police performed follow up at 634 W. North Avenue (Level's on North) regarding earlier contacts with police at the tavern (Items #6 and #7). The agent stated that he wanted to work with police on any problems that may be the result of the establishment. He was informed that the employees were uncooperative with officers during a shooting investigation, the manager urinated in a sink, and employees were cooking and selling food. The agent informed officers that he was unaware of these problems and the person urinating in the sink was not the manager but just a "helper". He was informed that a meeting needs to take place per the request of the Captain of the Fifth District in order to work out any problems and about the citation's he will be issued for the earlier violation observed by officers.
- 9. On 07/22/18 at 12:40 am, Milwaukee Police conducted a tavern check at 634 W. North Avenue (Level's on North). In past contacts with police, occupants would lock the entrance to the establishment and open it after several knocks. When officers approached the tavern during this check, patrons attempted to shut the door on officers but they were able to gain entry before the door was fully closed. As police gained entry, multiple subjects blocked the entrance and officers observed multiple subjects flee into the back rooms of the location. Officers checked the two bartenders for Class D Operators license but neither one could verify their license status. The maximum occupancy of the establishment is 62, but officer's body cameras revealed that the tavern appeared to be above that occupancy. There was armed security inside the tavern and officers did have a conversation with the agent. No citations were issued.
- 10. On 08/14/18 at 10:29 pm, Milwaukee Police conducted a tavern check at 634 W. North Avenue (Level's on North). Officers were met outside by the agent and they proceeded to enter the rear of the business which is a kitchen area. Officers observed in the kitchen that the agent had four fryers on and a large bucket of chicken in the sink defrosting under water. The agent was informed that he is not allowed to serve food because he did not have a proper license and he stated that he was not selling the food, it was for a party. Officers informed him that making chicken for a party is still in violation and he could receive citations if he does it again. The agent understood and said he would stop making chicken. The agent informed officers that his license was up for renewal and he has a meeting with the alderperson regarding his license.

#### PA-33E Narrative

This report is written by P.O. Greg GREGORY assigned to District Five, Late Shift with PO Mark HORSTMEYER, Squad 5341.

On Saturday, March 17, 2018 at 3:15am, I was dispatched to saturate the area of 6th and W. North Ave. for a complaint of a shooting. I came in contact with a trail of blood that I followed to 634 W. North Ave. which is known as Level's On North. Outside the bar I observed multiple casings on the ground and on the stairs outside of the business.

I made contact with Clarence H. HALL (b/m, 11/04/86) whom later identified himself as the bar manager of Level's On North. HALL stated that he heard approximately 2 gun shots from inside the bar. HALL stated he was unable to hear shots prior to that because the music was playing loudly inside the bar. HALL stated he after he heard the shots he came outside and didn't see anyone in the area injured. HALL stated he did observe what he described as a dark vehicle possibly 4dr facing southbound within the intersection of 7th and W. North Ave. I then entered the bar and observed noise coming from the female restroom at approximately 3:30am on 03/17/18. I approached the bathroom, the door opened and two individuals later identified as Eric D. RUSS (b/m, 06/02/91) and Brianna N. REYNOLDS (b/f, 11/25/95) exited the restroom. I was informed not to let anyone leave the business until CIB arrived and made contact with the three individuals inside Level's On North. While inside the bar and during portions of this incident I had my MPD issued body camera functioning.

While inside the bar I was observing the floor of the bar looking for signs of entry to the bar by the victim from the blood trail I observed outside. I observed blood on the inside of the threshold of the door to the bar which lead me to believe that there may have been more blood inside on the floor. While I was using my flashlight inside the bar HALL got defensive and started to question what I was looking around the bar for. HALL asked for my name and I gave HALL my contact information on an MPD issued business card. HALL appeared to be agitated and continued to question me on what I was looking for inside the business. HALL informed kept informing me that he was just the bar manager and that the owner was Jeffrey L. HENDERSON (b/m, 05/26/78). I tried to gain information of HENDERSON trough HALL and he was being evasive. HALL gave me contact information to HENDERSON on the scene and was also asked to try to get in contact with HENDERSON regarding the incident. The number HALL gave me was the phone number to Level's On North and when HALL was asked how he gets in contact with HENDERSON he kept referring to that phone number.

CIB arrived at the scene and took over the investigation and I informed them of all the information that I had regarding the incident. HALL was being extremely uncooperative with the CIB Detectives and kept repeating himself while being asked questions regarding HENDERSON.

While inside Level's On North, I observed HALL behind the bar urinating in the bar sink behind the bar. I observed and heard HALL urinating while the door to the business was wide open disregarding me standing at the entrance of the business.

#### PA-33E Narrative

This report is written by PO David LETTEER, assigned to District 5 Tavern Car, Late Power Shift with PO Russell MACRAE, Sq. 5469.

On 03-20-18 we went to Level's On North, located at 634 W. North Ave., in order to conduct follow up regarding a shooting that occurred outside of the bar on 03/17/18 (IR 18-076-0023). Upon arrival inside if the bar, we observed a male handing a female sitting at the bar, a styroform box of food.

We then spoke to that male, a stocker at the bar, by the name of Clarance HALL (b/m 11-04-86) who stated he has been working at the bar for a month and was closing the bar on that day when he heard 10 gun shots from outside of the bar. He stated at this time the bar was closed and it was himself and a male and female customer that were in the bar. He stated the male and female customers were helping him clean the bar after close. HALL stated he hear the gunshots at or about 2:40 a.m., after bar close. He continued to tell us that he observed people running past the bar after the gunshots and observed a vehicle parked in the intersection of N. 7th St. and W. North Ave. I asked him if anyone had come into the bar and state they were bleeding or shot. He stated no one came into the bar. HALL stated he is the "Manager" of the bar. I asked him if he is the Class B Manager and he stated he was not, just a person who stocks and helps clean the bar.

I informed HALL that someone came into the bar and that the bartender and other patrons had helped the person who was bleeding from a gunshot wound and that bar towels was used to wrap his wound. I informed him that the bar was not in trouble that we were just trying to speak to the people that were there after the bar closed. HALL then changed his story and stated after the gunshots were heard, a male came into the bar, but he would not go into detail about what happened after coming into the bar.

While I was speaking to HALL, both PO MACRAE and I could smell fried food being made. PO MACRAE then walked into the kitchen and found that there was a person by the name of Michael S. WATKINS(b/m 10-25-82) standing next to an oil fryer and that he had 4 baskets of wings frying in the deep fryers and a large bucket (5 gallon) of chicken wings defrosting in the sink. WATKINS stated they were selling the food items and that he was in charge of food for the bar and also helps around the bar.

We then spoke to the bartender, Loyalty K. DIXON (b/f 10/01/82) who stated she was working the night of 03/17/18. She stated the bar was closed when the gunshots rang out. I asked her if anyone had come into the bar and claimed they were shot. She stated that no one came in and that the bar was closed at this time. She stated that when people leave the bar at close, no one comes back inside of the bar.

I then informed her that the victim of the gunshots came into the bar and that it was the bartender and other patrons who helped wrap towels from the bar around the gunshot wound. DIXON then stated a male was let into the bar by a patron and that he was bleeding. She stated he had blood on his pants and realized that he was shot. She stated the person shot was given towels to wrap around his wound and that he left shortly after that. She stated the male who was shot was outside of the bar for a few minutes then left. I asked her if anyone working that night had called the police and she stated a patron had called. I asked her if any bullets came into the bar and she stated nothing came into the bar.

I asked both HALL and DIXON if they both knew how to operate the DVR camera system and both stated they did not, but that the police had taken the DVR in order to look at it. I asked them if they had security working on this night. I was informed that security was working, but had left before the gunshots were heard.

Upon returning to District 5, we checked the online licensing system to find that Level's On North does not have a food dealers license and was issued a citation for not having a food license.

#### PA-33E Narrative

This report is written by PO David LETTEER, assigned to District 5 Late Power Shift, Sq. 5469 Tavern Squad with PO Russell MACRAE.

On 03-21-18 we returned to Level's On North and spoke to the owner Mr. HENDERSON. He informed us that he wanted to work with us on any problems that may be as a result of the establishment. I went on to inform Mr. HENDERSON of the food violation that we observed the night before and that we spoke to Mr. HALL and Ms. DIXON about what happened.

We informed Mr. HENDERSON that we were there to follow up regarding the shooting and that we spoke to Mr. HALL and Ms. DIXON, who were both working at the bar, the night of the shooting. We informed Mr. HENDERSON that the bar was not cooperative the night of the shooting with responding officers. We informed Mr. HENDERSON that the officers that responded to the shooting wrote a PA-33 regarding the events of the night. PO MACRAE read portions of the PA-33 to Mr. HENDERSON, things such as Mr. HALL not cooperating with the police and urinating in the sink behind the bar. We spoke to Mr. HENDERSON about the bar not being cooperative in regards to the video system. Mr. HENDERSON stated the workers did not know how to operate the cameras and that the detectives came back the next day, with Mr. HENDERSON allowing the detectives to take the DVR system. He went on to tell me since his last meeting, where his license was expired and he took a suspension from the licensing committee he has not had any problems at the bar and that the police have not been to the bar for anything.

I also asked Mr. HENDERSON if he was the only person currently on the license or if he had anyone else added. I went on to ask him if Mr. HALL was a licensee and was informed that Mr. HALL is nothing more than a helper at the bar, getting it cleaned up and stocking.

Mr. HENDERSON was unaware that Mr. HALL was not cooperative with the police, nor about him urinating in the sink behind the bar while the police investigating behind the bar. While speaking to Mr. HENDERSON, Mr. HALL was cleaning before the bar opened and he stated he had recorded the police on his cell phone and was not happy that the police were being disrespectful with him, he did not like the attitude with some of the officers at the bar. We also informed him that according to the statements of HALL and DIXON, there were two patrons in the bar after the bar was closed, helping Mr. HALL clean up.

I informed Mr. HENDERSON that a meeting needs to take place and the request of Captain HEIER. At this time Mr. HENDERSON wants to meet, in order to work out any problems. We are currently looking at having a meeting either in the first or second week of April, where District 5, Project SafeSound and other community members can bring concerns and resolutions to the bar. Mr. HENDERSON also stated that he is not happy about the way Mr. HALL conducted himself and that he would rectify the situation by firing Mr. HALL.

We will also be issuing Mr. HENDERSON a citation for Class B Premise Allow Patron After Hours. This will be based on Mr. HALLS statements to us, as well as officers observations on the night of the shooting (03-17-18).

investigation.

We arrived on scene at approximately 12:40AM. In past contacts with the location, occupants lock the entrance to the premise upon sight of police, and open the front door for us after several knocks. While approaching the front door this time, occupants attempted to shut the door. I was able to make it to the door in time to stop it from closing. When I opened the door, multiple subjects blocked the entrance, with one unknown subject stating that I should have knocked and attempting to confront me. I perceived this as an attempt to stall officers from entering the building. While trying to gain entrance to the location, I could see multiple subjects flee into the back rooms of the location.

I made contact with both bartenders, whom I witnessed serving alcohol, at the location, who were able to identify themselves with WI ID's, and who stated that they had their bartender certifications. Neither bartender was able to provide verification of their bartender status. They were identified as follows:

- -Tomica C THOMAS (B/F 07-21-1988)
- -Jaquese S HEMPHILL (B/F 05-23-1994)

I checked their premise licenses. Their paperwork states that their max occupancy is 62. There appeared to be above that amount of patrons inside of the location, which is able to be seen in officer's body cameras. Their tavern license #0205676 is effective from 11-07-17 to 11-6-18

There was an armed security guard working at the location. He identified himself verbally as Donald E JONES (8/M 01-18-1993). He was in uniform, with a badge hanging on a chain around his neck and wearing a full duty belt, with his pistol visible on his hip.

While officers were discussing the tavern check outside of the location, we were approached by Jeffrey L HENDERSON (B/M 05-26-1978), who Identified himself as the owner. I observed HENDERSON'S name on the liquor license report as the location's agent earlier. HENDERSON initiated contact with police officers. HENDERSON wanted to know why we were at the location. HENDERSON stated that these checks are not really routine, and that we are not the usual officers. During the conversation, HENDERSON dld state that he was armed with a pistol and is a valid CCW. I did observe what appeared to be a grip of a pistol printing through his shirt on his right hip. HENDERSON stated that everyone has a pistol. We then ended contact. A query of HENDERSON through E-TIME verified his CCW status.






