There is a possibility that your application may be denied for one or the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. See attached police report or correspondence.

Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

Limited parking for persons attending meetings during normal business hours is available at reduced rates (5 hour limit) at the Milwaukee Center on the southwest corner of Kilbourn Avenue and Water Street. You must present a copy of the meeting notice to the parking cashier.



LICENSED PREMISE REPORT

This report is being typed by PO Dellian Mendez-Santiago, assigned to District Two, Late Power, Tavern Squad 2445, and equipped with my department issued body worn camera, which captured this incident.

On Wednesday, October 23, 2024 at approximately9:00 PM, Squad 2445 (I) responded to 1401 S. 29th St, in the City and County of Milwaukee, to conduct two License Premises reports for "Tacos Los Picosos" and "El Miel De Amor" food trucks.

Upon arrival, I observed "El Miel de Amor" food truck was parked on the west side of S. 29th St facing southbound. I observed "Tacos Los Piscsos" was parked on the east side of S. 29th St, facing northbound. Both businesses were opening and operating. Both businesses were not playing music, their generators were not making noises, and both east and west side of the streets were being cleaned but by both food trucks.

Interview of Medina LOPEZ-ORTEGA owner of "El Miel de Amor"

I spoke to the owner of El Miel de Amor who was identified as Medina LOPEZ-ORTEGA (w/m, 8/12/85). LOPEZ-ORTEGA informed me she was confused with my visit. I explained to LOPEZ-ORTEGA, the reason for my visit is in regard to a license premises report, as neighbors have been complaining the food trucks are becoming a nuisance. LOPEZ-ORTEGA informed me her business hours are 12pm to 9pm Monday through Sunday and usually does not have any issues.

I explained there is a two-hour parking rule, where the establishment would have to move every two hours in order to avoid being cited by MPD or Parking enforcement. LOPEZ-ORTEGA stated she was not aware of this and was not approached by any officer's regarding this rule. LOPEZ-ORTEGA state she appreciated the conversation and the updates on the rules. LOPEZ-ORTEGA was also informed she is not allowed to park on W. Greenfield Ave, as it's a not parking zone for food trucks. LOPEZ-ORTEGA informed me she was aware of that rule but not the parking rule. LOPEZ-ORTEGA stated she is working with the owner of Blue Kangaroo to have access to parking in the rear of the parking lot to be able to avoid further problems with MPD.

LOPEZ-ORTEGA stated she does not understand why, I was solely speaking with her as there are two other food trucks that also work from that location. I informed LOPEZ-ORTEGA I would be speaking with all the trucks there.

LOPEZ-ORTEGA informed me her food truck and "Los Picosos" are the only two trucks now working as the third truck was upset MPD was bothering them.

Interview of Jose L RODRIGUEZ-NUNEZ "Tacos Los Piscsos"

I spoke to the manager on scene, who was identified as Jose L RODRIGUEZ-NUNEZ (9/10/67). I informed RODRIGUEZ-NUNEZ, I was here to conduct a License Premise report and speak to him about the parking rule. RODRIGUEZ-NUNEZ informed me his boss was aware of the rule but did not understand what officers were talking about as he does not speak English.

I explained to RODRIGUEZ-NUNEZ due to the location of his food truck, he has to move and park at a different location every two hours, to avoid receiving a parking.

RODRIGUEZ-NUNEZ stated he would pass the information on to his boss and would call me if they had any questions.

RODRIGUEZ-NUNEZ informed me the food truck hours are from 2:00 PM to 9:00PM.

End of interview with RODRIGUEZ-NUNEZ.

I provided both food trucks with my contact information.

No violations were observed.

After two hours both food trucks were no longer at the location.

Both businesses, had their license information posted on the front window and are currently valid.



The hearing before the Licenses Committee will take place on 10/21/2025 at 10:00 AM in Room 301-B, Third Floor, City Hall. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony via internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
