Dear Ms. Singer:

This office is in receipt of your claim in the amount of \$104.00, for your time spent in the winter of 2003 for snow removal from your sidewalk at 4823 South 21st Street.

Our investigation reveals that you have 24 hours to remove snow from your sidewalk, but you chose to remove the snow immediately prior to the snowplows coming through your neighborhood. The Sanitation Division indicates the snowplow crews are instructed to drive slowly to minimize snow being thrown on the sidewalks. The division also noted the City has a program for elderly or disabled residents whereby, the City will clear their sidewalk for a nominal fee which is placed on the property's tax roll. Since the Sanitation Division followed normal and customary procedures, the City cannot accept liability. Accordingly, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
