This report is written by Police Officer Penny Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 09/03/22 at 1:01a.m., Milwaukee Police were dispatched to a Threat at 7311 W. Capitol Dr. Investigation revealed a subject entered the store and requested a free blunt. When the cashier denied the request, the subject brandished a firearm and stated "I'll Kill you", then fled the store. The cashier stated the subject is a regular at the store and would provide video surveillance to the officers once the cameras could be reviewed by the store manager.
- 2. On 10/24/22 at 12:38a.m., Milwaukee Police were dispatched to Children's Hospital for a walk-in shooting victim. Investigation revealed this was related to an earlier call for Shots Fired at 7311 W. Capitol Dr. Video surveillance depicted the victim exiting the store and standing outside the door. Suspect #1 exited the store and suspect #2 exited a parked vehicle with a firearm, which suspect #1 took and began to chase the victim, firing several rounds, eventually shooting the victim in the thigh. The victim initially lied to the police, stating the incident occurred on N. 60th St., however, the employee's cooperation allowed the officers to ascertain where the incident occurred by calling for police and allowing officers to view video surveillance of the incident.
- 3. On 11/14/22 at 6:04a.m., Milwaukee Police were dispatched to a Shoplifter at 7311 W. Capitol Dr. Investigation revealed a subject had poured a drink, refused to pay for it or leave the store. The subject was arrested and conveyed to the district for processing.

- 4. On 04/08/23 at 12:07a.m., Milwaukee Police were dispatched to a Fight at 7311 W. Capitol Dr. Investigation revealed two subjects were physically fighting inside the store, which prompted the call for police. The employee was cooperative and allowed officers to view video surveillance of the incident.
- 5. On 04/20/23 at 7:21a.m., Milwaukee Police were dispatched to a Fight at 7311 W. Capitol Dr. Investigation revealed a subject threw a rock through a window of the store. The employee was cooperative and allowed officers to view video surveillance of the incident.
- 6. On 06/16/23 at 12:09p.m., Milwaukee Police conducted a License Premise Check at 7311 W. Capitol Dr., regarding drug dealing complaints. The manager was cooperative and stated there are drug deals that occur in the parking lot, however, didn't have specific details on people or vehicles. The manager was advised to call the police when they suspect drug deals are taking place in the parking lot.

PO Charles WORTHINGTON drafted the following report regarding an incident that occurred at 7311 W. Capitol Dr.

"This report is written by P.O. Charles WORTHINGTON, assigned to District 7, Late Shift.

On Sunday, September 4th, 2022, at approximately 1:01am, Squad 7369 (P.O. Shemar MOORE and I, while in full duty uniform, equipped with an axon body worn camera operating a marked Milwaukee Police Squad car) responded to a threat complaint at the BP Gas station located at 7311 W Capitol drive, which is located within the City and County of Milwaukee, WI.

Prior to our arrival, reported in the CAD (Computer Aided Dispatch) revealed, the caller was threatened by an unknown male subject and that a gun was flashed at the caller.

Once arriving on scene, I spoke with the Caller/Victim who was later identified by his Driver's License as LOVEDEEP SINGH (W/M 02-20-2001). SINGH is also the only gas station clerk working at the BP station and his regular shift is from 9:00pm-9:00am. SINGH stated that on yesterday's date (September 3rd, 2022) at approximately 10:45pm, a male subject entered the gas station and began to argue with him. SINGH stated the unidentified subject was wearing a green zip up jacket labeled in white lettering "KAPPA" on the left chest area, blue jean pants, unknown shoes, black ski mask that covered majority of the subject facial features, standing approximately 5'08, 190lbs, medium build. SINGH stated the subject inquired about receiving a free blunt and paying for it later on.

SINGH denied the subject offer to which the subject replied," I'll Kill you." SINGH stated the subject brandished a black semi automatic handgun from his front waistband, pointing and aiming the handgun towards SINGH. SINGH was stationed behind the store's plexiglass during the subject actions. SINGH stated the subject immediately fled outside the store running westbound on W Appleton Ave. SINGH stated he couldn't describe the firearm any further or the suspect description. SINGH stated that he was unaware how the camera's worked and did not have a still photo of the subject. The suspect actions caused SINGH to fear for his safety and replied that the subject comes into the store often. SINGH was advised to notify myself or contact District 7 when an image of the suspect appeared once his manager reviewed the store camera. SINGH was issued a PV-17 and a community contact card regarding. We searched the area in attempt to locate the suspect, however the subject wasn't located. No other cameras were located within the vicinity of the gas station that would've captured the suspect description.

"On Monday, October 24th, 2022, at approximately 12:38am, MPD Officers were originally dispatched to Children Hospital of Wisconsin located 9000 W Wisconsin in regard to a walk-in shooting victim. The victim identified as MICHAEL J COLLINS (B/M 11-03-1998) drove himself to Childrens Hospital as he suffered a gunshot wound to his right thigh. COLLINS drove himself in a black 2022, Nissan Pathfinder WI auto plate AMV-1406, Vin # 5N1DR3ACXNC227974 listed to LISA M JORDAN (B/F 05-29-1963). JORDAN is COLLINS mother and the two of them reside together at the address of 3935 N 60th street. Once COLLINS was transported to FROEDTERT HOSPITAL ED room 19, I was able to collect a statement from COLLINS. COLLINS stated near 12am he walked outside his residence with his 3-year-old German Shepard to take his dog on a walk.

COLLINS stated he was walking northbound on 60th street from his residence approaching Capitol Dr, when he heard 5 gunshots coming from an unknown direction. COLLINS stated that two undescribed individuals were shooting at each other. COLLINS stated he couldn't describe any of the subjects who fired the shots or if any vehicles were involved with the shots fired. COLLINS stated he noticed that he shot in his right leg and immediately ran to his mother's vehicle and fled from the location. COLLINS stated he already had the car keys on him and did not notify anyone of his injury. COLLINS stated he didn't know where his dog ran off to, but he quickly wanted to drive himself to the hospital. COLLINS stated he doesn't believe he's being targeted. COLLINS was admitted to FROEDTERT at 12:45am and treated by Physican TOM GRAWEY who confirmed there was a gunshot wound to COLLINS's right thigh.

Be advised that squads responded to the BP Gas Station located at 7311 W Capitol drive for reports of shots fired in the area. The call was placed by the clerk, Abraham, who reported hearing 3 shots fired outside. Upon arrival, Officers located a blood trail and 1 casing in the vicinity of the gas station lot. This call was generated at 12:22am and victim's mother (JORDAN) informed Officers that her son (COLLINS) usually hangs out in this gas station area. JORDAN also stated that she did not hear any shots throughout the night while inside her residence."

The review of video surveillance revealed that both the victim and suspect of the shooting were inside the gas station at the same time but there appeared to be no altercation inside. The clerk, Abraham, stated he was unable to access the video and that someone would have to access it during the day.

Taken from the detective's review of the video:

Camera 7 depicts the suspect vehicle, a light colored minivan arriving at 12:15:00am, parking at gas pump #3 facing north bound in the lot towards N. Capitol Dr.

Camera 7 depicts the victim arriving at 12:18:10am driving a dark colored Pathfinder, and parks south of the suspect vehicle also facing north towards N. Capitol Dr, just west of the building.

Camera 11'depicts the B/M suspect entering the gas station at 12:18:00am.

Camera 11 depicts the victim entering the gas station at 12:18:47am.

Camera 11 depicts the victim exiting that gas station at 12:19:42am and standing near the door until the suspect exits at 12:20:18am.

Camera 11 depicts a B/F passenger seated in the front passenger's seat of the light colored minivan, who exits, points a firearm at the victim at 12:20:20am.

Camera 11 depicts the B/M suspect taking the firearm from the B/F at 12:20:27am, who then begins to chase the victim around the east side of the building.

Camera 11 depicts the B/F retrieves what appears to be a second firearm from inside of the light colored minivan at 12:20:33am.

Camera 11 depicts the B/F starts to run towards the front of the building, then returns to the light colored minivan and puts what appears to be a firearm back into the vehicle at 12:20:44am.

Camera 11 depicts the B/M suspect come back into frame, still chasing and shooting the victim at 12:20:55am.

Camera 11 depicts the B/M and B/F get back into their light colored minivan and drive off the lot, eastbound onto W. Capitol Dr at 12:21:55am.

Camera 11 depicts the victim getting back into his dark colored Pathfinder and exiting onto w. Appleton Av, then westbound onto W. Capitol Dr at 12:21:35am.


