1st Aldermanic District

W. Hampton Ave. – N. Green Bay Ave. to N. Teutonia Ave. (ST320100801):

Concrete pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches where necessary, sodding (6-foot width of tree border area), and grading.

Approve, by Ald. Donovan. Prevailed. 4-0

N. 35th St. – W. Cameron Ave. to W. Villard Ave. (ST211130121):

Concrete pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches where necessary, sodding (9 – 11-foot width of tree border area), and grading.

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, install new walk as necessary, sodding (8-foot

width of tree border area), and grading.

N. 105th St. – W. Bradley Rd. to W. Sylvia St. (ST211130109):

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, install new walk as necessary, sodding (8-foot width of tree border area), and grading.

Approve, except no sidewalk work, with extended late billing, by Ald. Puente.

12th Aldermanic District

S. 14th St. – W. Harrison Ave. to W. Lincoln Ave. (ST211130138):

Pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches where necessary, narrow roadway from 36 feet to 32 feet, sodding (7-foot width of tree border area), and grading.

Approve, by Ald. Donovan. Prevailed. 5-0

13th Aldermanic District

Alley between W. Crawford Ave., W. Howard Ave., S. 16th St., and S. 17th St. (East-West Leg) (ST212070103):

Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, grading, and storm drainage facilities where necessary.

Approve, by Ald. Donovan. Prevailed. 5-0

14th Aldermanic District

S. Griffin Ave. – E. Morgan Ave. to E. Holt Ave. (ST211120107):

Pavement reconstruction, replace all curb and gutter, replace sidewalk and driveway approaches where necessary, sodding (7 – 9-foot width of tree border area), and grading.
