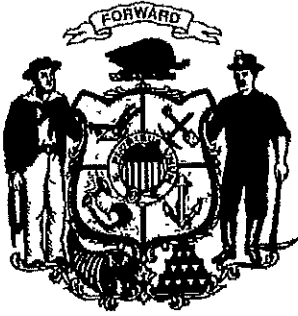



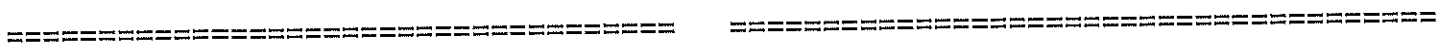

Dear Jose,

I hope this finds you well.

2 years ago on the fourth of July a \$900 window of mine sustained a hole from a falling "celebration" bullet. This year the neighborhood is lit up with both consumer grade and heavy duty professional grade fireworks and I think it's *intolerable* that enforcement is so lax. I grew up in a Milwaukee where you could get sparklers and snakes and that was it, and widespread flouting of laws regarding the sale and use of fireworks within city limits did not exist.

Besides the absolute fact that this poses a danger to life and property, it is also a quality of life issue. Noise pollution is not a fictitious concept. Noise has a real, measurable effect on people and this city is extremely permissive about noise. Pedal Taverns blasting music as patrons scream while wobbling down our streets, motorcyclists who flout the rules about exhaust systems and let out literally ear-damaging blasts of sound just for fun, or to signal their presence, vehicles blasting 150 decibels (as you recall) of bass so loud it penetrates my _____ which is otherwise impervious to outside sound..... all are all tolerated in *your* district and it's really disappointing.

I hope you can exert some influence in this area. We are in so many other ways improving as a city - noise enforcement is a glaring exception.
