Pursuant to the provisions of Sec. 893.80(1)(a) the claimant, Derrick Graham, an adult, residing at 2848 W. Wisconsin Avenue, in the City and County of Milwaukee, State of Wisconsin, herewith gives notice of injury giving rise to a future claim for relief in the form of monetary damages as set forth below:

1. The attorneys for Derrick Graham, an adult resident of the City of Milwaukee, residing at 2848 W. Wisconsin Avenue, Milwaukee, Wisconsin, are GENDLIN, LIVERMAN & RYMER, S.C., 10335 W. Oklahoma Ave. Suite 300, Milwaukee, WI 53227.
2. This Notice of Injury will also serve as a formal notification of our attorney lien rights in accordance with Wisconsin Statute §757.36.
3. That Derrick Graham sustained serious personal injuries and damage to his vehicle at approximately 5:37 p.m. on May 19, 2023 at West State Street and North 26th Street, in the City and County of Milwaukee, when City of Milwaukee firefighter, Robert Wilson, while acting within the scope of his employment, drove a Milwaukee Fire Department truck negligently including but not limited to his failing in his duty of lookout, failing in his management and control of the vehicle, failing to negotiate a turn, and struck the parked vehicle that Derrick Graham was occupying resulting in serious injuries to Derrick Graham.

4. That a proximate cause of said injuries was the negligence of Milwaukee County, Milwaukee Fire Department, and Robert Wilson, causing serious injuries.

5. That as a result of the foretasted incident, Derrick Graham sustained serious personal injuries, pain, suffering and disability and incurred medical expenses, loss of earnings, and damage to his property.

6. That the undersigned is one of the attorneys for Derrick Graham, and is, therefore, authorized to give this Notice of Injury and certifies that the above-described injury, damage actually occurred, that I have read the above notice and that the same is true to my knowledge except for those matters stated upon information and belief and as to those matters, I believe the same to be true.
