3	Dance renewal application and Tavern Amusement
4	renewal application, a change of entertainment as
5	agent for "Stargazers, LLC," for Stargazers at
6	7158 West Fond du Lac Avenue.
7	Good morning to you.
8	THE APPLICANT: Good morning.
9	VICE-CHAIRMAN BOHL: Ms. Honey, we'll
10	have you raise your right hand. Are there any
11	other neighbors who are here to testify on
12	Stargazers other than the gentleman who is here
13	with us? Any others here? Okay.
14	Please, we'll swear you both in. Thank
15	you.
16	(Whereupon the witnesses were sworn.)
17	VICE-CHAIRMAN BOHL: Name and address
18	for the record, please.
19	THE APPLICANT: Eretta Honey, 8990
20	North 95th Street, Milwaukee 53224.
21	VICE-CHAIRMAN BOHL: And, Ms. Honey, I
22	need to ask you if you acknowledge receiving
23	notice of today's meeting with the possibility
24	your application could be denied. It is cited
25	for matters contained within the a police

2	THE APPLICANT: Yes, sir.
3	VICE-CHAIRMAN BOHL: Going around the
4	horn. Health Department?
5	HEALTH DEPARTMENT: No objections.
6	VICE-CHAIRMAN BOHL: Neighborhood
7	Services.
8	DNS: No objection.
9	VICE-CHAIRMAN BOHL: Sergeant?
10	SERGEANT ULICKEY: On 3/26 of '06 at
11	approximately 2:11 a.m. Milwaukee Police
12	Department Officers were dispatched to the
13	licensed premises, Stargazers, 7158 West Fond du
14	Lac, to investigate a shooting. The licensee,
15	Honey, stated that that a DOE, Germane A.
16	Wright was attempting to settle an argument
17	between two unknown actors through the course of
18	the night. One of the actors left the bar and
19	returned with an unknown blunt object in his
20	right pocket. A door bouncer, Gary Burdine,
21	attempted to prevent the unknown subject from
22	reentering the bar by physically restraining him.
23	The actor was still able to fire off a round
24	striking the DOE behind the left ear. The
25	investigation shows the shooting took place in

00004 the doorway of the establishment, and the police 1 2 being called from the establishment. 3 VICE-CHAIRMAN BOHL: Questions by 4 Committee of Sergeant Ulickey at this point? 5 Ms. Honey, is there - - Are there any 6 questions or comments you want to raise at this 7 point relating to the matters as read into the 8 record by the Police Department? 9 THE APPLICANT: I tried to get a copy 10 of the police report last night. I was told that 11 the investigation is open, and that the City 12 Attorney had the - - the report and I could not 13 get it. I wanted to also get Detective Formello, 14 who had told me he would come and speak to you all, but he was off last night. The last part of 15 16 that is true. The first part is not true. That 17 is not what I told him. I don't know how much I 18 can say, because the investigation is open. But 19 can I explain what - -20 SERGEANT ULICKEY: Yes. That's up to 21 you, if you'd like to explain further. And I 22 will add that this is just a short summation. 23 This by no means is the entire investigation. 24 THE APPLICANT: Well, I - - I was not 25 aware - -

00005 1 VICE-CHAIRMAN BOHL: Ms. Honey, one - one second. Mr. Schrimpf, if you - -2 3 MR. SCHRIMPF: Thank you, Mr. Chairman. 4 Mr. Chairman, because the term City Attorney was 5 used, I have no knowledge of the City Attorney's 6 office having any reports from this matter. 7 THE APPLICANT: That's what the - - I 8 went to the police station on Fond du Lac and 9 Capitol to speak to Detective Formello to let him 10 know about today's meeting. They told me that he 11 works out of downtown and to call down there. 12 And I called down there. They told me I could 13 get the reports at open records this morning. 14 When I called down there last night, they told me 15 that - - They called me back, as a matter of 16 fact, and told me that there were no reports 17 available to me, because it's an open 18 investigation. But that the City Attorney had 19 the report, so. 20 ALDERMAN PUENTE: Mr. Chair. 21 VICE-CHAIRMAN BOHL: Alderman Puente. 22 ALDERMAN PUENTE: Yeah, that's - -23 that's not accurate if you were told that. The 24 District Attorney would handle this type of case. 25 So if they said City Attorney, they - -

00006 THE APPLICANT: They said City 1 2 Attorney. As a matter of fact - -3 ALDERMAN PUENTE: Just so you know. 4 It's not the City Attorney. It's the District 5 Attorney that would handle a homicide. THE APPLICANT: Okay. 6 7 ALDERMAN PUENTE: And I would ask you, 8 what would this Detective tell you or - -9 THE APPLICANT: Well, he just told me 10 during the investigation that if I needed someone 11 to come and speak on - - on the behalf of the - -12 of the club that he would come. 13 ALDERMAN PUENTE: Does he frequent your 14 club? 15 THE APPLICANT: No. Never seen him 16 before. 17 ALDERMAN PUENTE: That would be very 18 unusual. 19 THE APPLICANT: Well, sir, I'm - - I'm 20 telling who he is, and you can speak to him if 21 you want to, but that's what he said. The reason Stargazers 3 has not had a problem in the past is because when 4 there are any type of verbal issues, I tend to 5 handle them myself even over security. And that 6 is because I feel that I can handle them better 7 than security. 8 Now, if it were ever to get physical, 9 then that's their job. But a lot of people call 10 me "mom," and I guess maybe that's why. I - - I 11 wouldn't - - I would not have a customer trying 12 to solve an issue. That just doesn't make sense. 13 I did not know there was a problem until I heard 14 the "pop," and even at that time I didn't know 15 what it was. So the rest of it is - - is true. 16 But that part, I didn't know there was anything 17 going on. 18 VICE-CHAIRMAN BOHL: Ms. Honey, I - - I 19 have a question for you. Why - - Why is it that 20 you are applying for some additional 21 entertainment? 22 THE APPLICANT: My - - My change - -23 - - hasn't - - I don't know what that part is. 24 VICE-CHAIRMAN BOHL: Well, in - - in -25 - in the past year you have not - - you have not

And this is not the first time 14 that I've raised my concerns at that particular 15 location, and this has nothing to do with the - -16 the - - the reflection on - - on the person who 17 is - - who is applying for the license. It has 18 to do with the operation of the establishment 19 itself, which has been a concern of the 20 neighborhood. And I'll represent that 21 neighborhood, since they can't speak, as their 22 alderman. 23 There was numerous times that Ms. Honey 24 could have - - as far as the situation is
