We have received your claim in the amount of \$613.00, relating to damage done by the Milwaukee Police Department (MPD) on December 15, 2006 when they were in search of an armed robbery suspect that they believed had fled into your garage at 4937 North 74th Street.

Our investigation reveals that the MPD was in pursuit of an armed robbery suspect in your area. The officers were searching the yards and found the service door to your garage was open. You informed the MPD that your son had nailed this door shut. The officers also pushed on the door and it was pushed back shut. The MPD established containment and made several announcements that were met with no response. The officers then deployed projected OC based on the circumstances and the fact they still had not captured the suspect in question. The MPD was acting within its sphere of responsibility, as such, we are denying your claim.
