Your letter of December 14, 2006 countersigned by Steven Carini, Investigator/Adjuster has been received. When filing my claim, I was required to provide evidence of prices from TWO sources for everything being claimed. Your letter gives a proposed settlement amount for about half that amount with absolutely no documentation, explanation or proof as to how your office arrived at this amount.

As was told to Mr. Carini on Dec. 26, 2006, one of the items we listed in the claim which was not part of the inventory (an Illinois Toll Authority I-Pass transponder) has been used several times since mid-August by a car with license plates not belonging to me at the toll plaza closest to the Wisconsin border. This information was discussed with my attorney who has reported it to Ms. Michelle Jacobs, Asst. U.S. Attorney there in Milwaukee who is the prosecutor of the above case.

Obviously, there is a serious need for a written procedure to cover the seizure, inventory of contents in complete detail (not 29 CD's, but listed by title/artist) by at least two people, the proper way to secure a car so no unauthorized persons have access to the vehicle, how to notify the registered owner of the vehicle and their attorney with a copy of the inventory, etc. I <u>never</u> received a copy of an inventory; my attorney never received a copy of an inventory; no information was ever forwarded as to how to retrieve my possessions until after the vast majority of the "partial" inventory had been "inadvertently destroyed" by the property section of the Milwaukee P.D.

I learned my I-Pass was being used when I called the Illinois Toll Authority and requested they close the account and send me a check for the remaining balance. There should be no doubt that the "inventoried" as well as not inventoried property was stolen and/or divided up by those who were interested in what I had in the car.

Since someone has stolen my property, which was not included in the inventory, I suggest you approve my claim in full since you have no valid way to prove the completeness of the supposed inventory.

Gentlemen:

First of all, I want to mention that the Milwaukee Police Department never notified me in any way that personal property had been removed from my automobile and (supposedly) inventoried. A copy of the inventory was never sent to my home or attorney. If sent, I never received it.

Not having been notified in any way (mail, e-mail or telephone), I had no knowledge that my property could be reclaimed and picked up or shipment arranged. It would seem that there would be complete written procedures including that notice should be sent by Certified Mail, Return Receipt which would protect you and your staff.

For some things I don't know how to go about getting two (2) estimates. For instance, for the lost shoes, I have gone to the manufacturer websites and printed their information that should certainly be considered accurate.

Not having received the supposedly complete inventory listing, I was unable to object to the fact that there are several items missing from the list. I had garage door opener(s) for both my parent's home where I live and my brother's home — only I opener is listed in the inventory. For my I-Pod (which has been returned in ruined condition), I had an adaptor in the console, which was a charger and served to connect it to the audio system in the car. Mounted to the windshield with velco strips was an Illinois Toll Road I-Pass transponder. I have provided information from Best Buy for a replacement I-Pod as well as for your choice of the four (4) adaptors listed at Best Buy. COM. The returned I-Pod had been ruined by your evidence technicians as what had been on the unit is almost totally ruined — more than 2/3 of the recordings are now garbled so the unit has been ruined and should also be replaced.

In going to Amazon.com and Barnes & Noble. COM, they didn't both have all the CD's on their lists. I have made adjustments to the totals for the two listings to add the missing titles from each list. The grand totals come out to a \$35 difference.

For the garage door openers, I enclose an estimate from the company I have used for my homes the last 33 years. They installed the original openers, replacement overhead springs (twice), replacement door, replacement openers and all remotes. They are the

ONLY party I will accept to come to my home and my son's home to reprogram the base unit, reprogram the other remotes and provide a new remote at each location to replace what your P.D. couldn't keep track of.

For the CD's, the totals are \$579.56 through Amazon.COM and \$613.65 through Barnes & Noble.COM. The remainder of the personal property (shoes, garage door openers, I-Pod and I-Pod adaptor) cost a total \$806.97 plus \$50 to replace the destroyed I-Pass transponder. The grand totals, depending on which source you choose for me to purchase the replacement CD's are \$1386.53 or \$1420.62, plus \$50 for the I-Pass, which is not subject to sales tax. All the lost items were bought at local retail stores. Now, most everything needing replacement will have to be bought through Amazon.com or similar where there is shipping, please add \$100 for shipping charges due to the large number of items to be bought & shipped. Where I would be going to make some of the purchases, the sales tax rate is 7.0% for another \$97 - \$100.

I can be reached at my home telephone number of 630-357-5003 nearly 24 hours each day as I'm on a home monitoring system.

As to detailed description, I'm enclosed a copy of what we finally received along with my personal property which had been in the hands of the evidence people. While they ruin things, they at least know how to keep track of them.

Your timely response will be appreciated.

This supplemental report is submitted by Detective Doreen Andrews, of the Criminal Investigation Bureau, High Technology Unit, day shift.

On August 16, 2006, while at the City Tow Lot, I removed items from McIlrath's Vehicle, as the vehicle was scheduled to be transferred to a lot belonging to the US Marshall's Office.

I removed 34 cd's a blue bag containing jumper cables, and ice scraper and a light, 2 pair of shoes, a bag containing a charger, socks, documents, and a garage door opener, as well as two additional ice scrapers, three empty cd cases, and an umbrella. I placed all of those items on Inventory #341753 as safekeeping.

A safekeeping inventory is used to temporary hold items not of evidentiary value until they can be claimed by the owner.

On October 13, 2006, I called the Property Bureau to determine whether Christopher McIlrath had claimed the property listed on inventory 341753. I was informed that it had been inadvertently destroyed.

The property bureau has provided me with a form with detailed instructions on how to file a claim against the City of Milwaukee.

- As detailed a description of the incident as possible, including the date, time and place.

ADDITIONAL INFORMATION

Before you can file a lawsuit against the City of Milwaukee for reimbursement, State law requires that you first follow the claim procedures established by the City Clerk.

Filing a claim against the City does not automatically guarantee reimbursement from the City. However, the City examines each claim on an individual basis in determining if reimbursement is legally required.

In order to obtain reimbursement for a claim against the City, you must prove that the City or its employees acted unlawfully or negligently.

Only the City Attorney or the Common Council and the Mayor can authorize payment of a claim against the City. Any other representations made by City employees are not legally binding on the City.


