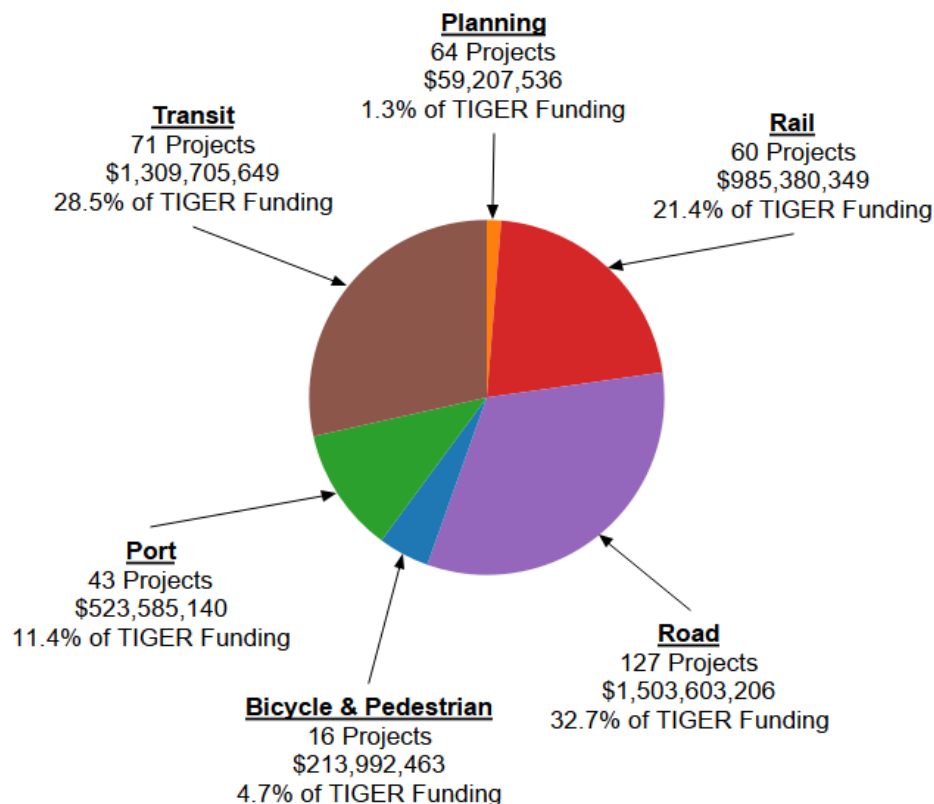

# 2016 TIGER: Fourth Street Extension

## TIGER: Transportation Investment Generating Economic Recovery

- \$4.6 billion awarded in first seven rounds of the program
- \$500 million allocated for 2016
- Focused on capital projects that generate economic development and improve access to reliable, safe and affordable transportation





# 2016 TIGER: Fourth Street Extension



## Project Details:

- .75 route miles
- 1.17 track miles
- 3 stops
- 90% dedicated lane
- 90% off-wire
- 1 new vehicle
- \$40M Total Cost (\$20M Fed / \$20M Local)

# 2016 TIGER: Fourth Street Extension

## Rationale for application

- Further implementation of the approved LPA
- Connects the Milwaukee Streetcar to:
  - The redevelopment of the Shops at Grand Avenue
  - TOD opportunity @ Wisconsin Avenue & 4<sup>th</sup> Street
  - Convention Center & over 2,500 hotel rooms in Westown
  - Growing residential base in Westown (over 1,200 units since 2010)
  - New Milwaukee Bucks Arena Development
  - Potential Milwaukee County Bus Rapid Transit
  - Major corporations (Bon-Ton, WEC Energy Group, Milwaukee Journal Sentinel)
- EA/FONSI approved and 30% Plans Completed
- Existing and/or new Tax Incremental Financing possible for local match
- Enables future north/south extension to Bronzeville and Walkers Point

## Anticipated Project Schedule

- April 29, 2016 – TIGER Application Due Date
- Summer/Fall 2016 – Council consider local match
- Fall 2016 – TIGER Projects awarded
- Fall 2017 – Complete Final Design
- Spring 2019 – 6<sup>th</sup> vehicle delivered
- Fall 2019 – Complete construction
- Spring 2020 – Testing completed
- Spring/Summer 2020 – Open for service
