The Milwaukee Police Department's investigation regarding this application revealed the following:

The following items are related to the licensee and business located at 9091 N. 76th Street. Three Star Foods.

- 1. On 07/18/24, at 12:36 p.m., officers were dispatched to a Retail Theft complaint. Two suspects entered the business. Suspect one retrieved a foam cooler from a shelf and filled it up with items. Suspect two requested a Black and Mild, which the employee told them they did not have. Both suspects exited the business without paying for the items in the cooler. Security footage was not able to be obtained during the investigation.
- 2. On 06/15/25, at 3:43 a.m., officers were dispatched to a Burglary. Security camera footage showed two suspects break an exterior glass, gain access into the building. The suspects attempt to force entry into the cashier area but were unsuccessful. Both suspects flee without anything of value.
- 3. On 06/07/25, at 12:42 p.m., an officer assisted in a WI WINS Tobacco compliance check. Two females under the legal age to possess tobacco, working with an agency and MPD. entered the business asked an employee for a Swisher Sweet cigar. The employee provided the females with the tobacco product without checking for an ID and confirming their ages. The employee was advised and business agent cited.

4. On 06/27/25, at 12:20 p.m., the business agent called MPD License Investigation Unit and spoke to an officer. The agent informed the officer he is not involved with the business which was sold to a cousin 3 months earlier. The agent was not aware of the current 2025 Filling station and Food application filed in his name. He stated someone must have put his name on the application.

Upon our arrival we spoke with the Store Manager of Speedway, his name is Lauersdorf, Keith R, who stated at 10:00AM on this date, two unknown B/F's entered the store. Subject number one, retrieved two foam coolers from the shelf and filled them with the listed consumable items. Subject number one did not proceed to the checkout, but walked passed the last point of sale and exited the store. Subject number 2 asked for a Black and Mild at which time she was advised they didn't have any and she proceeded to exit the store. Both subject entered a red unknown type vehicle and drove south bound from the location.

We requested to view the video, but Lauersdorf was unable to access the video at that time. We also requested an email address, so once they were able to access the video, they would be able to upload it to Evidence.com. The email was not able to be provided by Lauersdorf at that time, he stated someone else would be able to provide that information via telephone. On 06/27/25, at 12:20 p.m., I received a phone call from a male that identified themselves as Darshan Darar the agent for 9091 N. 76th Street, Three Star Foods. Darar was inquiring about a business check that I conducted at his business. I advised him of the following.

On 06/07/25 I conducted a Wisconsin Wins Tobacco check with Jump at the Sun consulting agency. There were two minor females under the legal age to buy or possess any tobacco products working with the Jump at the Sun and Milwaukee Police conducting compliance checks. The females walked into the business and asked for a cigar product, and they were served by an employee without requesting to a valid ID to verify their age.

Darar stated the employee told him the female looked to be old enough to purchase tobacco products. I advised him that ID's should always be checked if the employee did not previous do so confirming the person's age to legally buy the product.

Darar asked what was going to happen, and I advised him a report would be filed, he may get a letter from WI WINS, and I would be mailing him a citation. Darar asked why was he getting the citation, and I informed him as the business agent he is responsible for the business and some of the employees' actions.

Darar stated that his cousin Ranir Sigh should get the citation because he sold Sigh the business 3 months ago, and he had nothing to do with the business. I asked why was he still the listed agent for all the licenses related to that business, but Darar did not know why it was not changed. I asked why did he (Darar) apply for a renewal on the licenses for that business (Filling 381971 and Food 381972) and Darar stated, he didn't, and someone must have put his name on the application.

Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony via internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
