5th Aldermanic District

N. Lovers Lane Rd. – W. Silver Spring Dr. to a point north of W. Silver Spring Rd. (ST211080101):

Asphalt surface overlay, replace curb and gutter, sidewalk and driveway approaches where needed, sodding.

6th Aldermanic District

N. 1st St. – W. Concordia Ave. to W. Keefe Ave. (ST211089001):

Install traffic calming devices.

8th Aldermanic District

Alley between W. Dakota St., W. Montana St., S. 49th St. and S. 50th St. (ST212020118):

Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, grading, and storm drainage facilities where necessary.

10th Aldermanic District

Alley between W. Galena St., W. Vliet St., N. 59th St. and N. 60th St. (ST212060121):

Concrete alley pavement reconstruction, replace some abutting walk or driveway approaches, grading, and storm drainage facilities where necessary.

11th Aldermanic District

W. Tripoli Ave. – S. Massachusetts Ave. to S. 75th St. (ST211080103):

Asphalt pavement resurfacing (inverted crown), replace driveway approaches where necessary, sodding.

14th Aldermanic District

E. Montana St. – S. California St. to S. Clement Ave. (ST211080115):

Asphalt pavement resurfacing, replace all curb and gutter, replace sidewalk and driveway approaches where needed, sodding, grading, and tree removal where necessary.
