Pursuant to sec. 125.12 of the Wisconsin Statutes, and Chapter 90 of the Code of Ordinances of the City of Milwaukee, you are hereby commanded to appear on May 29th, 2009 at 9:45 A.M. at a hearing before the City's Licenses Committee to be held in Room 301-B, City Hall, 200 East Wells Street, Milwaukee, Wisconsin to show cause why your Class "B" Manager License should not be revoked or suspended. The hearing is being initiated because of the City of Milwaukee's receipt of a signed and sworn written complaint filed by the Chief of Police seeking the revocation of the Class "B" Manager License issued for the establishment located at 4001 W. Fond du Lac Avenue in the City and County of Milwaukee, Wisconsin. A copy of this complaint is attached hereto. You are also being provided with a copy of sec. 90-12 of the Milwaukee Code of Ordinances.

On May 29th, 2009 at 9:45 A.M., you will be given an opportunity to speak on your own behalf, and to respond to and challenge any charges or reasons given by witnesses at the aforementioned hearing in support of a revocation or suspension of your license. You may present your own supporting witnesses, under oath, at this hearing, and you may also confront and cross-examine opposing witnesses. If you wish to do so, and at your own expense, you may be accompanied by an attorney of your own choosing to represent you at this hearing.

If you, Eddie J. Nuell, fail to appear in person before the Committee on May 29th, 2009 at 9:45 A.M. in Room 301-B, of City Hall, as required by the Summons, the Committee will proceed to consider the allegations of the Complaint, which allegations shall

be taken as true. If the Committee determines that the allegations are sufficient, the law requires that the license shall be revoked or suspended.

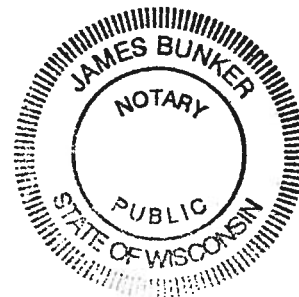

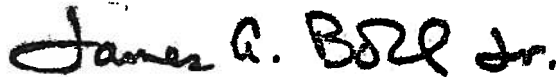

Dear Mr. Nuell:

You are invited to attend a hearing on Friday, May 29th, at 9:45 a.m., in room 301-B, Milwaukee City Hall at 200 E. Wells St. Your Class "B" Manager license for the premises at 4001 W. Fond du Lac Ave. ("All Star Sports Bar") may be revoked based upon sworn charges from the Milwaukee Police Department.

I have enclosed a copy of the charges filed by the Milwaukee Police Department, your license application, and a copy of the updated police report, which is all that is currently in the file. You will be given an opportunity to respond to and challenge the reasons for revocation, to present witnesses under oath and to confront and cross-examine witnesses under oath.
