On April 4, 2006, I hit a pot hole on Fond du Lac Avenue just south of the Hampton intersection and in front of a beauty store. The enclosed picture shows the exact spot. The hole was deep enough to cause damage to my tire and rim. I drove to work, and then I noticed that the tire was slowly going flat. The next morning (April 5), I took the car to Tires Plus and explained what had happened. The inspection showed that the rim was dented and the tire was no longer able to be used. The rim and tire needed to be replaced.

Enclosed are copies of the bill for the replacement of the rim (remanufactured) and the tire. Also, I have included two photos of the pot hole. There are numerous pot holes on Fond du Lac Avenue and also on Capital, (the route I take to work) but I believe that the pot hole I have taken a picture of is the one that caused the damage. When I drove over (in to) it, the car and I were severely jolted.

I am requesting that the cost of this rim and tire be reimbursed. The amount is listed on the receipt and is \$327.97.
