## 5. DESCRIPTION OF PROJECT:

The goal of the project is to provide a prospective tenant with the signage required to move them and their jobs to downtown Milwaukee, in particular to the top two floors of our building. We are seeking signage for the largest tenant in the building, that we hope you will consider comparable to what other buildings have provided to their largest tenants.

To show that a historic building can attract a new large tenant such as this, at a time when it seems new buildings are taking large tenants from other existing buildings - would be to show the market place that existing buildings can compete - and that owning a historic building is a viable investment in the City of Milwaukee.

This tenant requires a roof top sign, smaller signage at the front and back entrance, and that the building construct a monument sign where they can place the top most panel. The monument sign will not only benefit this tenant, but also will provide the First National Bank building with a monument sign commensurate with other Class A office buildings in the downtown.
