Re: Report of the renewal application of Reginald D. Reed, Jr., for a Secondhand Dealer's license for the premises at 4422

West North Avenue ("R&R Resale").

# FINDINGS OF FACT

1. Reginald D. Reed, Jr. (hereinafter the "Licensee") holds a Secondhand Dealer's license for the premises at 4422 West North Avenue in the City and County of Milwaukee, Wisconsin ("R & R Resale"). Said license expired at midnight, December 31, 2011.

2. An application to renew said license was untimely filed with the Office of the City Clerk on January 9, 2012.

3. Pursuant to Chapter 92 of the Milwaukee Code of Ordinances the matter was referred to the Milwaukee Police Department for investigation. The Milwaukee Police Department responded with a report, dated January 16, 2012, which could form the basis for denial or suspension of this license.

4. On January 31, 2012, the City Clerk's Office provided notice to the licensee, pursuant to Chapter 92 of the Milwaukee Code of Ordinances of the police report that could be the basis of nonrenewal or suspension of this license as well as of the neighborhood objections that could form the basis for suspension or nonrenewal of the license of the licensee. The licensee was provided a copy of the police report with the notice of hearing. The matter was scheduled for a hearing on the neighborhood objections on February 13, 2012 at 8:30 a.m. The licensee failed to appear and was not represented by counsel.

at R&R Resale to speak with the licensee (Reed Jr., Reginald D.) about this. The investigation revealed the store had no transaction record with the suspect's name and the stolen property was not found. Reed stated that there were two burglaries to the store and that his store laptop, internet connect card, and video surveillance system were stolen. Reed said because of this he was unable to report transactions to NEWPRS and could not video the transaction either. He was advised that he should have contacted Detective Laura to make him aware of the situation. Several of the store's written transaction records were found to be incomplete. While looking through the written records a copy of a search warrant from Waukesha Police Department was found. A Waukesha detective discovered some stolen video equipment being sold on Craigslist by R&R Resale. The stolen property was found during the search warrant and Reed said he purchased this at a yard sale. Reed stated he is the only person responsible for purchasing items from sellers. While checking the information regarding the burglaries Detective Laura came across a battery incident involving the store. The victim was in R&R Resale to buy a stereo to replace the one that was stolen and saw the suspect in the store trying to sell his stolen stereo. The victim confronted the suspect outside and was beat up by him and several friends. On September 15, 2011, Reed was advised to stop making purchases until he obtained a computer to enter transactions into NEWPRS as required by the ordinance. Reed was told that he must comply with all the regulations in the ordinance. On October 5, 2011, Detective Laura met with Reed at his store and since he quickly got into compliance he was not cited for his violations.

- E. On October 30, 2011, Police Officer Bodo Gajevic of the Milwaukee Police Department became aware that Mequon Police officers were conducting an investigation regarding a stolen laptop computer involving the applicant as a suspect. The applicant was subsequently arrested by Mequon Police and has been charged in Ozaukee County with receiving stolen property and carrying a concealed weapon (see item #G).
- F. On November 7, 2011, at 10:08 a.m., a male suspect fired several shots from a pistol into an occupied vehicle

in the gas station parking lot at 2627 West Capitol Drive. The suspect was identified by the security video and was arrested on November 11, 2011 with the same loaded pistol. The suspect confessed to firing the shots into the occupied vehicle and also stated he purchased the handgun at the resale shop at 4422 West North Avenue. The owner of the resale shop, who he knows as Mr. Reed, asked the suspect if he wanted to buy a gun. Mr. Reed directed the suspect to an employee known to him as "Mr. Homey" who he bought the pistol from for \$500. Mr. Reed told the suspect he had more guns if he wanted to buy them.

- G. On November 15, 2011, the applicant was charged in Ozaukee County with Receiving Stolen Property (<=\$2500.00) § 943.34(1)(a) and Carrying a Concealed Weapon § 941.23. Both matters are pending further proceedings on March 12, 2012
- H. On December 9, 2011, the Milwaukee Police Department executed a search warrant at the home of the applicant. Simultaneous to the execution of the warrant, Milwaukee police conducted a license premise check at R & R Resale Shop (4422 West North Avenue). During the premise check, officers discovered a shotgun in the business that the applicant identified as his. Officers ascertained that the applicant had been served with a protection order originating in the state of Michigan and served on the applicant by Milwaukee County Sheriff deputies. While officers indicate that charges will be pursued against the agent for possession of a firearm in violation of this protection order. As of the time this report was written, no charges had been issued.
- I. Officer Bodo Gajevic testified that he conducted an investigation and found the licensee engaged in criminal activities of selling stolen items on EBay.
- J. Staff Assistant Keith Stanley, for Alderman Willie Hines, appeared in opposition to the license due to criminal activity mentioned in the police report and concerns of the residents in the community.

- 5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
  - A. A notice of the hearing was sent to Reginald D. Reed, Jr. at 2546 North 60<sup>th</sup> Street, Milwaukee, Wisconsin 53210 on January 31, 2012 by U.S. prepaid first-class mail in an envelope bearing the return address of the License Division. The address of 2546 North 60<sup>th</sup> Street, Milwaukee, Wisconsin 53210 is the address given by the licensee on his application. The envelope was not returned to the License Division by the United States Postal Service. The licensee failed to appear at the hearing on February 13, 2012 following proper notice and mailing by United States first-class prepaid mail.
  - B. On May 11, 2011, Police Officer Bodo Gajevic of the Milwaukee Police Department discovered that the New Berlin Police Department had executed a search warrant at R & R Resale Shop (4422 West North Avenue) on May 11, 2011 at 5:45 p.m. During the execution of this warrant, New Berlin Police discovered NEC brand digital projectors that had previously been reported stolen during a burglary that had occurred in New Berlin. An additional investigation is pending, but as of the date of this report, no charges have been issued against the applicant.
  - C. On September 13, 2011, Police Officer Bodo Gajevic of the Milwaukee Police Department initiated an investigation into the activities of R & R Resale Shop (4422 West North Avenue) based on information received from an informant as well as the execution of a search warrant at this address by the New Berlin Police Department. At the time this report was written, it was discovered by Police Officer Gajevic that the applicant had failed to properly log into NEWPRS property he was selling on EBay.
  - D. On September 14, 2011, a Wauwatosa detective related that a burglary suspect stated in an interview that he sold stolen property to R&R Resale Shop on 4422 West North Avenue. The suspect added this is where everyone goes to sell stolen property. The suspect's name was checked in NEWPRS as well as R&R to see if any transactions had been made. No transactions were found for the suspect or R&R had none since June 24, 2011. Both detectives met

# **CONCLUSIONS OF LAW**

- 1. The Committee has jurisdiction to hold hearings and provided Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 92 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the licensee, Reginald D. Reed, Jr., has not met the criteria of Chapter 92 of the Milwaukee Code of Ordinances to allow renewal of the Secondhand Dealer's license for the premises located at 4422 West North Avenue ("R & R Resale") based on nonappearance, aldermanic objections, the police report, and police department testimony.
- 3. In order to protect the health, safety, and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to not renew the Secondhand Dealer's license of Reginald D. Reed, Jr. for the premises located at 4422 West North Avenue in the City and County of Milwaukee, Wisconsin based on nonappearance, aldermanic objections, the police report, and police department testimony.

#### RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of three (3) ayes and zero (0) noes, recommends that the Secondhand Dealer's license of Reginald D. Reed, Jr. for the premises located at 4422 West North Avenue ("R & R Resale") in the City and County of Milwaukee, Wisconsin not be renewed based upon nonappearance, aldermanic objections, the police report, and police department testimony.

Re: Report on the renewal application of Danette A. Stone, Agent for "Black N Black, Inc." for a Class "A" Malt and Class "A" Liquor license for the premises at 3901 West Vliet Street in the City and County of Milwaukee, Wisconsin ("Vliet Discount Liquor").

# FINDINGS OF FACT

1. Danette A. Stone (hereinafter the "Licensee") is the holder of a Class "A" Malt and Class "A" Liquor license for the premises at 3901 West Vliet Street in the City and County of Milwaukee, Wisconsin ("Vliet Discount Liquor"). Said license expired on February 4, 2012.

2. An application to renew said license was filed with the Office of the City Clerk on November 23, 2011.

3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances, the matter was referred to the Milwaukee Police Department for investigation. On November 25, 2011, the Milwaukee Police Department responded with a police report which could form the basis of nonrenewal, suspension for revocation of this licensee.

4. On February 8, 2012, the City Clerk's Office provided notice to the licensee, pursuant to Chapter 90 of the Milwaukee Code of Ordinances, of the police report that could form the basis of nonrenewal or suspension of this licensee. The licensee was provided a copy of the police report with the notice of hearing. The matter was scheduled for hearing on February 13, 2012 at 8:30 a.m. The licensee did not appear and was not represented by counsel. The licensee had previously not appeared before the committee on this application.

- 5. Based upon the sworn testimony heard and the evidence received at the hearings, the Committee finds the following:
  - A. A notice of the hearing as well as a copy of the police report was sent to Danette A. Stone at 3901 West Vliet Street, Milwaukee, Wisconsin 53208 on February 8, 2012 by U.S. prepaid first-class mail in an envelope bearing the return address of the License Division. The address of 3901 West Vliet Street, Milwaukee, Wisconsin 53208 is the address given by the licensee on her application. The envelope was not returned to the License Division by the United States Postal Service. The licensee failed to appear at the hearing on February 13, 2012. The envelope was not returned to the License Division by the United States Postal Service. The licensee has failed to appear on repeated dates.
  - B. On March 14, 2010, a 19-year old Milwaukee police aide, working with Milwaukee police officers, was able to purchase a 6-pack of Heineken beer from the clerk at 3901 West Vliet Street (Vliet Discount Liquor). The clerk, Dustin D. Henley and the licensee were cited for sale of alcohol to underage. Dustin Henley was found guilty of alcohol to underage and fined \$171.00 on May 4, 2011. The licensee, Danette Stone was found guilty sale of alcohol to underage and fined \$171.00 on May 4, 2011.
  - C. On Mary 22, 2011, Milwaukee police discovered the clerk, Trenise D. Simmons at 3901 West Vliet Street (Vliet Discount Liquor) was working without a Class "D" Liquor license. The clerk was issued a citation for Class "D" operator liquor license required which was dismissed on October 3, 2011.
  - D. Attorney Michael Maistelman appeared on behalf of Discount Liquor and testified that the licensee is in violation of a court order and is illegally using a business name already registered to his client. He stated that his client has filed a lawsuit against the licensee with regard to the use of "Discount Liquor" in the trade name.

#### **CONCLUSIONS OF LAW**

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 90 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts found, the Committee concludes that the licensee, Danette A. Stone, Agent for "Black N Black, Inc." for the premise located at 3901 West Vliet Street, in the City and County of Milwaukee, Wisconsin ("Vliet Discount Liquor") has not met the criteria of Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of her Class "A" Malt and Class "A" Liquor license due to repeated nonappearances and the police report.
- 3. In order to protect the health, safety, and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its discretion to not renew the Class "A" Malt and Class "A" Liquor license for the premises located at 3901 West Vliet Street in the City and County of Milwaukee, Wisconsin ("Vliet Discount Liquor") based upon repeated nonappearances and the police report.

# RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of three (3) ayes and zero (0) noes, recommends that the Class "A" Malt and Class "A" Liquor license for the premises located at 3901 West Vliet Street in the City and County of Milwaukee, Wisconsin not be renewed based upon repeated nonappearances and the police report.

# FINDINGS OF FACT

1. Luis M. Silva (hereinafter the "Licensee") is the holder of a Class "B" Tavern license for the premises located at 1631 West Mitchell Street in the City and County of Milwaukee, Wisconsin. Said license expired on February 7, 2012.

2. An application to renew said license was filed with the Office of the City Clerk on November 23, 2011.

3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances, the matter was referred to the Milwaukee Police Department for investigation and there was no police report.

4. On February 31, 2012, the City Clerk's Office provided notice to the licensee of neighborhood and aldermanic objections that could form the basis of nonrenewal or suspension of this licensee. The hearing was noticed for February 13, 2012 at 9:30 a.m. The licensee did not appear and was not represented by counsel.

5. Based upon the sworn testimony heard and the evidence received at the hearings, the Committee finds the following:

A. A notice of the hearing as well as a copy of the police report was sent to Luis M. Silva at 307 West Mitchell

Street, Milwaukee, Wisconsin 53204 on January 31, 2012 by U.S. prepaid first-class mail in an envelope bearing the return address of the License Division. The address of 307 West Mitchell Street, Milwaukee, Wisconsin 53204 is the address given by the licensee on his application. The envelope was not returned to the License Division by the United States Postal Service. The licensee failed to appear at the hearing on February 13, 2012.

- B. Carroll David Turner appeared in opposition to the license because the licensee was operating as a night club at night time, which was outside of the license's restrictions.
- C. Alderman James Witkowiak testified that the licensee operates as a restaurant during the day and clears the inside of its tables to operate as a night club at night. He added that this night club operation and limited parking has adversely affected neighbors and that a new applicant had filed a license application for this location.

# **CONCLUSIONS OF LAW**

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 90 of the Milwaukee Code of Ordinances.
- 2. Based upon the above facts, the Committee concludes that the licensee, Luis M. Silva, has not met the criteria of Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of his Class "B" Tavern license for the premises located at 1631 West Mitchell Street ("Hecho'n Casa El Cielo Lounge") based on repeated nonappearances, aldermanic objections, and neighborhood objections.
- 3. In order to protect the health, safety, and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its discretion to not renew the Class "B" Tavern license for Luis M. Silva for the premises located at 1631 West Mitchell Street in the City and County of Milwaukee, Wisconsin based upon repeated nonappearances, aldermanic objections, and neighborhood objections.

Wisconsin 53233 on January 31, 2012 by U.S. prepaid first-class mail in an envelope bearing the return address of the License Division. The address of 2608 West State Street, Milwaukee, Wisconsin 53233 is the address given by the licensee on her application. The envelope was not returned to the License Division by the United States Postal Service. The licensee failed to appear at the hearing on February 13, 2012. This was her second nonappearance.

#### CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
- 2. Based on the above facts found, the Committee concludes that the licensee, Mary E. Acker, has not met the criteria of Chapter 125 of the Wisconsin Statutes or Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of the Class "D" Bartender license based upon a second nonappearance.
- 3. In order to protect the health, safety, and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council should exercise its discretion to not renew the Class "D" Bartender license held by Mary E. Acker based upon a second nonappearance.

# RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of four (4) ayes and zero (0) noes, recommends that the Class "D" Bartender license not be renewed based upon a second nonappearance.

2. An application to renew said license was filed with the Office of the City Clerk on January 4, 2012.

3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On January 10, 2012, the Milwaukee Police Department responded with a police report that could form a basis for nonrenewal or suspension of said license.

4. On January 31, 2012 the City Clerk's Office provided timely notice to the licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the report of the Milwaukee Police Department and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the police department report on February 13, 2012, commencing at 1:30 p.m. in Room 301B of City Hall. At said date, time, and place, the licensee appeared and he was not represented by counsel.

5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:

A. On January 3, 2010 the applicant was arrested and subsequently convicted in Walworth County for operating while intoxicated (3<sup>rd</sup> offense). He found guilty of this charge on July 19, 2010 and fined and sentenced to 250 days in local jail, a 30-month license revocation and 30 hours of community service.

#### CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
- 2. Based on the above facts found, the Committee concludes that the licensee, Robert D. Lucksinger, has not met the criteria of Chapter 125 of the Wisconsin Statutes or Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of the Class "D" Bartender license without undergoing a ten (10) day suspension based upon the police report.
- 3. In order to protect the health, safety, and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council should exercise its discretion to renew the Class "D" Bartender license held by Robert D. Lucksinger with a ten (10) day suspension based upon the police report.

#### RECOMMENDATION
